Thanks to our many volunteers here at Wemberley Hill Garden Homes. You make this a wonderful place to live!

TO: ALL RESIDENTS, WEMBERLEY HILL COMMUNITY!

As you know, a proposal to build as many as 308 apartments in the vacant lot to the North is in the final stages of approval.

Several of our residents have attended meetings in person and on line objecting to the population density, noise pollution, traffic congestion, security and safety due to single access. All of these objections have been given variances or are being addressed.

Recently at a hearing, we learned that 3 dumpsters will be located on the WHGH property line. This will seriously impact at least 6 homeowners, the pool area and all of our property values. The only opportunity we have to reverse this plan is to make a LOT of noise before April 21. A better solution is self-contained compactors located near the property exit. We all need to pitch in to get this changed in the plans.

Dumpsters by nature are available 24 hours a day:NOISEAccept food garbage and diapers:SMELLAttract animals like raccoons, skunks and rats.PESTSThese dumpsters will be located 25' from our patios and bedroom windows.

While this affects the residents on the North side of our community most, all property values will suffer.

The final public hearing is April 21! If our concerns are not addressed by the end of that hearing, the proposal will be approved.

What can we do? Car pool to the April 21st hearing! Or attend on line. A letter has been placed in the clubhouse: SIGN with your condo address if you agree! Send a respectful objection to: julia.williams@louisvilleky.gov_stating your concerns.
