- MasterCard/Visa, Cash, Cashiers check, or Personal check accompanied by your Bank's Letter of Credit.
- Credit Cards accepted with a 5% convenience fee.
- <u>We will not take checks without your banks Letter of</u> <u>Credit. Letter of Credit must reach our office one week</u> <u>before the auction.</u> Please send to:

- <u>Two valid forms of Identifications required.</u>
- Health papers must be in order <u>BEFORE UNLOADING</u>.
- Please refer to Oklahoma state requirements for any livestock importing regulations.
- <u>Sales tax will be charged to all customers unless a</u> <u>copy of your sales tax exemption certificate is present-</u> <u>ed to us.</u>
- Sheep and Goat Requirements: Scrapie Tag and Corresponding plastic tag with health certificate <u>PRIOR</u> to unloading. (\$10.00 Han-dling Fee per head if this requirement is not met.)
- Bovine Requirements: All cattle are required to have an RFID Tag corresponding dangle ear tag with health certificate.
- <u>2 Year Old Bulls and older will</u> require <u>Trichomoniasis</u> test and paperwork <u>PRIOR to unloading</u>. Check with local and state regulations.

Equine Requirements: Coggins test and paperwork is required to be completedd on all Equine PRIOR to

- the sale. Veterinarian will be available for Coggins testing on Thursday morning from 9am 12pm. \$60 Coggins test fee will be charged to the seller if this is not done.
- All cages sell with each lot. Birds & animals must be able to stand in cage & meet USDA approval guidelines. NO CARDBOARD BOXES!!! All birds and animals in this sale are for breeding, food & fiber purposes only. All guarantees & sales are between buyer & seller.
- Cages must meet the USDA Guidelines: All cages must have handles (wood-wire-plastic-etc.) All cages must has access door-gates-etc. All cages must have solid bottoms (wood-metal-hard plastic-etc.) No paper-cardboard-carpet-etc. All cages must have attached and non-breakable food and water dishes. All cages must have ample bedding All cages must allow animal or animals enough room to stand and move about. All cages must have Live Animal Stickers on them.

- Barn opens 8:30 am daily Auction Starts at 9:00 am daily Closes 9:00 pm.
- Animals may be delivered on day BEFORE First Sale, between 12:00 noon and 6:00 p.m. Please call in advance.
- <u>Load out Requirements:</u> Loading of all animals must be conducted by Auction Staff ONLY
- Load out sheet must be signed by Auction Staff and Buyer prior to leaving (NO EXCEPTIONS)
- Load out is preferred day of sale, but available next day

Yardage: \$7.00 / head / day
