#### **Eligibility:**

1. To be eligible for nomination to the WESTSOUND USBC Association's Board of Directors, the candidate must meet the requirements outlined in Article V Section B of the Association Bylaws, elected at the Association's Annual Meeting or appointed to a vacancy by the Association President and;

#### ADULT:

- (1) A USBC member is good standing at the time of election (or appointment) and throughout their term of office.
- (2) Be a member of a certified league within the jurisdiction of the Association, or if a non-league bowler, reside within the jurisdiction of the Association and be a member of the Association on an affiliate basis.
- (3) Register with USBC's Registered Volunteer Program (RVP) (if elected).

#### YOUTH:

- (1) A USBC Youth member age 14 or older in good standing at the time of election (or appointment) and throughout their term of office.
- (2) Be a member of a USBC certified Youth league within the Association's jurisdiction.

#### All Candidates:

- (1) All candidates 18 years of age and older must be eligible for bonding by the USBC.
- (2) Elected or appointed without regard to race, age (other than minimum age), color, religion, sex, sexual orientation, disability, or nationality.
- (3) Reasonably representative of the membership constituency.
- (4) Must have not been convicted of any felony.
- (5) Must not have been convicted of the misuse of any financial accounts or funds.
