General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Guitardean.com legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- You have given guitardean.com permission to do so
- Processing your personal information is in guitardean.com legitimate interests

# Log Files

Guitardean.com follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks.
