Minutes of the Westmoreland Selectmen's Meeting

Tuesday, May 7, 2025

BOARD MEMBERS PRESENT: John Snowdon, Bill McGahie and Mark Terry

- 1. The meeting was called to order at 6 pm by John Snowdon.
- 2. Approval of Minutes: April 15, 2025 Motion was made by Mark Terry, seconded by Bill McGahie to accept the minutes as printed. Motion passed 3-0.
- 3. Accounts Payable: Motion was made by Mark Terry seconded by Bill McGahie to approve Manifests for: General Fund \$415,568.66. Motion passed 3-0.

4. Guest

- A. Tom Bates Old Moore Road Questioned how the road will be improved.
 - John Snowdon and Dave Poklemba met for a site visit prior to the meeting to determine what can be done to address the road's issues. Tom Bates joined during the visit and there was discussion about the raised surface, larger than normal gravel, ditching needs and culvert problem could be addressed.
 - Poklemba, the town's road agent, determined necessary repairs including scraping the road down, replacing culvert and ditching.
 - Bates 35% roads in the state are unpaved and other towns have adopted standards to maintain them including using concave blades and bonding materials. Could consult a road engineer to repair the road correctly.
 - Selectmen agree that Poklemba does a great job reporting to them any issues with the roads. Dave takes a lot of extra measures to make sure the town roads are well maintained and safe including going out at all hours of the night during and after storms to make sure people can get to work and kids can get to school. Selectmen have confidence in his ability to do what needs to be done to bring Old Moore Road up to the town standard. Once repairs are made Selectmen welcome Bates and any other residents on the road to report to them if further work is needed.
- B. Park Hill residents are concerned about neighbor Jason Kats, hosting a 4 day party with fireworks and El Pulpo Magnifico, an art piece that shoots flames.
 - Selectmen received a letter from some of the Park Hill residents listing concerns with the event (letter attached)
 - Snowdon It is neither the selectmen's or fire chief's place to promote or prohibit an event but to ensure an event meets existing Town and State regulations and laws.. Town attorney advised that there are no ordinances prohibiting noise or fireworks. In fact, prohibiting displays of art like El Pulpo Magnifico could violate the First Amendment.
 - Fire Chief Nelson contacted NH Fire Marshall. Documents outlining requirements were sent to Chief Nelson and shared with Kats.
 - In a letter to the Selectmen Kats addressed parking, insurance, fireworks and other concerns (letter attached). Kats did not think he needed a permit from the Fire Marshal, but is currently working with the Marshal to comply with the permitting process.
 - Snowdon Selectmen contacted Troop C to make them aware of the event. Troopers will not be specifically assigned to the event, but they will patrol the area to help ensure that attendees are not disorderly and that Route 63 is safe. Selectmen suggested Kats hire troopers for traffic and safety. Kats has agreed to contact NHSP.

- The flaming octopus will be placed on a concrete slab and both Chief Nelson and the Fire Marshal will be there when it is erected. They will inspect safety features before use. It does not operate if it is windy or raining.
- Fireworks displayed by a licensed company. They will be on Moore's field further from neighbors. Fireworks company requires safety conditions including firefighters on site, safe weather conditions and safe distance from El Pulpo.
- Fire Chief Nelson suggested Kats not park cars on his driveway for emergency access or minimally have medical on site. Kats agreed to look into having CCEMS on site. Selectboard cannot enforce this as it is private property.
- Parking on the Town Common at Park Hill will be allowed, and Kats accepts all responsibility for any damage and litter left on the common. Park Hill residents intend to restrict parking on their personal property.
- Brenda Smith adamant that selectmen should do more since this is a 4 day event and most families on Park Hill don't want it to happen. Snowdon no ordinances to prohibit so nothing to enforce. Terry RSA 644:2 referred to in letter from residents gives police authority to deal with disturbances. If needed residents can call them to deal with issues.
- Paul Berch Appreciate Selectmen's analysis of what can and cannot be done. Is there a
 policy about drug or alcohol use? Snowdon No sale of anything so nothing to enforce
 since it is private property.
- Sharon Combes-Farr Will Park Hill neighborhood be a parking lot for 4 days? Concern about parking on Esty Road as it is a narrow road only wide enough for one vehicle. Snowdon no overnight parking will be allowed and Selectmen agreed to post no parking sign on Esty Road. Cindy Hatt can suggest to Kats that he have a shuttle for excess parking further from site if needed for safety.
- Paul Steblein appreciates efforts of Selectmen. Has experience managing large events and recommends 63 is staffed with a State Trooper. Concerned for what is the safe threshold for attendees at this event. Snowdon police will be in the area, but would be up to Kats to staff the event with a trooper. State police would determine if/when the event became out of control.
- Patti Seymour representing Park Hill Meeting House. It is a historical building that cannot be replaced if fireworks embers or a malfunction set the building on fire. Nelson Octopus and fireworks will not go off if windy.
- Combs-Farr How much propane will be on site? TJ Kelly, insurance agent, 1000 gallon tank set up by gas company on site.
- Paul Berch Will there be adequate porta potties? Chief Nelson There have been port-a-potties on site previous years and expect there will be this year as well. Nelson assured that he will do everything he can to keep people safe at the event.
- Bruce Farr Is there a plan if attendance exceeds estimates? Snowdon will ask Kats as far as parking, disturbance issues that arise due to attendance would be handled by NHSP.
- Snowdon Selectmen understand neighbors concerns, but If the fire marshall issues permit the event will take place. Concerns and suggestions will be forwarded to Kats.

5. Old Business

- A. Legal Council Selectmen decided after interviewing Drummond Woodsum Attorneys at Law, to hire the firm who specialized in municipal law to represent the Town.
- B. Makinen Road Dan Lang's attorney and surveyor told him he did not need to deed 4 feet of property to the Town as he would own the property under the road anyhow. Only thing that would change is the surface of the road which would shift toward his property to avoid Eversouce utility box. Snowdon confirmed with Town's attorney who recommended once the road is laid out it is put in writing to memorialize the change.

Dear Members of the Westmoreland Select Board,

We are writing to express significant concerns regarding a proposed <u>four</u>-day Memorial Day weekend event planned by a resident of the Park Hill neighborhood of Westmoreland, NH, featuring an installation called "<u>El Pulpo Magnifico</u>." This event, advertised to nearly 10,000 people via a <u>public Facebook page</u>, has raised alarm among abutters to this property and several other neighbors due to its potential to disrupt the peace, safety, and enjoyment of what should be a somber weekend in remembrance of our fallen soldiers. An event of this magnitude and duration simply does not belong in this setting, and we are asking the Select Board to assert its authority to protect all our citizens and their property, as well as the potential attendees of such an ill-conceived event.

The proposed event, with its significant scale and wide-ranging public invitation, is likely to cause excessive noise, traffic, and disruption, infringing upon the quiet enjoyment of and access to our property with significant potential to violate NH RSA 644:2. Park Hill is a small, residential neighborhood, unprepared for an influx of hundreds (let alone potentially thousands) of visitors, and such an event raises serious concerns about public safety, parking, emergency access, property damage, and environmental impact. Paramount among our safety concerns is the dangerous curve on the crest of the Route 63 hill adjacent to the Meeting House, the scene of many past accidents, even when the highway was relatively unobstructed. Furthermore, the organizer's failure to engage with his neighbors beforehand demonstrates a disregard for the values of cooperation and mutual respect that define our town.

We respectfully urge the Select Board to carefully review the scope and management of this proposed event, particularly given its public promotion as a "four-day free frolic" that may attract untold hundreds of attendees from outside the community. We as abutters and neighbors, require more clarity on how our property, privacy and right to peace will be protected under NH RSA 644. The property owner should be required to provide the following details no less than 14 days prior to the event

- Park Hill residents have the right to enjoy and access their property without disruption. What steps will be taken to ensure that residents' access to roads and driveways is not blocked or interfered with by fatigued or potentially intoxicated attendees?
- Noise pollution, including fireworks and loud, beat-driven, amplified music well after 11 p.m. has been an issue in prior years. How will noise be managed throughout the four-day event, and what are the expectations for ending times for music, fireworks, and other loud activities each night?
- The event location has been noted for its high wind potential. A brush fire had also broken out at a previous event at this location. What safety precautions will be in place to ensure a small fire does not accelerate due to the high winds at the location?
- Congregations of people at events of this scale inevitably generate trash and refuse. The town recently sponsored a successful roadside cleanup effort. Who will be responsible for trash removal and cleanup after this event?

Thus, we ask that the Board take reasonable steps to ensure that safeguards are in place to manage noise, prevent property trespass or damage, and protect public safety, as well as the safety of attendees at this event, who are no doubt accustomed to attending events with far more infrastructure (i.e., parking, campgrounds, sanitation, etc.) and planning. We also request that the event organizer be required to present a transparent plan to the community. Even in the absence of formal permitting, we urge the Board to exercise its authority to minimize liability, prevent unmanaged or potentially disruptive and dangerous gatherings of this scale.

Before any possible approval of this event, we also respectfully request that the Select Board coordinate with the New Hampshire State Police and Department of Transportation regarding the impact of this proposed event on Route 63. As a state-maintained highway with limited shoulder space and visibility concerns in certain areas, any overflow parking or pedestrian activity near the roadway presents a serious safety hazard. The promotional framing of this as a "four-day free frolic" underscores the need for a proactive traffic and parking plan on all roads.

We value our peaceful, close-knit community and seek to maintain its character and tranquility. We appreciate the Select Board's attention to this matter and your commitment to addressing the concerns of Westmoreland residents. Some of our concerned neighbors—but not all, due to other commitments —are planning to attend the next Select Board meeting, which is scheduled for 6p.m. on Tuesday, May 6th. We appreciate that this topic has been added to the agenda.

Please note that we reserve the right to contact the creator and operator of El Pulpo Magnifico directly, outlining our safety concerns and requesting that the installation not proceed without community review and coordination with local and state authorities. However, currently, we believe it is sufficient to alert the Select Board to the content of his public Facebook post from April 27, 2025.

Dear Selectmen,

I am unable to attend tonight's meeting but wanted the Selectmen to know that I am in favor of the Town creating an ordinance for noise which would place a time limit on events of say 10 PM. It would be even nicer if there was a permitting process that addresses parking for larger events so that the roadways are not used.

We had a situation last summer of a person (new to town) holding what was reported to me by a neighbor of an internet live band event. The cars were from NY, MA, CT, VT and lined the road parking almost halfway into the road. They are new neighbors so it was ignored hoping it was a one time thing and the music stopped between 10 - 10:30. Hopefully the recent further clearing of the concert spot is not an indication of future events.

It would also be nice if a noise ordinance could also address barking dogs as a nuisance. My understanding is that we do not have any kind of a noise ordinance in Town now. As the Town grows, this might be quite helpful.

Thank you and I apologize that I have a conflict tonight that prevents me from attending.

Sincerely, Lisa Prince Good morning, John - I am writing to bring you and the rest of the BOS up to speed with respect to the various plans, procedures, and protocols we have in place for "Start of Summer" 2025, pursuant to your emailed request for such details last week, a copy of which is annexed hereto as Appendix A.

- 1. <u>Parking/Traffic</u>; we can fit approx. 70-80 cars on my property parked alongside the roughly 1,400-ft run of all legs of my driveway. If there is overflow, those extra cars will be parked on the Common in front of the Meetinghouse. And if there is any overflow from there (highly doubted), extra cars will be parked on River Road around the corner from my house. Nothing and nobody will be allowed on/around Route 63. We will have 4-5 volunteers every single night working to direct traffic; they will all be wearing fluorescent vests with flashlights, etc. to ensure visibility in the dark. We will also post fluorescent "Event" and "Slow Down" signs on Route 63 on either side of my driveway, for folks to slow down as they approach.
- 2. **Insurance**; we bought, as we do every single year, an insurance policy covering our event from Knight Specialty Insurance, a paid invoice of which is annexed hereto as Appendix B. This policy always lists the Town of Westmoreland and the Park Hill Meetinghouse as additional insured, COIs of which I will forward to you prior to the event, once I receive them. The insurer gives us a very lengthy list of recs that we must satisfy in order to be in compliance with the terms of the policy. Among this list of recs is what I outlined above; directing traffic and ensuring cars park safely, etc. We are also obligated to have numerous life-saving first aid measures on standby; we have an AED, first aid kits, COVID/flu rapid tests, countless face masks, nitrile gloves, Narcan doses, disinfectants, etc. (none of which has ever been used, thankfully). Most of the items are located in a conspicuously-labeled central kitchen drawer in my house which I clearly publicize to all the event's creators and planners who run the show; annexed hereto as Appendix C is a screenshot of a group text I sent everyone during last year's event, alerting them to the location of these items. We also have perhaps half a dozen or so fire extinguishers on-hand, none of which (thankfully) has ever been used either; half of them are located in the carport in the rear of my house with the other half on my front lawn near the aerial rig. We also are not allowed to serve/sell alcohol. There are literally dozens of such recs we must comply by...bottom line; there are few places anywhere in the world safer than my property on the days/nights of our annual event. Think of how many private residences are equipped with a live, active, and fully charged AED ready to shock a comatose Granite Stater back to life!!
- 3. Attendance; we are projecting approx. 80-100 guests on Thursday, perhaps 100-150 on Friday, and maybe 150-200 on Saturday and Sunday each. The vast majority of the guests are expected to attend at night, when the octopus is performing. If you average approx. 2 attendees per car, there is more than enough room on my property and the Common to accommodate everyone's parking needs without needing to overflow to River Road. Most of our events have drawn, on average, perhaps 70-80 attendees on the most heavily-attended nights (the Sat and Sun of the event). Our 2023 iteration drew the most guests; perhaps around 120-140 on the Sunday night of the fireworks. We never had any issues whatsoever regarding traffic or parking, etc.
- 4. Evacuation Plan; we presented Knight (the insurer) with an evacuation plan for this event, exactly as we have done for all prior events they've insured. Annexed hereto as Appendix D is a letter written and signed by the Board President of Eden Foundation II summarizing the 2025 plan accepted by the insurer, along with the relevant exhibit illustrating exactly what we're doing. Perhaps I made a mistake in not proactively sharing this with you before today; with that said, it was only put together a few days ago, so you're not too late to the dance, as these things go. I'm a homebuilder, not a politician, and public relations is clearly not my strong suit, to say the least (see the "Windgate Scandal" for further evidence). With that said, the insurer is very much on board with everything, which should speak volumes about the safety of the event.

- 5. Octopus; the octopus (El Pulpo) will remain stationary on the southwest edge of the concrete pad on my property throughout the entire event. There is no vegetation or anything flammable anywhere close. The controls will be manned only by Duane Flatmo, the creator and owner of the octopus. There are no permitting or licensing requirements for the octopus given that it is not performing in front of a "proximate audience" (meaning, indoors). El Pulpo will always be outdoors; he will never perform when it's raining or windy. If it makes the Town/BOS/FD more comfortable, we are amenable to paying the Town to park a tanker truck on my property while the octopus is performing, akin to how we already pay the Town to park a tanker truck during the Sunday night fireworks display. I have, as you know, been very transparent about this since Day One and Chief Nelson has always fully known of our offer regarding the tanker truck. With that said; it would be the first time in El Pulpo's 15-yr-long history that an intervention from first responders would be necessary during the course of its performance, if such a thing were to happen. It has a literally flawless track record.
- 6. <u>Fireworks</u>; my next door neighbor Elaine Moore is generously loaning us the use of her field abutting my property for staging the Sunday night fireworks display. Annexed hereto as Appendix E is a diagram of this display put together by JPI Pyrotechnics, a licensed/bonded/insured professional pyrotechnics firm based in Allenstown, NH. They're the same firm that has been doing our fireworks since Day One. There will be more than sufficient clearance between El Pulpo and the fireworks. The paperwork to properly permit this is being submitted to the town and the state this week, ahead of the deadline.
- 7. "the fact that these other existing plans have been made without Town knowledge, input, or approval causes concern" respectively, the only "concern" being voiced has nothing to do with our event but rather everything to do with me personally. I am guilty of the ghastly crime of making a proposal that some of my abutters objected to (Windgate Scandal). Never mind that it happened nearly three years ago at this point; that I even had the audacity to propose it is, evidently, still very fresh on their minds. These are the same abutters, let me remind you, who attended at least two of our first events several years ago (pre-Windgate) and never verbalized a word about any "concerns" they had, back before they decided to transmogrify me into the evil cartoon villain next door. At one of these events I literally burned my own house to the ground; never once did I hear a word of "concern" from any of these people about my activities back then. If anything, they came, partied their asses off, posed for copious photos in front of the fiery debacle, and had a blast. We had well over 100 guests on that day; again, no issues at all concerning parking, traffic, crowds, etc.; no "concerns" to be had.
- 8. "there is potential for large crowds" yes, but literally all of those crowds and most of their cars will be on my private property, it's not like attendees will be overflowing onto the neighbors' front lawns and into their dining rooms. Remember, I have 17 acres.... the Hatts regularly draw close to a thousand attendees and hundreds of vehicles to their event (!!) on less than half the land that I sit on, absent any space constraints. Also; the vast majority of attendees annually, easily three-quarters if not more, are fellow Westmorelanders. So what, exactly, is the issue? It's not like the bulk of the guests are random strangers who we know nothing about, people who may be coming into our community with nefarious intent. On the contrary, we are neighbors with the vast majority of those who come.
- 9. "may require our first responders' involvement" we have had four such events (including, again, one where I literally burned my own house to the ground), all of which went off completely without a hitch and without so much as a band-aid needing to be fetched from the first aid kits. There is no reason why this year's event will be any different. Same thing goes for TimFest; they've been at it for 15+ years, and I don't think they've ever had to call Fire & Rescue for anything. Remember; the creators and planners who throw our event all come from the same thing in the desert as I do. Their specialty is planning parties for tens of thousands of

revelers; an event for only a few hundred is, frankly, not a heavy lift for any of us. Nothing about what we're doing (including El Pulpo) is remotely unusual for any of us.

Bottom line; our event is incredibly safe and well-provisioned and we have a number of measures and protocols implemented that actively ensure the security of all attendees, not to mention a comprehensive insurance policy that covers the Town and the Meetinghouse. This is a whole big NothingBurger, at the end of the day. Caused by people with an axe to grind who are simply using this event as a Trojan Horse via which to deliver their ad hominem grievances against me, under the guise of "concern" for public safety. Remember what I said earlier regarding their decision to transmogrify me into the evil cartoon villain next door; it's curious that none of these "concerns" was ever aired prior to the Windgate Scandal, even though the event is the same as it's always been.

Our event is open to the public, caters to all ages, and is totally free of charge. We even have a bounce house and a slip-and-slide, for the little ones. It is as nonprofit of an event as you'll ever get; there is nothing whatsoever commercialized about any of it. "Start of Summer" is an enormous benefit to our community, in much the same way as the TimFest and Old Home Day events in August are (about which, conspicuously, I've never heard a single word of "concern" from anybody). And, like those events, it only happens one weekend/year. The other 51 weekends (not to mention all the weekdays in between) I host nothing and do nothing; I'm quieter than a church mouse. I encourage aggrieved abutters to realize that sharing neighborhood resources with other taxpayers for only one weekend/year is how good neighbors are supposed to operate.

Good morning, Jason.

During our conversation yesterday concerning your availability to attend next Tuesday's select board meeting, you mentioned your crowded schedule and your willingness to instead respond to questions in writing. You also mentioned that, at the request of your insurance company, you have prepared a series of plans to manage various aspects of your upcoming event. These plans include parking issues and evacuation routes.

While you have met with Fire Chief Nelson concerning the location of the octopus, the fact that these other existing plans have been made without Town knowledge, input, or approval causes concern as it seems there is potential for large crowds and may require our first responders' involvement. 

To whom it may concern:

This letter is to confirm the details of the Evacuation Plan (the "Plan") agreed upon between Knight Specialty Insurance Company (the "Insurer") and Eden Foundation II (the "Insured") regarding the event taking place in May 2025 at a private residence in Westmoreland, NH (the "Venue").


- 1. The parking regimen for attendees' vehicles will be staggered in a tertiary pattern. The first tier of vehicles will be parked on the side of the Venue's two driveways, which altogether run approximately 1,400 feet in length. The Insured can fit approximately 70-80 cars along the length of these driveways (see enclosed exhibit; marked-up survey of the Venue). Any overflow crowds will then be directed to park on the Park Hill Common across from the Venue. That area can fit approximately 30-40 cars. Any overflow crowds from that point on will then be directed to park along the side of River Road, a short walk from the Venue. No parking will be allowed on or around Route 63.
- 2. A team of volunteers wearing fluorescent vests and carrying flashlights and glow-in-the-dark indicators will direct all cars into their appropriate parking spaces. Per the Insurer's explicit request, all cars will be parked in a pattern whereby their hoods face the driveway and/or road. Thus, in the event of an emergency, attendees need only enter their vehicles and drive forward in order to properly evacuate the Venue. This pattern will hold throughout all three parking venues; all attendees will be made to pull into their parking spaces in reverse in order to ensure easy evacuation from the Venue in the event of an emergency.
- 3. The driveway leading in/out of the Venue will be kept fully open at all times. All cars parked on the edges of the driveway will be left on only one side of the driveway, in order to ensure adequate open space for passage of vehicles.
- 4. All medical equipment relating to the safety and wellbeing of the attendees will be placed in a clearly labeled pull-out cabinet/drawer located in the center of the Venue's kitchen. All event creators and planners will be made aware of the location prior to event start date.
