Minutes of the Westmoreland Selectmen's Meeting Thursday, April 15, 2021

BOARD MEMBERS PRESENT: Frank Reeder, Russ Austin, Clayton Stalker

- 1. The meeting was called to order at 10:00AM by Chairman Clayton Stalker.
- 2. Approval of Minutes: April 1, 2021 & April, 2021. Motion was made by Russ Austin, second by Frank Reeder to accept the minutes as printed. Motion passed 3-0.
- 3. Guests: None
- 4. Accounts Payable: A motion was made by Russ Austin, second by Frank Reeder to approve a manifest of \$12,226.82 for the highway department and \$55,908.38 for all other bills for a total of \$68,135.20. Motion passed 3-0.

5. Old Business:

- A. Backhoe: The current backhoe the highway department is using will be sold by bid when the new backhoe comes in.
- B. Spofford Road property: After reviewing Zoning records, it was discovered that in 1984, based on zoning at the time, that the lot on R4-24 was not considered a building lot. Changes to the Zoning Ordinances in 1988 allowed existing lots as of the effective date of the change to be built on, as long as they were not less than ½ acre (in 1990 it was changed to 'not less than 1 acre'.
- C. Town Common post update: The claim for damage to the posts has been settled and the town will receive compensation.
- D. Recycling Center fees: Research was done to find out what other towns were charging for items at their recycling centers. Supervisor Ron Fish will recommend any changes in fees in our current fees to the Selectmen.
- E. Partridge Brook Road update of possible dead trees on the roadside: Richard Cate asked the Selectmen for time to discuss the liability issue with his attorney and to allow time for trees to bud to determine their status. Selectmen agreed to his requests.
- F. Town Hall Septic: Nine letters were sent to possible contractors and it was posted in the Sentinel.
- G. The Post Office needs some tiles replaced on the bathroom floor and the back wall needs to be painted. Jo Ann will talk to Bruce Uhas about doing the work and also look into purchasing a dehumidifier for the Post Office.
