- 1. The meeting was called to order at 6:00PM by Chairman Russ Austin.
- 2. Approval of Minutes: December 5, 2019. Motion was made by Clayton Stalker, second by Frank Reeder to accept the minutes as printed. Motion passed 3-0.

3. Guests:

John Snowdon, Broadband Advisory Committee: To meet requirements for the proposed bond to be voted on at the March town meeting, the Selectmen will hold a hearing on Thursday, January 2, 2020 at 5:45pm to discuss the public vs private benefit findings to improve broadband service in town.

4. Accounts Payable: A motion was made by Clayton Stalker, second by Russ Austin to approve a manifest of \$22,768.16 for the highway department and \$8,726.02 for all other bills for a total of \$31,494.18. Motion passed 3-0.

- B. Broadband: The Selectmen signed an Engagement Letter from the bond attorney. A letter was included from Consolidated Communications that they would be responsible for the payment of the attorney.
- C. The three-year contract for annual auditors MelansonHeath expired with the completion of the 2018 audit. They were asked to present a proposal for a new contract.
