 - Have a Property Line Adjustment Hearing with the Planning Board on January 15th. Heard there was a potential violation issue.
 - Reeder Zoning Administrator can give specific violations and steps to become compliant. Town attorney has advised the Planning Board that properties need to be compliant before lot line adjustment should be done. Reeder suggested that any structures, trailers, campers etc. currently on the property should be removed.
 - Ian Ingram intends to build a house on the property, but will need to upgrade a section of Old County Road to gain needed frontage.
