

Minutes of the Westmoreland Selectmen's Meeting

Thursday, January 26, 2022

BOARD MEMBERS PRESENT: Russ Austin, Frank Reeder and John Snowdon.

1. The meeting was called to order at 6:00 pm by Russ Austin
2. Approval of Minutes: January 5, 2023. Motion was made by John Snowdon, seconded by Frank Reeder to accept the minutes as printed. Motion passed 3-0
3. Accounts Payable: Motion was made by John Snowdon, seconded by Frank Reeder to Approve Manifests for: General Fund \$109,181.57 Fire Station \$14,500.00 Motion passed 3-0.
4. Guest: County EMS
Cheshire County: County Administrator, Chris Coates; Commissioner, Jack Wozmak;
Chief Michael Spain, Deputy Chad Butler; Finance Director, Sheryl Trombly
 - County EMS new service now located 53 Monadnock Highway (Route 12) Swanzey
 - ARPA grant money used to start up. No bonds
 - 3 ambulances & 1 Fly Car current staffed
 - Will have 8 ambulances: 4-911, 2-transfers, 2-reserve
 - Future plans for substations in other towns-potentially Maplewood
 - Plans for EMT and community education programs
 - Concern present services not sustainable. County goal to help make all services stronger
 - Inter facility transfers key to income making 911 service coverage more affordable. County currently does 95% of Cheshire Medical transfers. County looking to sustain service, not profit.
 - County is offering a 3-year period of rate-smoothing funded by federal funds to be allocated by 2024 expiration: Rates: 1st year 8,000, 2nd year 9,520, 3rd year 12,800.
 - Graham Gitchell - Will service increase in price dramatically in near future? Wozmak-no dramatic change expected in next 10 years.
5. Old Business:
 - A. Keene Ambulance Contract - New contract price approximately substantially less than last year. Last year the town budgeted \$71,235 which was increased by the City of Keene on March 18, 2022 to \$78,733. 2023 projected cost \$61,000 / \$54,303 if grant is received. After some discussion comparing both County and Keene services, Selectmen concurred to have the Town Attorney review County contract and make a decision on service to be used by the Town at the first February meeting.
 - B. Auto Body Shop - Continuing to do business although cease and desist issued by the Town Attorney. Tenant was issued a notice of eviction by the owner, but has failed to vacate. Town attorney advised that the owner's attorney is working to remove the tenant.
 - C. Monument plaques - Design and price to be completed by end of week. Monument is on hold until plaques are in hand. Once price is in a warrant article for the purchase of the

plaques with all names of those who served in all wars from Westmoreland can be written for the town to vote on.

- A. Jason Kats emailed a proposal to build a bridge replacing the River Road South Bridge and rent it to the town. Frank Reeder - Bridges in NH are considered highway structures and it is not legal in NH to build a private bridge on a public road to rent to the town.
- B. Allison Fissette - Tree that took down wires on South Village Road had been marked for removal for years. Power was lost for 2 days when the tree fell. Reeder - would need to ask Eversource or Asplundh tree service why it was not done.
