- New rescue chassis has been ordered from Faith's Ford in Brattleboro at the lowest price. No details yet on delivery date.
- Cleaning out the Fire Station before the demo. Some items such as doors, openers, the generator, and hot air furnace are old, but still useful. Dave Poklemba is interested in the generator as well as a door with an opener that is the same size as a damaged one at the town garage. The rest could potentially be sold. Selectboard agreed that it makes sense for the highway garage to use what they can since it already belongs to the town and that any of these items that can be sold is good for the town.

5. Old Business:

A. Daggett Hill Camper has been removed from property. Need to dispose of. Reeder - See if Harry would want to burn for training. If not all agree to have the highway department demo and dispose of.

- B. Town Hall Lift Lift for ADA compliance will be approximately \$70,000. There is not a plan at the moment to use the upstairs for public events. Could be added at a later time if this changes. With all the work to be done to restore the Town Hall selectboard agreed better to push the lift to another year and focus funds on electrical work needed to update the upstairs.
- C. Fidium Snowdon Residents have received notices to change to Fidium by January 31st for promotional pricing. After that standard prices will apply.

6. New Business:

A. Open Storage in Village Center - Selectmen emailed concern about violation of town ordinance section 422. Reeder - Complaint Form needs to be filed by concerned residents for the selectboard to formally address issues. Selectmen do not have resources to enforce all violations and are advised by town council to only address complaints filed using approved format. Allison Fissette - Wouldn't it be reasonable for the selectboard to write a letter informing residents of violations as they are brought to the board's attention? People may not know they are in violation. Could help eliminate future problems. Selectmen should enforce ordinances including incomplete zoning permits with outstanding conditions that have not been met. After a brief discussion the selectboard agreed a letter would be sent to notify the residents of zoning violations.

B Received State revenue:

Meals and Rooms \$148,908 - budgeted annual revenue dispersed by state SB401 Bridge Grant \$107,786.96 - additional grant funding

C. Hazardous Waste Collection - Cost for town to participate in hazardous waste collection days for 2023-2024 season (24 collections) \$2610. Selectmen agreed to continue the program since it helps eliminate improper disposal.
