# Minutes of the Westmoreland Selectmen's Meeting Thursday, January 18, 2018

# BOARD MEMBERS PRESENT: Jack Zeller, Clayton Stalker, Russ Austin

- 1. The meeting was called to order at 6:00PM by Chairman Zeller.
- 2. Approval of Minutes: January 5, 2018. A motion was made by Jack Zeller, second by Russ Austin to accept the minutes as printed. Motion passed 3-0.
- 3. Accounts Payable: A motion was made by Russ Austin, second by Clayton Stalker to approve a manifest of \$15,279.25 for the Highway Department and \$24,242.41 for all other bills for a total of \$39,521.66. Motion passed 3-0.

#### 4. Old Business:

- A. Financial Audit: Recommendations from auditors, MelansonHeath, continue to be worked on. All departments that take in money were given cash receipt books to use for payments that are made in cash. A carbon copy of the receipt needs to be included with and balance to the bank deposit.
- B. Direct Deposit for employees is set up and ready to be used.
- C. David Wirth has asked the Selectmen to look for someone to take his place as Zoning Administrator.
