- A. Selectmen approved of the town's participation in twenty four Hazardous Waste Collection Days for the summer and fall of 2019 and the spring of 2020. The estimated cost is \$2,372. The town is already signed up for spring of 2019.
- B. Patrick Baker sent a letter stating that he will not be finishing his term as a Trustee of the Trust Funds. He will finish the current year upon the town elections in March of 2019, at which time his replacement will be elected to fill the remainder of Patrick's term (one year).
- C. A claim was filed with the town insurance company due to the cardboard container door catching the wind at the Recycling Center and hitting a vehicle parked near the container on November 14.
- D. The Selectmen will begin working on the 2019 budget at their next meeting.
- E. 2015 Tax Deeded properties: Five properties that were due to be deeded to the town in June of 2018 were not done during the allotted time. Tax Collector Melissa Bonito stated that the town attorney informed her that the deeds could be done at this time. Payment arrangements will be offered for properties with a residence.
