- 1. The meeting was called to order at 6:00PM by Chairman Stalker.
- 2. Approval of Minutes: September, 4, 2018, September 6, 2018 and September 10, 2018. A motion was made by Russ Austin, second by Frank Reeder to accept the minutes as printed. Motion passed 3-0.

 - While at the conference, Melissa talked to Avitar about training for the tax software that the town purchased in 2009 and has not been used. The program will be updated and networked with the town's assessing software.
 - Avitar also has a Town Clerk program that will be looked at.
- 5. Accounts Payable: A motion was made by Russ Austin, second by Frank Reeder to approve a manifest of \$7,498.71 for the Highway Department and \$15,613.12 for all other bills for a total of \$23,111.83 Motion passed 3-0.

6. Old Business:

- A. A motion was made by Russ Austin, second by Clayton Stalker to accept the letter of resignation sent by Deputy Tax Collector Pam Jenkins. Motion passed 3-0.
- B. Tobacco Coalition request update to increase the age for purchasing tobacco product sales in town. It is unclear at this time if a town has the right to create an ordinance for this purpose.
- C. The newly appointed Town Clerk and Tax Collector are continuing to reorganize the office and get the necessary training. Keene will continue to do vehicle registrations for the next three weeks.
