

## Nixon City Council Minutes for 3.18.2024 Regular Meeting

The Nixon City Council met in Regular Session on the 18th day of March 2024 at 5:30 p.m. in the Council Chambers at City Hall 302 E. Central Ave Nixon, TX 78140.

A quorum was declared present, and Madame Mayor Dorothy Riojas called the meeting to order at 5:30 p.m.

Roll call was conducted. All council members were present.

Mayor Dorothy Riojas said a prayer. And the Pledge of Allegiance to the United States of America and the State of Texas was recited.

Deborah Bustamante spoke under citizens to be heard regarding agenda items #9 (Discuss, Consider, Possible Action on the resignation of council member Melissa Pompa effective March 1st, 2024.) and agenda item #10 (Discuss, Consider, Possible Action on adding Finance Officer Melissa Pompa as an authorized signatory to all financial accounts, loans, and online banking at Third Coast Bank.)

A motion was made by Justin La Fleur and seconded by Ellie Dominguez to approve adding Melissa Pompa, Finance Officer as an authorized signatory to all financial accounts, loans, and online banking at Third Coast Bank. Motion carried 3-0.

A motion was made by Justin La Fleur and seconded by Ellie Dominguez to approve accepting applications for the vacancy of one council position for one week ending March 25th, 2024, at 5 pm. Motion carried 3-0.

There was no action taken on any necessary 2023-2024 budget amendments under items listed on the current agenda.

Interim City Manager Darryl Becker gave his report.
