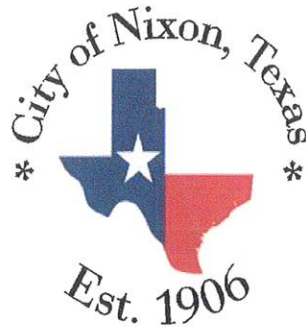




Notice of Special Meeting
Nixon City Council
May 12th, 2025

The Nixon City Council will convene in a Regular Meeting on Monday, May 12th, 2025, at 6:00 p.m. in the Nixon City Hall Council Chambers 302 E. Central Ave Nixon, TX 78140. The order of business will be as follows

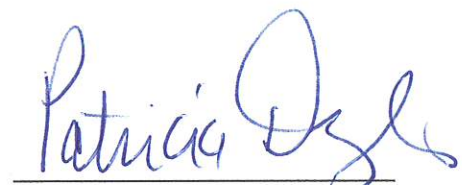

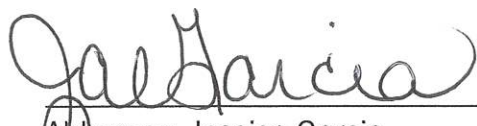

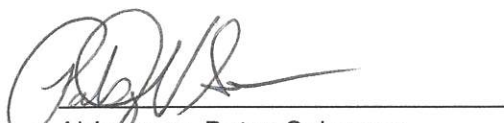
