A motion was made by Justin La Fleur and seconded by Maggie Gaytan to approve the appointments of members to the Tourism and Development board by the city council for a two-year term along with compliance with any other requirements and members must reside inside the City Limits of the City of Nixon and be registered voters in the City of Nixon. Motion carried 5-0

A motion was made by Maggie Gaytan and seconded by Justin La Fleur to appoint Laura Swenson and Briana Dominguez to the Tourism and Development Board. And to cap the members to 13. Motion carried 5-0

A motion was made by Ellie Dominguez and seconded by Justin La Fleur approving the Tourism and Development board officers as elected. Chairman-Travis Hansen, Vice-Chairman-Briana Dominguez, Secretary-Pablo Aguirre, Treasurer-Nina Hernandez, and Sergeant at Arms-Mark Soto. Motion carried 5-0

A motion was made by Maggie Gaytan and seconded by Justin La Fleur to keep the current name of the Tourism and Development Board. Motion carried 5-0

A motion was made by Maggie Gaytan and seconded by Melissa Pompa to allow the Tourism and Development Board to create its bylaws and present them to the council. Motion carried 5-0

A motion was made by Justin La Fleur and seconded by Maggie Gaytan for the Tourism and Development Board to contact Mando Cisneros to get some advice on the building of Memorial Park. Motion carried 5-0

A motion was made by Melissa Pompa and seconded by Justin La Fleur to approve fundraising for the "Park" by the Tourism and Development Board. Motion carried 5-0

A motion was made by Justin La Fleur and seconded by Melissa Pompa to architected and engineered the design of all phases of the theoretical Memorial Park. Motion carried 5-0

A motion was made by Justin La Fleur and seconded by Maggie Gaytan to move agenda item #17 into executive session under 551.071 Consultation with Attorney. Motion carried 5-0
