



Nixon City Council Minutes for 7.18.2022 Regular Meeting

The Nixon City Council met in Regular Session on the 18th day of July 2022 at 5:00 p.m. in the Council Chambers at City Hall 302 E. Central Ave Nixon, TX 78140.

Quorum was declared present, and the meeting was called to order by Madame Mayor Dorothy Riojas at 5:02 p.m.



City Manager Harold Rice gave his monthly report.


Motion was made by Justin La Fleur and seconded by Rene Amaya to adjourn. Motion carried 5-0




