

Ordinance O-2025-09-15 TR

**AN ORDINANCE OF THE CITY OF NIXON, TEXAS LEVYING PROPERTY TAXES FOR USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF NIXON, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026; PROVIDING FOR A REPEALER; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Texas Local Government Code Section 101.002, the Council manage and control the finances of the municipality; and

**WHEREAS**, pursuant to Texas Local Government Code Section 101.002, the Council may manage and control the finances of the municipality; and

**WHEREAS**, the City Council finds that it is necessary and proper for the good government, peace or order of the City of Nixon to adopt an ordinance levying the property tax rate for the 2025-2026 fiscal year; and

**WHEREAS**, the City has satisfied all statutory requirements for public notices regarding the proposed property tax rate.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NIXON, TEXAS THAT:

**Section 1. FINDINGS OF FACT:**

The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.

That there is hereby levied and there shall be collected for the use and support of the municipal government of the City of Nixon, Texas upon all property, real, personal, and missed, within the corporate limits of said City subject to taxation, a tax rate of 0.3155 on each \$100.00 valuation of property for the purpose of maintenance and operation 0.2188 and the interest and sinking of 0.0967 (Debt Fund):

THIS TAX RATE WILL NOT RAISE MORE TAXES FOR THE MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

## **Section 2. REPEALER**

To the extent reasonably possible, ordinances are to be read together in harmony. However, all ordinances, or parts of, that are in conflict or inconsistent with any provisions of the ordinance are hereby repealed to the extent of such conflict and the provisions of the ordinance shall be and remain controlling as the matter regulated, herein.

## **Section 3. SEVERABILITY**

Should any of the clauses, sentences, paragraphs, sections, or parts of this ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of the Ordinance.

## **Section 4. EFFECTIVE DATE:**

This ordinance shall be effective immediately upon passage as provided by law.

## **Section 7. PROPER NOTICE AND MEETING**

It is hereby officially found and determined that the meeting at which this ordinance was passed was open to the public, and the public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.


