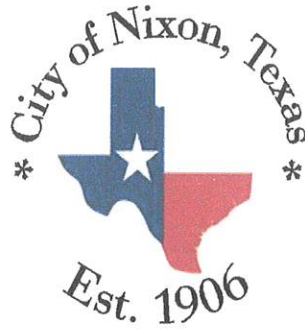




Notice of Regular Meeting

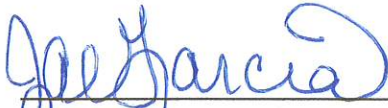

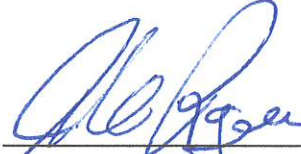

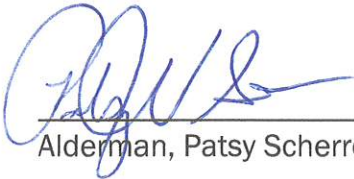
Alderman, Patricia Dingler



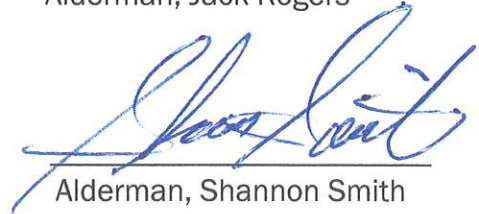
Alderman, Jessica Garcia
