



## League Agreement

**Name of Group:** Durham League

**Date of Event:** 2026 Season

**Price per player:** \$60

**Event Conformation:** Conformation and a guarantee as to the specific number of players is required **Wednesday** prior to the event date. The group will be required to pay for no less than the guaranteed number of players.

**Payment of the Event:** Full payment of the balance for all league fees is **due the day of the event**. Payment is accepted in the form of cash, check, MC, VISA, DISCOVER, and AMEX.

**Dress Code:** Proper golf attire must be worn at all times. Appropriate dress includes golf shoes with soft spikes or smooth soled shoes, collared shirt, slacks or Bermuda length shorts. Metal spikes, work jeans, undershirts, gym shorts, tank tops, halter tops, cutoffs, short shorts, work out clothes, and attire of similar nature are not permitted.

**Conduct:** The league group is responsible for proper conduct while on the golf course property. The league group is responsible for obeying the posted daily cart path rules, replacing divots, repairing ball marks on the green and raking of bunkers. Unruly behavior and inappropriate language will not be tolerated. All golfers will be expected to adhere to proper golf etiquette.

**Pace of Play:** Groups must play their event in **5 hours** or less. All players are expected to play ready golf. All players are to keep pace with the group ahead of them.

**Inclement Weather:** If playing conditions require cancellation of the event by the course, the event will be rescheduled at a mutually agreed upon time. Frost, fog or inclement weather may cause delay of event start. The league coordinator should call the course when the weather is questionable.

**Food and Beverage:** All food and beverage services must be coordinated through the golf course. All food must be purchased from the course unless prior arrangements have been made. **All alcoholic beverages must be purchased through the club. No outside alcoholic beverages are permitted to be brought on the premises at any time.** All food and beverage services will be paid for on the day of the event.

**Personal coolers are not permitted on the golf course at any time.**

**Liability:** The League group and chairperson are responsible for all participants and guests, including their conduct, attire, use and care of the golf course and all other facilities and equipment, including golf carts, as set forth in the Golf Course Rules and Regulations. Further, the League group and chairperson agrees to be held liable for any damage to persons, the golf course, equipment, carts, or facilities caused by the League, its participants or any related third parties, and that any damage to the above will result in the League group and chairperson being billed for said damages.

This agreement and the terms and conditions constitute the entire golf tournament agreement between the golf course and the event sponsor. All changes or addendums to this agreement shall be in writing and made between both parties. Accepted and agreed once signed by both parties.
