

ISPMB PRESIDENT SPEAKS OUT AT SLAUGHTER SUMMIT

held Called the "Summit of the Horse" on January 3-6 at the South Point Hotel in Las Vegas and attended by fewer than 90 people turned into what many humane groups termed, "The Slaughter Summit." ISPMB's president gave the sponsors, United Horsemen, the benefit of the doubt after reading about the group's intention to begin horse rescue. However, after the third day of vitriolic rhetoric attacking the humane groups and proposing only one solution, slaughter, ISPMB's president, Karen Sussman, spoke up! She chastised them for having only one solution. She mentioned that for the past two decades, 900,000 horses die annually in our country. The fact that we only send less than 100,000 animals to slaughter should be testimony enough that it wouldn't be difficult to find a solution for the 100,000 animals other than slaughter! (There are 9 million horses in our country and 1% die annually).

After speaking up, Ed Butcher of MT tried to denigrate Ms. Sussman by saying that humane people do not know what they are speaking about when they live in the cities and have little horse experience. Mr. Butcher apparently did not know to whom he was addressing since Karen has been riding since she was four and was in the horse industry in her adult life until she adopted her first wild horse in 1981. She has thirty years of experience with wild horses alone, managing four wild herds since 1999. It served only to make his argument incredible.

Ex- US Representative, Charlie Stenholm, from Texas was their Keynote speaker. Stenholm, known as the most conservative Democrat in Congress, is now a lobbyist for the horsemeat industry. Stenholm encouraged the participants to contact their local, state, and federal representatives to promote slaughter. As opponents, we should ask for election reform in our country. No Congress person should return to Congress as a lobbyist or have any influence on Congress once they leave!

Temple Grandin, a guest speaker at the Summit who has extensive experience in the slaughter industry, showed frustration when she admitted that slaughter houses continue their undesired practices when no one is there to inspect them. She stated the only way to end this is to have a third party watching the slaughter house practices by video.

The Summit promoters suggested that they must put across to Congress and the American people that they are truly concerned about the welfare of the horse and in the same breath their eyes twinkled when they talked about starting slaughter houses in every state with auction yards right next door. Their premise of the summit and appeal to the American people was based on "unwanted" horses who are suffering in our country. It was obvious as they continued to speak that they see the horse industry as extremely profitable, slaughtering horses and selling them to China and Russia, that is if they can revive it again. There was no true concern for the horses but for their bottom line - profits.

The organizers of the Summit said it took them three years to produce this summit. It took ISPMB's president only five weeks to successfully organize the Wild Horse Summit in Las Vegas in 2007 which included leading scientists and wild horse ecologists and attended by more than 150 people! This should say something about this group's ability to pull off horse slaughter in the U.S.

Categorically, the American people do not want to see our horses slaughtered. It will never happen but we must be vigilant and continue to speak out with good hearts.

BLM DIRECTOR SPEAKS AT THE SLAUGHTER SUMMIT

Surrounded by body guards, Bob Abbey, spoke to the participants of the Summit. ISPMB was pleased with his response that in no uncertain terms the BLM will not allow sale authority or slaughter of the horses in the holding pastures. He also stated that BLM will always have wild horses and burros on public land. His soft-spoken words appeared to be sincere and were emphasized more than once. We applaud the Director for standing firm for wild horses!

NEW CONGRESS CONVENES ALL PREVIOUS BILLS DEAD

As the new Congress convenes, all the antislaughter bills have died. This means that new bills must be introduced into committee, voted upon, and then brought before the House of Representatives. A bill in Congress that makes it to the floor will only last for two years. If it does not pass through both houses of Congress then it dies. ISPMB will be working toward reversing the devastating Burn's amendment to the Wild Horses and Burros Act. This amendment allows for horses over the age of ten to be sold to the highest bidder. Of course this means that they will be sold for slaughter. Although this administration has taken slaughter off the table, we must remain active in reversing the Burn's amendment. It is interesting to note that Senator Burns from Montana suffered a crippling stroke just five years almost to the date that he slipped this rider in the Appropriations bill Thanksgiving 2004 which put our wild horses at great risk.

As wild horses are treated so it will be with the well being of our country. We must remember that our wild horses are true symbols of the freedom and beauty of our country.



BLM SAYS <u>NO</u> TO MADELEINE PICKENS WILD HORSE SANCTUARY

Unbeknownst to Ms. Picken's, BLM announced Friday that her eco-sanctuary for wild horses was rejected. According to Bob Abbey, despite numerous requests for a formal and detailed proposal from Pickens was not forthcoming. Other considerations by the BLM included the cost which would be \$25 per horse higher than other holding areas. The BLM said the law would also have to be changed so that private landowners could be reimbursed for grazing wild horses.

AP's article shows Abbey criticized the Pickens' sanctuary media campaign which he states that some information is "just plain false."

According to Ms. Pickens, the BLM never informed her of their decision until she read of it in the paper.


Pickens recently purchased two ranches in Nevada which consists of 28,000 acres of private land and 564,000 acres of public lands. The land has wild horses roaming freely on the public lands already. BLM is scheduled to remove many of those horses this year in spite of pleas from the public and Pickens to leave the horses alone.

ISPMB RESCUES THREE STALLIONS

Three beautiful bay stallions will be reunited with their Virginia Range herd before the end of January. The stallions were adopted in 2008 by a local trainer in South Dakota. Unfortunately, the adopter fell ill and can no longer keep his horses. These horses are under the age of five and have had little training since adopted. In an effort to preserve this beautiful herd and assist in this hardship case, ISPMB will eventually reunite these horses with their families.




VIRGINIA RANGE STALLIONS ARE REUNITED WITH THEIR MARES



We gratefully acknowledge Dr. Cassandra Nunez and Dr. James Adelman for their generous contribution which allowed ISPMB to purchase 6 foot steel panels to enclose the pasture containing the Virginia mares. The pasture was previously fenced in barbed wire which was not suitable to allow the stallions in with the mares. During the month of August, the stallions were released one and two at a time to join the mares. It was a glorious reunion for the stallions who banded up with their families once again. The project took several weeks as new stallions were released. This reduced the fighting for mares by the stallions. The entire process went smoothly and without incident.

This herd was received in 2007 when the Cheyenne River Sioux Tribe removed the horses gifted to them by ISPMB. Along with the horses several hundred buffalo were removed to allow cattle grazing on their 22,000 acre ranch. The horses originated in Virginia City, NV and are descendants of those horses that our first president, Wild Horse Annie, enjoyed watching. These horses are not protected under the 1971 law although they received the first protection in the United States in 1952 under the Storey Co. law.

It is our goal to move these horses to a larger ranch this summer.





PRESIDENT'S REPORT

We have settled into another tough winter here in South Dakota. When I moved here, I was told that people and animals living here are the hardiest on the planet! My granddaughter, Sienna, had to show me in her science book that South Dakota has the coldest winters and warmest summers. I guess that sums it up. Since the horses and I have moved here, we have experienced blizzards, tornadoes, droughts, floods, and recently a lot of frigid temps and snow. In spite of the hardships we all suffer, this state is one of the most beautiful with an array of stars at night that light up the sky like twinkling beacons. The open spaces, fresh air and assortment of wildlife remind me of what it was like hundreds of years ago. On the last 100 miles to our place, I often count how many cars I encounter as I drive home from Rapid City. I am lucky if I see five cars late at night. This is a wonderful place to maintain four wild horse herds.

We have so many blessings to be thankful for this past year. I want to thank all of you for your wonderful support of our Conservation Center. We have so many generous donors who have requested to remain anonymous. We couldn't have made it through this winter without your help and the help of each and every one of you! Many of you gave when you had very little to give. You realized how important it was to make sure that our herds had enough hay for the winter. Imagine surviving in extremes of temps that drop to thirty below. We here are eternally grateful for your contributions.

Now this spring we have a lot to accomplish. We will be looking at expanding and we will definitely need your help as we begin to grow. Our goal is to purchase another ranch closer to where we can develop our eco-tourism and have enough room to grow our own hay. We have identified the site! With your help we can accomplish this lofty goal.

ISPMB'S PRESIDENT TO GO TO WASHINGTON

Armed with eleven years of data that could transform the management of wild horses and burros on public lands, Karen Sussman will be headed to D.C. to meet with Director Bob Abbey. Since the first herd was rescued by ISPMB in 1999, it has been ISPMB's goal to create a model for managing wild horses in our country. In the forty years since the law passed to save America's wild horses

and burros, there have been few studies that understand the social dynamics of the herds. We have discovered how the bands work together for the good of the entire herd. We know why fertility rates increase when social structures are destroyed through repetitive removals. We see the stability of social structures when not disturbed resulting in a 10% growth rate or even less at times.

BLM states that herd growth is around 20%. This is the direct result of intrusive gathers separating stallions from their mares. It is our goal to assist the BLM in developing a plan that protects wild horses and burros so that future generations can enjoy these icons of our Western heritage.
