Ed is the owner of Code 2 K-9 Services LLC in Omaha, Nebraska.

Ed spent over 30 years in Law Enforcement, 18 years as a K-9 Deputy and 11 years as a K-9 Supervisor and Trainer. Ed also spent over five years working undercover in a Narcotics Task Force purchasing illegal drugs and guns from outlaw bikers, gang members, white supremacists and many other characters. The undercover work provided Ed with invaluable experience that would enable him to read, understand and communicate with some of the most dangerous criminals that officers encounter.



These experiences would prove beneficial in the K-9/Interdiction Unit where Ed seized over \$7 million in drug related currency and almost one ton of marijuana in one stop alone and thousands of pounds altogether.

# Robert Francis Cryne Career Prosecutor in both State & Federal Court Omaha, Nebraska



Robert Francis Cryne is a career prosecutor. Over the past forty (40) years, he has had extensive experience with multi-national investigations involving transnational criminal, narcotics trafficking, and terrorist organizations in the Middle East, Europe and Latin America.

Mr. Cryne retired from the U.S. Justice Department in July, 2014, after service with the Special Operations Division (SOD) in Washington, DC, and before that as an Assistant U. S. Attorney with the United States Attorney's Office in Nebraska on the Organized Crime Drug Enforcement Task Force (OCDETF) and the Joint Terrorism Task Force (JTTF). He previously worked for many years as a Deputy County Attorney with the Douglas County Attorney's Office in Omaha, first on the Felony Trial Staff, then as Deputy in Charge of Narcotics, Firearms and Special Operations. During the cold War from 1979-1982, he served on active duty as a Captain in the U.S. Army Judge *Advocate General's Corps in Western Europe*.

During the Second Gulf War, from 2005-2006, Mr. Cryne served with the Regime Crimes Liaison's Office (RCLO) as an Attorney Adviser to the Iraqi High Tribunal for the Trial of Saddam Hussein and other former high officials of the Iraqi Ba'ath Socialist Party for War Crimes, Genocide and Crimes Against Humanity. He also served as RCLO Principal Liaison with the Kuwaiti government concerning Iraqi War Crimes and atrocities during the Invasion and Occupation of Kuwait 1990-91. His duties took him around Iraq and the Persian Gulf. He was recognized for Distinguished Service by both the Iraqi and Kuwaiti governments. He received the Director's Award, U. S. Department of Justice, for Outstanding Service in the Global War on Terror.

Since retiring from government service in 2014, Mr. Cryne has engaged in legal practice, been court appointed as a Special Prosecutor, has served as a consultant on national and International Law Enforcement, Organized Crime and Terrorism, and is an Adjunct Professor at University of Nebraska School of Criminology and Criminal Justice, and other area institutions of higher education.

Mike began his career with the NSP in 1978, stationed in Fremont, NE. In 1987, Mike transferred to Omaha. In 1982, he was promoted to sergeant and moved to Lincoln to work at the Nebraska State Patrol Training Academy. From 1987 until 1999, he worked in the training division. In April 1999, he took over as Lieutenant of the Police Service Dog Division, after already working with patrol dogs for 10 years.

Mike received numerous awards, including Nebraska State Patrol Group Citation Awards and the Nebraska State Patrol's Distinguished Service Award.



Throughout the years, Mike accumulated countless hours of training in areas of defensive tactics, special weapons and tactics (SWAT), and police service dogs.

Mike is an internationally recognized instructor and highly respected trainer of police service dogs. He has taught in Australia, Canada, Germany, Hong Kong and the United Kingdom, as well as throughout the U.S. In 1998, he became one of a handful of Americans selected to judge at the International Police Dog Championships in Lübeck, Germany. He's a teacher of judges — the highest rank within the German canine training system. In October of 2015, Mike became a Staff Instructor at the Nebraska Law Enforcement Training Center, allowing him to continue sharing his knowledge and expertise with local, county and state police recruits.

Deputy Gries attended Buena Vista University in Storm Lake and graduated in 2006 with a Bachelor of Arts Degree, attaining the Dean's List. In December of 2006, Gries graduated first in his class academically from the Regional Law Enforcement Academy in Waterloo, IA

and began his law enforcement career working for the Coon Rapids Police Department.

Deputy Gries worked two years in Coon Rapids and four years with the Audubon County Sheriff's Office before finding his home at the Guthrie County Sheriff's Office.
