

## ART COMPETITION ANOUNCEMENT

April 1, 2021

MYKONOS HIGH PRIVATE CAPITAL COMPANY (hereinafter MYKONOS HIGH) announces an art competition for the promotion of an artist or a group of artists as well as for the promotion of the open space (ARENA) which will adorn the company.

### Introduction

MYKONOS HIGH wishes to showcase the natural and wild beauty of the island of Mykonos and of the area of KOUNOUPA in particular, as well as to provide a space for expression that can host artistic, cultural and entertainment events. The outdoor area of MYKONOS HIGH (hereinafter referred to as the ARENA), has been designed with the protection of the natural beauty of the area in mind. Part of this outdoor space of the ARENA, with an area of approximately 1,000.00 square meters, will be used as a venue for the announced competition (photo of the space is attached). Wishing on the one hand to aesthetically upgrade the space and on the other hand to encourage the creative nature and artistic expression of young artists, MYKONOS HIGH proceeds to carry out a competition for the selection of the artist or group of artists who will undertake to decorate the northwestern outdoor section of the space. Artists should create an artwork that will promote and highlight the area, art and the idea of creating a space where visitors will have the opportunity to get in touch with nature and art while wandering around MYKONOS HIGH. The ultimate goal is for the creation that will adorn ARENA to become an attraction for the visitors of Mykonos. It is possible that the works that will adorn ARENA may gain international acclaim. This competition is of particular value, as it takes place during the COVID-19 pandemic, a milestone that may inspire participants accordingly.

### Who can participate:

The invitation is addressed to Greek citizens over 18 years old, EU citizens over 18 years old and any other person, who has resident permit in Greece. Participants must be able to legally create and sell works of art. They can participate either individually or in groups. Each group must consist of up to 3 people. However, the leader of each group will be considered the contestant and shall hereinafter be referred to as "the artist". Contestants have the right to participate with multiple proposals and corresponding applications. All contestants are required to read the terms, regulations and privacy policy of MYKONOS HIGH during their stay at the site of the competition, By participating, contestants fully accept the said terms and conditions. The maximum number of contestants is 12 (regardless of individual or group participation) and the maximum time limit for completion of the competition is 3 days from its commencement. Materials that can be used are for instance the

following: Wood, Stone, Iron, Clay, ropes, cement, soil, paints, digital media etc. Participants must indicate the materials they will use and their cost in their participation dossier. It is noted that ARENA is in an outdoor area and therefore, participants need to take into account the issue of durability. The area of MYKONOS HIGH and MYKONOS HIGH ARENA is characterized by strong north winds and humidity. The rocky landscape is dominant in the area as is typically the case with the islands of the Cyclades.

#### Deadline:

The deadline for submission of proposals is June 1, 2021 and the competition will take place from 17-6-2021 to 20-6-2021.

#### Submission:

Each participant should send their proposal to: HUB VRYSI, MYKONOS, 54600. The participation dossier must be clearly marked with the phrase: "PARTICIPATION IN COMPETITION". The participation dossier of each participant should include the following: - Signed Application form according to the attached template - Scale drawings depicting the participant's proposal - Brief description of the proposal and justification of its connection with the theme of the competition - Analysis of materials and tools to be used - Works timetable- Project team - Project costing, which will include the cost of Raw Materials, consumables (according to the attached template). It is necessary to include a presentation of the participant's previous works - Certificate of studies, if any. After contacting MYKONOS HIGH, it is possible for each participant to visit the area, in order to gain a better understanding of both the space itself and the surrounding environment.

#### Evaluation process

The evaluation of proposals and participations shall be carried out by MYKONOS HIGH. The committee, after evaluating the proposals, will shortlist the candidates, who must not be more than 12. The winner will be announced by a decision of the evaluation committee, after checking the score of each participant. More specifically, on the last day of the competition printed and / or digital means (e.g. voting via Instagram, etc.) will be provided, so that both participants and the public, who may be present at the site will be able to rate the projects. The criteria to be considered in the evaluation by the committee, the public and the participants are the following:

- Topic - Clarity. The projects will be evaluated in relation to the subject of the competition.
- Originality of the Idea - Imagination. An important criterion will be the originality and authenticity of the designs.
- Degree of difficulty - Quality of the work from an artistic point of view. This criterion emphasizes the aesthetic result from an artistic point of view.
- Cost of construction.

The relevant ranking will take place in the presence of the notary of Mykonos Mrs. Georgia Toli at her notary's office in the area of Dexamenes, Mykonos the day after the end of the competition

Expense coverage:

MYKONOS HIGH will undertake the financing for the materials required for the implementation of the works based on the costing that is included in the artists' proposal. Similarly, MYKONOS HIGH assumes the cost of accommodation of the artists / groups on the island of Mykonos, not including food and transportation costs. The accommodation of the participants will take place in a space that is managed by the organizer. In any case, the choice of accommodation will be carried out by MYKONOS HIGH.

Awards:

The best three entries will share the prize of 2,000.00 euros and specifically, the first-place winner will receive the amount of 1,000.00 euros and a commemorative medal, the second-place winner will receive the amount of 600.00 euros and a commemorative medal and the third-place winner will receive the amount of 400.00 euros and a commemorative medal.

Terms - Conditions for Participation

- 1. MYKONOS HIGH has no obligation to pay any remuneration or general compensation to participants whose proposal was not selected or did not win one of the first three places.**
2. MYKONOS HIGH shall not undertake to guard the premises but shall only proceed to fence the entire property, and therefore it has no obligation to compensate the artist or restore the artwork in case of vandalism or destruction by third parties and due to weather conditions.
3. MYKONOS HIGH reserves the right to replace the artwork or restore the space to its previous condition whenever it wishes. Especially if after its completion the artwork does not correspond to the approved design and is deemed unacceptable, MYKONOS HIGH has no obligation to the artist, other than the payment of the construction cost and the cost of accommodation, up to the day of their notification. **The work remains the property of MYKONOS HIGH, and the company shall be able to use it freely and as it wishes, without having to return it to the Artist. It is understood that in the above case prizes do not apply.**
4. MYKONOS HIGH has the obligation to keep a file of the participants' personal data exclusively for the purposes of this competition. After the completion of the competition and the delivery of the prize, the file will be destroyed, before the above No

5. tary, who will draw up a relevant destruction certificate.
6. Copyright: Participants in the competition must be the sole copyright owners of the works they submit. In case of misappropriation of copyrights of third parties, the participation will be canceled and the participant will be the only accountable to the real owner of the copyright. The participant shall be excluded from any subsequent competition and shall not be able to participate while giving permission to the Company to provide their details to the real owner of the artwork. In any case, the "artist" is responsible for their participation in the competition. The participants of the competition authorize MYKONOS HIGH to use the works in any way it wishes in order to promote the competition in the media of MYKONOS HIGH (social networks, website, google, print communication, etc.) as well as in any third partner media. **The works will always be accompanied by the names of the artists.** Participants know that they offer their work for free, in the context of the promotion of the competition and they shall not pursue any claims against MYKONOS HIGH.
7. **The works should not infringe copyright, trademarks or other intellectual property rights of third parties.**
8. Exposure of sensitive personal data on the works is not permitted.
9. Each participant is solely responsible for the complete and correct completion and submission of their personal data. MYKONOS HIGH PC reserves the right to exclude any participant at any stage of the competition, if it is found that the information provided by said participant is incomplete or untrue and does not correspond to reality.
10. Organizers verify the validity of the participations and may exclude any participant who attempts to illegally interfere in the participation process or whose participation does not comply with these terms. In this case, MYKONOS HIGH owes the cost of accommodation and construction up to the day of exclusion of the participant.
11. Participants must not have a final conviction against them for one of the following reasons: a) participation in a criminal organization, b) fraud, c) terrorist crimes or crimes related to terrorist activities, d) money laundering, e) theft or robbery, f) crimes against life.
12. **Contestants accept that after the end of the competition, their works shall remain in the exclusive ownership of MYKONOS HIGH and that they shall not pursue any claims against MYKONOS HIGH and MYKONOS HIGH shall not have the obligation to return said works, unless it so wishes. In particular, it is expressly agreed that the works of the twelve participants (including the works of the winners) will be, after the end of the competition, property of MYKONOS HIGH and the company will be free to do with these as it wishes.**

**13. All contestants must comply with the protective measures against COVID-19, as provided by the Greek Government. In case of violations of the protective measures, MYKONOS HIGH reserves the right to judicially pursue the fines that may have been confirmed against it for violations of protective measures against COVID-19 made by the participants. Each contestant is solely responsible for any violations of the above protective measures.**

Cancellation of the competition- Other terms of the competition:

The competition may be extended or canceled or modified in accordance with its terms at any time. Interested parties can be regularly informed from the website of MYKONOS HIGH. MYKONOS HIGH is not responsible for any damage or loss. It does not offer any guarantees, express or implied, about any matter that arises and it does not offer any financial transactions.

#### Amendments

Modifications by the organizers of the terms, duration or type of prizes offered during or after the end of the competition, as well as the postponement of the date of conduct, are not excluded.

Any changes deemed appropriate will be submitted to the notary, who guarantees the fairness of the procedure and will be announced with entries on the website [www.mykonoshigh.com](http://www.mykonoshigh.com)

#### Promotion (Advertising)

The organizing company may carry out all actions deemed appropriate by it for the advertising of the procedure and the results of the competition. Indicatively the following actions are mentioned: the reproduction of audiovisual material from the draw or the delivery of the gifts to the winners, the publication of the winners' names, and also the sharing of the experience of the winners after the end of the trip in which they participated. The participants give their consent to the organizing company for the above promotions, they consent to the assignment of the necessary copyrights free of charge and explicitly, stating that the above is not an infringement of the right of personality.

#### Acceptance of the terms:

Participation in the Competition implies the unconditional acceptance of the terms and regulations of this Competition and the automatic waiving by each contestant of the right to challenge or object for any reason. These terms shall be governed by Greek law and any dispute regarding the Competition shall be resolved by the competent Courts of Syros. MYKONOS HIGH complies fully with the provisions of Law 4624/2019, on the protection of personal data.
