APPLICATIONS ARE TO BE APPROVED BASED ON COMPLIANCE OF RULES AND REGULATIONS

**CANCELLATIONS:** A cancelled application for any reason will forfeit fees paid.

**HOLDING DEPOSIT:** Deposit is transferable to booth fee. NO PERSONAL CHECKS, Money Order only. Payable to: Navajo Nation

**BALANCE:** Must be paid in full by August 17, 2018. If deadline is not met vending, space will be forfeited to the next vendor on waiting list who has full payment.

**VENDOR INSURANCE:** Vendor agrees to indemnify the Navajo Nation and the 72nd Annual Navajo Nation Fair against claims for damages to persons or property resulting from the actions of the Vendor. Vendor hold harmless the Navajo Nation from any loss, damage or expense whatsoever from any and all claims and or demands arising from accidents occurring on the premises of the Navajo Nation, Navajo Parks and Recreation, Navajo Nation Fair Office. A copy of your Certificate of Insurance is required upon submittal of application and deposit. Commercial General Liability \$1,000,000 and Aggregate \$2,000,000. Navajo Nation is to be added as additional insured. A copy of insurance coverage for vehicle insurance and golf carts is required for use on the fairgrounds.

**INDEMNIFICATION:** All vending is an at-risk business in which sales are not guaranteed, any loss in profit, expenses, ect. will not be covered by Navajo Nation, Navajo Parks and Recreation, Navajo Nation Fair Office. **Vendor agrees to indemnify and hold harmless the Navajo Nation from any loss, damage, personal or bodily injury to person or property whatsoever from any and all claims or demands arising out of any incidents that occur on the premises of the Navajo Nation Fairgrounds and/or caused by the actions of the vendor.**

**FOOD VENDORS:** To comply with inspection completed by NAIHS, DOH, Safety & Loss, NN Fire Department; All Food Vendors with open grills/ovens/fryers flammable equipment will be assigned spaces 10 feet away from any building structures to prevent fire hazards. All workers will have Navajo Nation food handler's cards visibly posted at all times. Grease Traps are located north of Navajo Pavilion and will be used to properly dispose of all fat/oil/grease. Unauthorized disposal will not be allowed. Navajo Pavilion are to utilize grease traps to avoid clogs in the drainage systems; continuous unclogging of a drain will be cause for eviction of rental space.

**GENERAL INFORMATION:** Upon entering the fairgrounds, check-in is required with the Fair Office to receive space assignment and concession/exhibitor's packet. Please call Navajo Nation Fair Office (928) 871-6478 for more information

**HOURS OF OPERATION:** The 72nd Annual Navajo Nation Fair opens Monday, September 3, 2018 and ceases, Sunday, September 9, 2018.

**SET UP SCHEDULE:** Vendors are allowed to move into spaces between August 31, - September 2, 2018 between the hours of 8AM and 5PM. In the event the exhibitor/concessionaire fails to occupy their booth or space by 5PM September 3, 2018 the Navajo Parks and Recreation, Navajo Nation Fair Office will forfeit your application and assign booth/space to next on the waiting list. No REFUND of payment(s) made of space. During move in please DO NOT PARK vehicles along established Fire Lanes along the Midway, Rodeo Grounds, in and around all buildings. This will apply throughout the duration of the fair. Vehicles in violation will be towed without warning at the owner's expense.

**BUILDING & STRUCTURE:** The Navajo Parks and Recreation, Navajo Nation Fair Office staff will not build self-contained booths, NO Exceptions. All concessionaires/exhibitors will supply their own materials and appliances. **Activities must be confined to the space assigned to each concessionaire/exhibitor and will not infringe on other vendor space or established fire lane.** All portable and temporary structures are to be constructed arranged, maintained and operated to avoid unseen danger to the lives and safety of its occupants and fair patrons. All structures must be made of fire resistant materials. Concession trailers are approved as designed specifically for food vending. All units shall be skirted on all sides, including the hitch to keep debris from gathering underneath the unit. All vendors are prohibited from operating and extending their activities into the midway or walkways to keep fire lanes unobstructed. All electrical outlets are for use to operate booths. A limitation of electrical appliance will be enforced to eliminate electrical shortage for all vendors. Vendors are not allowed to utilize outlets for personal motor homes/trailers, a camping permit can be purchased and parking is designated in specific locations.

**EQUIPMENT:** Machinery in motion must be located safely inside exhibitor's space with adequate safeguards. Limitation on the number of appliances to one (1) refrigerator and one (1) freezer due to electrical overload.

**CHECK OUT:** All vendors during the 72nd Annual Navajo Nation Fair must remain open until closing of event on Sunday, September 9, 2018

**The Navajo Nation Fair Office reserves the right to reject concessionaires/exhibitors if the above restrictions are not observed and if the concession will be hazardous or dangerous to other concessionaires/exhibitors and the public.**
