They would draw from those who have responded by surveys that they have interest in serving. If they have trouble filling the position they could seek the assistance of the Nominations Team.

#### **Job Description of Administrative Board and Its Leadership**

The **Administrative Board** chair should organize an annual planning meeting for church vision and ministry goals. An effective chairperson provides initiative, coordination, and collaborative leadership for the congregational group that does planning, goal setting, implementation, and evaluation of ministry to fulfill the mission and vision of the congregation.

This leader benefits from having one or more of these spiritual gifts: leadership, administration, faith, shepherding, servanthood, discernment, and teaching. This leader should show evidence of prior effective ministry leadership and evidence of active and growing discipleship. Useful skills for this position are the ability to listen to and communicate with people of all ages, work with other ministry leaders, preside over meetings, delegate responsibility, and follow up to complete tasks. This leader should show genuine interest in responding to the hopes and concerns of people in the community.

#### **Responsibilities of the Chairperson**

- This person should organize an annual planning meeting for church vision and ministry goals.

- During the year, this leader prepares and communicates the agenda for meetings, leads the meetings, follows up actions by assigning responsibility for implementation, coordinates the activities of the leadership teams, and maintains a healthy and growing spiritual life.

### **Job Description:**

- Contacts and schedules contractors as required -Provide basic maintenance services to the church and property
- Oversees any contracts for other maintenance services to be done by others and supervise contract personnel
- Help schedule any events to be held on the premises as needed
- Work with other teams to help provide any special needs associated with special events such as weddings, receptions, etc.
- Ensures the facility is closed and secured
- Ensures property is clean and in order inside and out after any events have taken place

### **Chair of the Property Team:**

- The chair of the property team will convene meetings of the team as needed and respond to emergency situations within the facility.
- The chair of Church Property may serve as long a term as he or she wishes unless asked to step down by the Administrative Board
