Dancewear: This is an **Intro to Ballet OR Intro to Dance Trial Class**. Dancer(s) may arrive in leggings and a t-shirt or dance attire if dancer(s) has/have purchased dance items. If dancer(s) wear appropriate dance attire **NO** underwear under our leotards. Our tights are our underwear! This is a normal thing in the dance world. Underwear is not flattering to the eyes and we strive for straight lines. We will send out dancers who wear appropriate dance attire out, if underwear are visible. The only Jewelry that is allowed are stud earrings, wedding bands, or medical jewelry. All dancer(s) must be barefoot (if no shoes are purchased) and, all dancer(s) must have their hair up in a bun for all genre of classes!

If you would like to purchase dancewear:

We have an online store to help alleviate the overwhelming amount of items available. Recommended, personal favorites by Instructor(s) have been selected. Dancers are not limited to these recommendations. Dancewear may be purchased at any dance supply store or online dance store. Some recommended online dance stores include, but are not limited to Discount Dance Supply and Dancewear Solutions. *****Note: please call and ask for assistance for the appropriate "Size" Dance Shoe. The Child's "STREET SHOE" will be a different size then a "DANCE SHOE". Please do not buy for foot growth, big shoes that do not fit appropriately will not be allowed and can cause injuries. WE are also not responsible for in correct sizes of dancewear. Ballet Slippers MAY NOT be slipper like material. Ballet Slippers must be leather or canvas. Please refrain from Ballet Slippers with elastic ties on the tops. Elastic ties are very distracting and disruptive. Canvas shoes are easier to clean. They may be washed and LINE DRIED ONLY. SHOES WILL SHRINK IF DRIED IN A DRYER!!! Examples of unacceptable dance shoes: ballet slippers from Target or Walmart.**

Class Cancellation and Absences:

The decision to run or cancel a class is at the discretion of Black River Falls DANCE. Holiday Closures are excluded from makeup classes. In order for a class to be held there must be at least (5) pre-registered students. There will be no refunds for classes that are cancelled due to weather, instructor illness, Black River Falls DANCE related performances, and cancellations due to building problems (i.e. power outages, etc.). Makeup classes will be scheduled per instructor, but may not be scheduled on the same weekday or time of the cancelled class. The days that Black River Falls DANCE would be closed would be posted on the Lunda Community Center's Facebook page, Black River Falls DANCE Facebook page, and emails will also be sent out. ****Initial here**

There will be NO credit adjustments/refunds for voluntary withdrawal or for classes missed due to the student's personal schedule (i.e. vacations, sports participation, outside performances, etc.) or illness.

Rules of Etiquette and Professional Conduct:

We expect, and strongly encourage, parents/guardians to support students in striving to attain a high level of professionalism and achievement and to work in partnership with Black River Falls DANCE, and Instructors to promote learning and enjoyment of dance. Students must attend all registered scheduled classes from beginning to end, arriving on time. Black River Falls DANCE Instructors reserve the right to not admit latecomers of more than 10 minutes to reduce the risk of injury and to avoid distraction for fellow classmates. If you will be tardy please call/email in advance prior to the start of class. Instructor(s)

reserve the right to send out dancer(s) or refuse instruction to dancer(s) who are having a difficult time participating or behaving throughout the duration of class. We have the right to terminate contracts and enrollment due to consistent misbehavior, emotional readiness, and, breach of contract for both dancer(s) and guardian(s).

Prior notification for all missed classes is requested at least an hour in advance to the start of class, via email or phone call. Please contact the instructor: Nicole Folkedahl, contact information is on the last page. ****Initial here**_____

Dancer(s) must arrive 5 minutes early for class, and be dressed prior to entering the studio room. If a student needs to change in the vicinity of the premises prior to the start of their class, they should arrive 10 minutes early. ****Initial here**_____

Dancer(s) that arrive dressed and ready for class are asked to remain outside until the instructor opens the door and dismisses the previous class. ****Initial here**_____

Please make sure Dancer(s) use the bathroom before class time begins. Bathroom breaks take away from learning time and are a distraction. ****Initial here**_____

Parent(s) of small children (3-4 years), dancer(s) **MUST** turn 3 by the end of September of every new dance season and, **MUST** be fully potty trained. PLEASE make sure to use the bathroom before class begins! We are **NOT** a preschool! We will not tolerate to be used as such. Preschool experience is recommended but, NOT required. We use a 3 Strike Warning System along with "Treasure Box" as a Reward. Parents are required to remain outside of the studio room during class.

Parent(s) of those under 12 years of age must remain in the building at all times. Parents who chose to utilize the facility during class must purchase a Day Pass or Walking Track Pass from the Lunda Community Center. Passes can be purchased at the Front Desk. If a parent/guardian invites another family member to watch class, they must purchase an Observer Pass for \$1.00

Dancer(s) must be picked up promptly after class. Lunda Community Center, Black River Falls DANCE, and Instructors are not responsible for unaccompanied children. If you will be more than 10 minutes late for pick up, please call/email the instructor. More than two late pick-ups without notification will result in a \$5 per 5 minutes charge to your account.

No parent(s) or small children in the classroom during class time unless prearranged with the instructor(s). **ONCE THE DOOR'S ARE CLOSED PARENT'S MAY NOT ENTER AND DANCER'S MAY NOT LEAVE UNLESS ADVISED!** All small children/sibling(s) must refrain from banging on doors, windows and, opening doors. Small children must be contained and must also follow Lunda Community Center's policies. We have other classes and community members in our Center. The Lunda Community Center's front desk may ask you to leave at any time! Continuous distraction from sibling(s) or smaller children can and will be asked not to return. All visitor(s) are subject to these Rules. Parent(s) and other visitor(s) may observe classes through the viewing windows; PLEASE be courteous of others and do not be distracting to the dancer(s).

- ✓ Minimal talking in class to prevent distraction from instruction.
- ✓ No loud talking, running, gymnastics, or horse playing on the premises.
- ✓ If instructor allows recording of choreography, it may only be used for instructional purposes – **NO social media**
- ✓ Dancer(s) failing to comply with these rules may have their performance privileges revoked, or maybe dismissed from Black River Falls DANCE. Parent(s)/Guardian(s) and Visitor(s) failing to comply with these rules will be subject to dismissal from the premises including dismissal of the Dancer(s).
