

Tourism and Recreation Committee MEETING MINUTES February 22, 2024

1. Introductions

- a. Tom Wdowik Oscoda AuSable Greenbush Convention and Business Bureau
- b. Gary Blaser Iosco County Parks & Recreation

2. Trail Discussion

- a. ATV/ORV and Snowmobile Trail Funding
 - i. Gary Blaser discussed that losco County Parks & Recreation receives funding from the State of Michigan from snowmobile trail permit sales to maintain and manage the snowmobile trails in losco County. That includes the ability to purchase equipment. That same opportunity currently does not exist for the ATV/ORV trails and the needs are substantial in losco County as the trail system is being used more and more.
 - ii. Gary is attending a meeting with the MDNR in Sault Ste. Marie to discuss the ability for the State to start providing ATV/ORV maintenance funding. More information will follow.
 - iii. There are 60 miles designated as ATV/ORV trail in Iosco County
 - iv. There are 103 miles designated as snowmobile trail in losco County

b. Trail Promotion

- i. US Forest Service roads being open to the public for ATV/ORV use is a pilot and could be temporary.
- ii. US Forest Service has limited law enforcement to manage use of the roads.
- iii. Preference is to not promote the use of the US Forest Service roads, let it happen naturally.
 - 1. If we are planning to promote any trails, promote the use of the ATV/ORV designated trails and snowmobile designated trails.

c. County Trail Map

- Iosco County recently completed its new trail map which promotes the ATV/ORV, Snowmobile, Corsair and etc. trails in the County. The map is currently available at the Iosco County Courthouse and other vendors across the County.
- ii. Rich Castle is working with losco County to inquire about a link so the trail can be accessed digitally.

3. Iosco Parks & Rec Community Grant

- a. Gary Blaser overviewed the parameters for the grant provided by losco Parks & Rec.
 - i. \$25,000
 - ii. Available for brick-and-mortar projects (ex. pavilion, courts, etc.)
 - iii. Townships and municipalities can apply.
 - iv. No match required.

- i. CVB has financially supported the construction of the losco Exploration Trail/Iron Belle Trail as well as Corsair
- ii. CVB applied for the Trail Town designation in 2023 but was unsuccessful as they were seeking designation for Oscoda, AuSable, and Greenbush and was told it can only be for one community.
 - 1. Will be reapplying in 2024 and for Oscoda only to be designated as a Michigan Trail Town.
- iii. AuSable Township portion of the Iosco Exploration Trail will be constructed in 2024.
- iv. Priorities are important for this committee to be successful.
- v. While the CVB works independently, we need to reach outside of our boundaries to promote our county and region.
