


# East Tawas/Tawas Bay Cruise Ship Proposal

#### Introduction

The East Tawas/Tawas Bay Cruise Ship Proposal is to make you aware of the City of East Tawas' interest in becoming a Great Lakes cruise ship destination. The proposal will explain why East Tawas and Tawas Bay are an ideal destination for both the ship itself and the visitors it brings.

# East Tawas, Michigan

East Tawas, Michigan is a community located on the shores of Tawas Bay and Lake Huron in northern Michigan. Along with its sister city, Tawas City, the two communities have a long and rich 162-year history as being a port city on Lake Huron for both recreational and commercial vessels including Great Lake freighters.

The two communities have a year-round resident population of approximately 5,000 people, but that population significantly increases during the summer months due to an influx of seasonal and second home residents who visit due to the proximity of Lake Huron. In addition, the two communities see a significant number of visitors as the area is a top draw for tourists from Detroit, Flint, the Tri-Cities, and Ohio during that same timeframe.

The economy of the Tawas area has changed many times over its history, but there has always been one constant and that is tourism. Even before roads connected East Tawas to the larger communities in southern Michigan, visitors were coming to the area via boat and by rail. With the advent of the automobile and a highway system, the way people travel to East Tawas is different, but what is not different is that they still come. The internet provides a significant opportunity to track interest in an area and according to SEMRUSH Analytics and MyMichiganBeach.com, the East Tawas area averages a monthly search volume of nearly 20,000 searches. In comparison, Alpena, MI located about 60 miles to the north and a current cruise destination averages a monthly search volume of nearly 16,000 searches.


#### **Tawas Bay**

Tawas Bay's maritime history is rooted in the geographical and botanical characteristics of the region colliding with the ballooning economic demand for building materials: wood and plaster. Logging in the 19th century was river based because the practice was to cut trees and float the logs to mills at the river mouths. Although only one river, the Tawas, flowed into our Bay, two other major logging rivers, the Au Gres and AuSable, flowed within short land-travel distance from the bay and a relatively long distance from their mouths and mills. As a result, Tawas Bay became an important maritime port supporting the logging activities on all three: receiving materials and shipping the finished product.

Concurrent with the development of the lumber industry, gypsum was discovered and a mining industry that continues today began. Sawdust and scrap wood from the mills used as fuel allowed the development of other products: gypsum was calcinated and converted into plaster, brine water from wells was reduced to salt, and sugar beets were refined into sugar. In the late 19th and early 20th century lath, bucket bolts, shingles, barrel stays, boards, framing lumber, wooden squares and rounds, plaster, salt and sugar were shipped. The Tawas Bay communities were also served by regularly scheduled passenger and packet freighters.

Currently there is an active gypsum shipping facility servicing 680-foot Great Lake freighters. The 180-foot NOAA's GREAT LAKES GUARDIAN is a frequent visitor to the East Tawas State Dock and in difficult weather situations, tugs and tows, freighters and pleasure craft seek shelter here. The Bay and its communities are able and ready to service and support a robust cruise industry. Its geographical and botanical characteristics make Tawas Bay an attractive destination with ease of access to beautiful rivers, forests, nature and historic sites.

#### **East Tawas Dock/State Harbor**

The East Tawas Dock and State Harbor has been a staple in the community since the lumbering era that drove the economy of the region from late 1800's into the early 1900's. The dock has seen upgrades over the years and today serves a much different purpose and that is to provide protection for Lake Huron recreational and smaller class commercial or educational vessels and the marina housing numerous recreational boats.

In 2010, Develop losco developed a study to evaluate the ability for the East Tawas Dock/State Harbor to support the mooring of Great Lakes cruise ships. The harbor provides for an excellent sheltered location for ships to harbor. Depths in the harbor range from approximately 20-25 feet at the entrance and 10-12 feet adjacent to the main pier and marina area.

According to the study, the main pier is in overall good condition. The pier is constructed with both a sheet pile wall segment that is in very good condition and a wood crib segment that is in adequate condition. The steel sheet pile wall portion is currently the jurisdiction of the United State Army Corp of Engineers, and the wood portion including the marina area is currently the jurisdiction of the Michigan Department of Natural Resources. Any commercial use of the dock would require a "use" permit from the either of the of entities depending on the section of dock used.

The study goes on to say the dock itself can support the docking of smaller cruise ships with upgrades either outside or inside the pier. While repairs have been made and reconfiguration of the marina has occurred since the report was developed, the mooring system including the two pile clusters and fenders that was recommended has not been completed. This upgrade is still desirable and if a cruise line could commit to East Tawas as a port destination, the community would look to secure funds to make this upgrade and work with the United State Army Corp of Engineers.

The study was developed at a time when it was thought that a cruise ship would need to use the dock to deliver passengers to the port. Since then, and being used elsewhere along the Great Lakes, cruise lines are now anchoring offshore and tendering people from the cruise to the docking location. The current configuration of the East Tawas Dock provides ample opportunities for the docking of a tender boat to bring passengers to shore.


In summary, the East Tawas Dock/State Harbor is adequate to supporting the tendering of people from a cruise ship anchored in Tawas Bay. Additionally, with upgrades, the East Tawas Dock/State Harbor is adequate to support the docking of the cruise ship.

#### **Downtown East Tawas/Excursions**

Stepping off the boat at the East Tawas Dock/State Harbor enters you into relaxing and walkable downtown East Tawas. Before reaching the end of the East Tawas State Dock you will be greeted with the white sandy beaches of the sunrise side of Michigan and the clear blue water of Tawas Bay. The beaches are usually full of beachgoers during the warm summer months and offers the cruise line an opportunity that many other Great Lake cruise destinations do not provide. Where else can you swim or dip your feet into one of the largest freshwater lakes in world while being on a cruise ship? There are bathroom facilities, beach volleyball, and water sport rentals all nearby to provide a memorable Great Lakes experience.

The East Tawas shopping district is conveniently located across the street providing dozens of shops, boutiques, bars and restaurants. At this point, you are located within one mile of 16 different eateries, and specialty shops providing items such as clothing, gifts, jewelry, coffee, candy, and chocolate. In addition, the community also provides a hospital, banking/ATM, post office, and grocery stores that can help provide the necessities. Downtown East Tawas offers cruise goers a delightful shopping experience. The following map shows the variety of shops located in the downtown.

If you are a history buff, within a short walk of the downtown and the beach is the losco County Historical Society Museum. The Museum is a two-story Victorian home that offers an insight into the local history of the Tawas area including its rich maritime history.

East Tawas and the surrounding area provide many different opportunities for excursions. Besides a walkable downtown and beach area, a tour of the historic Tawas Point Lighthouse and Tawas Point State Park is a key highlight. The State Park can be reached by our bike trail that stretches 13.1 miles along Tawas Bay or is a short 10-minute drive. The state park also offers hiking trails that are popular for world renown bird watching and is surrounded by the white sandy beaches of Tawas Bay and Lake Huron. This spot is also notably used for wind surfing and kite flying. In addition, there are opportunities to enjoy the waters of Tawas Bay and Lake Huron if you are interested in charter fishing, wave runners/jet skis, and kayaking. Also, if your cruise goers are golfers or want to try golfing, there is an award-winning golf course 10 minutes away from downtown East Tawas and a golf simulator establishment downtown.

Additionally, within 20 miles of downtown East Tawas there are many other possible options for excursions by bus such as canoeing and kayaking the famous AuSable River. Also, along the river there are the scenic overlooks and historical sites of Lumberman's Monument & largo Springs. On the way back to East Tawas, a stop in the riverfront/lakefront town of Oscoda and their downtown shopping district and beach area is also an option.

Whether cruise goers want to stay close to the dock and enjoy the walkable area of East Tawas or take excursions to see additional sites in the East Tawas area, there are multiple opportunities to enjoy East Tawas as a cruise ship destination.
