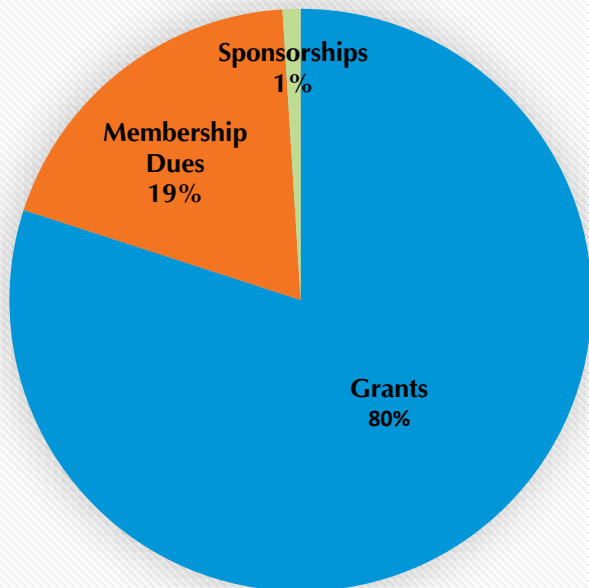

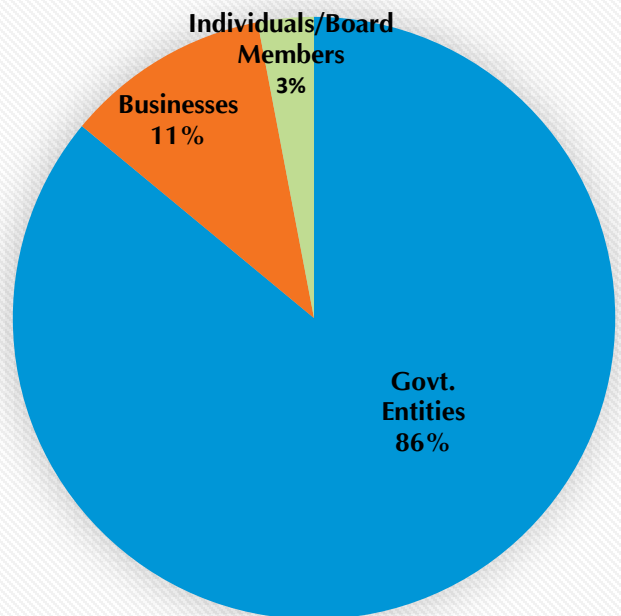
## FY 2024 Annual Revenue Budget: \$171,000
