Acceptable Use Policy

Last Updated: November 8, 2025

1. Purpose and Scope

This Acceptable Use Policy ("AUP") defines the acceptable use of oleksandrpotapenko.com (the "Website") and sets forth the conduct that is prohibited when accessing or using the Website.

This AUP applies to all users of the Website, including visitors, registered users, and any other parties accessing Website content or services.

By accessing or using the Website, you agree to comply with this AUP. Violation of this AUP may result in suspension or termination of access, and may expose you to civil and criminal liability.

2. General Principles

2.1 Lawful Use

You must use the Website only for lawful purposes and in compliance with:

- All applicable local, national, and international laws
- All applicable regulations and industry standards
- This AUP and all other Website policies
- Intellectual property rights of others

2.2 Good Faith

You must:

- Act in good faith when using the Website

2.3 Reasonable Use

You must not:

3. Prohibited Activities

3.1 Illegal Activities

You must not use the Website to:

Criminal Activities:

- Evade sanctions or export controls
- Engage in market manipulation or insider trading

Regulatory Violations:

3.2 Security Violations

You must not:

Unauthorized Access:

System Interference:

- Probe, scan, or test the vulnerability of systems or networks
- Breach or circumvent security or authentication measures

Data Breaches:

- Attempt to access, modify, or delete data belonging to others
- Intercept or monitor data transmissions without authorization
- Decrypt encrypted data without authorization
- Exfiltrate data from the Website

3.3 Content Violations

You must not post, upload, transmit, or share content that:

Harmful Content:

- Contains viruses, malware, or other harmful code
- Is designed to damage, interfere with, or misappropriate systems or data
- Facilitates hacking, cracking, or other security breaches

Illegal Content:

- Violates laws or regulations in any jurisdiction
- Infringes intellectual property rights
- Violates privacy or data protection rights
- Contains classified or confidential information

Offensive Content:

- Is defamatory, libelous, or slanderous
- Promotes hatred, violence, or discrimination
- Harasses, threatens, or intimidates others
- Contains sexually explicit or obscene material
- Exploits or harms minors in any way

Misleading Content:

• Contains false, misleading, or deceptive information

- Impersonates another person, entity, or official
- Contains fake news or disinformation
- Makes fraudulent claims or representations

3.4 Commercial Misuse

You must not:

Unauthorized Commercial Use:

- Use the Website for commercial purposes without authorization
- Resell, redistribute, or sublicense Website content or services
- Use the Website to compete with our business interests
- Extract data for commercial purposes without permission

Spam and Advertising:

- Send unsolicited bulk messages (spam)
- Engage in email harvesting or scraping contact information
- Post unauthorized advertisements or promotional content
- Engage in affiliate marketing without authorization
- Send chain letters, pyramid schemes, or similar schemes

Market Manipulation:

- Manipulate financial markets or securities
- Engage in pump-and-dump schemes
- Spread false information to influence prices
- Engage in insider trading activities

3.5 Technical Abuse

You must not:

Automated Systems:

- Use bots, scrapers, crawlers, or automated tools without authorization
- Overwhelm the Website with automated requests
- Bypass rate limiting or access controls
- Use the Website to train AI models without permission

System Exploitation:

- Exploit vulnerabilities or bugs for unauthorized purposes
- Reverse engineer, decompile, or disassemble Website software
- Modify, adapt, or create derivative works without authorization
- Remove or alter copyright notices or proprietary markings

Network Abuse:

- Forge headers or manipulate identifiers

3.6 Privacy Violations

You must not:

Data Collection:

Privacy Breaches:

- Share personal data of others without consent
- Violate confidentiality obligations
- Publish private information (doxxing)
- Access accounts or data belonging to others

Surveillance:

- Monitor communications without authorization
- Intercept private messages or transmissions
- Use tracking technologies inappropriately
- Conduct unauthorized surveillance activities

3.7 Al Assistant and Chatbot Usage Restrictions

When using Al-powered features on this Website, you must not:

4.2 Trademarks

You must not:

- Use trademarks without authorization
- Create confusion about brand affiliation or endorsement
- Register domain names incorporating others' trademarks (cybersquatting)

4.3 Trade Secrets

Given the financial technology focus of the Website, you specifically must not:

5.1 Regulatory Evasion

- Enable violation of export controls
- Circumvent regulatory requirements

5.2 Market Abuse

- Engage in market manipulation or abuse
- Front-run transactions or orders
- Engage in wash trading or spoofing
- Manipulate benchmarks or reference rates

5.3 Unlicensed Activities

- Provide financial services without proper licensing
- Operate as a payment service provider without authorization
- Engage in banking activities without banking license
- Offer investment services without regulatory approval

5.4 Financial Crime

- Facilitate fraud, theft, or embezzlement
- Process criminal proceeds
- Assist in tax evasion or tax fraud
- Engage in corruption or bribery

6. Reporting Violations

6.1 How to Report

- Your contact information (optional but helpful)

6.2 Investigation

We will:

- Review all reports promptly
- Investigate suspected violations
- Take appropriate action as necessary
- Maintain confidentiality to the extent possible

6.3 No Retaliation

We prohibit retaliation against individuals who report violations in good faith.

7. Consequences of Violations

7.1 Enforcement Actions

Violations of this AUP may result in:

Immediate Actions:

- Warning or notice of violation
- Temporary suspension of access
- Permanent termination of access.
- Removal of content

Additional Consequences:

- Notification to law enforcement
- Cooperation with legal proceedings
- Civil legal action for damages
- Criminal prosecution where applicable

7.2 Discretion
