

Cookie Policy

1. Introduction

This Cookie Policy explains how Oleksandr Potapenko ("we," "us," or "our") uses cookies and similar technologies on oleksandrpotapenko.com (the "Website"). This policy should be read in conjunction with our Privacy Policy.

By using our Website, you consent to the use of cookies in accordance with this Cookie Policy. You can manage your cookie preferences as described in Section 7 below.

2. What Are Cookies?

Cookies are small text files that are placed on your device (computer, smartphone, tablet) when you visit a website. Cookies are widely used to make websites work more efficiently and provide information to website owners.

2.1 Types of Cookies by Lifespan

Session Cookies: Temporary cookies that expire when you close your browser.

Persistent Cookies: Cookies that remain on your device for a set period or until you delete them.

2.2 Types of Cookies by Origin

First-Party Cookies: Set by the website you are visiting.

Third-Party Cookies: Set by external services or partners integrated into the website.

3. How We Use Cookies

We use cookies for the following purposes:

3.1 Strictly Necessary Cookies

Purpose: Essential for website functionality and security.

Examples:

- Authentication and session management

- Security features and fraud prevention
- Load balancing and performance
- Cookie consent preferences

Legal Basis: Legitimate interest (essential for service provision)

Retention: Session or up to 1 year

Consent Required: No (these cookies are exempt under most regulations)

3.2 Performance and Analytics Cookies

Purpose: Help us understand how visitors interact with our Website.

Examples:

- Google Analytics (anonymized IP)
- Page performance monitoring
- User behavior analysis
- Traffic source tracking

Information Collected:

- Pages visited and time spent
- Browser and device information
- Geographic location (country/city level)
- Referral sources

Legal Basis: Consent (where required) or legitimate interest

Retention: Up to 26 months

Consent Required: Yes (under GDPR/ePrivacy)

3.3 Functionality Cookies

Purpose: Remember your preferences and enhance user experience.

Examples:

- Language preferences
- Display settings
- Accessibility options
- Form data retention

Legal Basis: Consent or legitimate interest

Retention: Up to 12 months

Consent Required: Generally yes (unless strictly necessary for requested service)

3.4 Marketing and Advertising Cookies

Purpose: Deliver relevant content and measure campaign effectiveness.

Examples:

- LinkedIn Insight Tag
- Remarketing pixels
- Conversion tracking
- Social media integration

Information Collected:

- Advertisement interaction
- Conversion events
- Cross-site tracking for remarketing

Legal Basis: Explicit consent

Retention: Up to 2 years

Consent Required: Yes (strict consent requirement)

5. Similar Technologies

In addition to cookies, we may use similar technologies:

5.1 Web Beacons (Pixels)

Small, transparent image files embedded in web pages or emails to track user behavior and email opens.

5.2 Local Storage

Browser storage that allows websites to store data locally on your device, with larger capacity than cookies.

5.3 Server Logs

Automatically recorded information about your visit, including IP address, browser type, and pages accessed.

5.4 Device Fingerprinting

Collection of device and browser characteristics to create a unique identifier (we use this only for fraud prevention).

We use the following third-party services that may set cookies:

6.1 Google Analytics

Purpose: Website analytics and performance monitoring

Data Collected: Anonymized usage data

Data Collected: Professional profile data, engagement

6.3 Content Delivery Networks (CDN)

Purpose: Fast and reliable content delivery

Data Collected: Technical data for optimization

7. Managing Your Cookie Preferences

You have several options to control cookies:

7.1 Cookie Consent Banner

When you first visit our Website, you can accept or decline non-essential cookies through our consent banner. You can change your preferences at any time by clicking the "Cookie Settings" link in the website footer.

7.2 Browser Settings

Most web browsers allow you to:

- View and delete cookies
- Block third-party cookies
- Block all cookies
- Delete cookies when you close your browser

Browser-Specific Instructions:

- **Chrome:** Settings > Privacy and security > Cookies and other site data
- **Firefox:** Options > Privacy & Security > Cookies and Site Data
- **Safari:** Preferences > Privacy > Cookies and website data
- **Edge:** Settings > Cookies and site permissions > Cookies and site data

Note that blocking all cookies may affect website functionality.

7.4 Mobile Devices

iOS: Settings > Privacy > Tracking (Disable "Allow Apps to Request to Track")

Android: Settings > Google > Ads > Opt out of Ads Personalization

Performance Cookies: We cannot improve website performance based on usage data

Functionality Cookies: Your preferences may not be saved

Marketing Cookies: You may see less relevant content

Web Beacon: Invisible image used to track user behavior
