The Martinez Youth Football & Cheer Association (MYF) is a respected organization that prides itself on promoting a positive and supportive environment. It is expected that all representatives of MYF—including registered participants, parents, family members, Coaches, and Board Members—conduct themselves in a respectful and wholesome manner at all MYF-related gatherings.

Any member, player, parent, family representative, spectator, Head Coach, Assistant Coach, or Association Official may be barred from participating in the association if, in the opinion of MYF, their behavior demonstrates:

- A. Failure or unwillingness to cooperate with their team, MYF Coaches, Board Members, or Association Officials, or reluctance to fulfill assigned responsibilities.
- B. Repeated acts of poor sportsmanship.
- C. Acts of vandalism, violence, criminal behavior, or any actions that damage property or harm the reputation of MYF and/or its members.
- D. Use of profanity or foul language.
- E. Slander or defamation of MYF, its participants, or its members.
- F. Combative or inappropriate dialogue with referees or officials by anyone. The EBYFC and the Referees Association enforce a strict zero-tolerance policy across the entire league.
- G. Possession or use of drugs or alcohol within 100 yards of any practice field, game field, parking lot, or MYF gathering.
- H. Any fighting will result in immediate dismissal without requiring a majority Board vote.
- I. Social media posts must not feature unsportsmanlike content. The EBYFC enforces a strict zero-tolerance policy for such content across the league.

Decisions to dismiss or suspend an offensive party require a majority vote of the MYF Board of Directors.
