The Martinez Youth Football & Cheer Association (MYF/Martinez Bulldogs) is a respected organization committed to promoting a positive, safe, and supportive environment for all participants. All representatives of MYF—including registered participants, parents, family members, spectators, coaches, volunteers, and Board Members—are expected to conduct themselves in a respectful, responsible, and sportsmanlike manner at all MYF-related practices, games, events, meetings, and communications.

Any member, player, parent, family representative, spectator, Head Coach, Assistant Coach, volunteer, or Association Official may be subject to disciplinary action, including removal or suspension from MYF activities, if, in the judgment of MYF, their behavior includes but is not limited to the following:

- A. Failure or unwillingness to cooperate with MYF policies, team expectations, coaches, Board Members, or Association Officials, including refusal to comply with attendance, safety, medical clearance, or participation requirements.
- B. Repeated acts of poor sportsmanship or unsportsmanlike conduct.
- C. Acts of vandalism, violence, criminal behavior, or any actions that damage property or harm the reputation of MYF and/or its members.
- D. Use of profanity, abusive language, or obscene gestures.
- E. Slander, defamation, harassment, or intimidation directed toward MYF, its participants, volunteers, coaches, officials, or families, whether in person, in writing, electronically, or via social media.
- F. Combative, disrespectful, or inappropriate dialogue or behavior toward referees or officials by any individual. The EBYFC and the Referees Association enforce a strict zero-tolerance policy across the league.
- G. Possession, use, or being under the influence of drugs or alcohol within one hundred (100) yards of any practice field, game field, parking lot, or MYF-related gathering.
- H. Discussion, disclosure, or speculation regarding another participant's medical condition or personal information, except as required for safety and communicated through proper MYF channels.
- I. Posting or sharing social media content that reflects unsportsmanlike behavior, harassment, threats, or conduct detrimental to MYF. The EBYFC enforces a strict zero-tolerance policy for such content.

*Any fighting or physical altercation will result in **immediate dismissal** from MYF activities and facilities and does **not** require a prior majority vote of the MYF Board.*

*Decisions regarding suspension or dismissal beyond immediate safety removal require a **majority vote of the MYF Board of Directors**. MYF reserves the right to take immediate action when necessary to protect the safety and integrity of the program.*
