## No.14 American Vote Integrity Act

**“I could think of no worse example for nations abroad, who for the first time were trying to put free electoral procedures into effect, than that of the United States wrangling over the results of our presidential election, and even suggesting that the presidency itself could be stolen by thievery at the ballot box” Thomas Jefferson**

On November 7<sup>th</sup> 2020 Kathryn Murdoch, wife of James Murdoch who left his father Rupert Murdoch's News Corp. in July after “disagreements over certain editorial content”, tweeted “We did it!!” when Biden was declared the winner of the presidential election. The tweet followed one on Election Day that read ‘What will you tell your children or your future self about the part you played in history?’ and just one day after tweeting on the 6<sup>th</sup> “I agree with this” in response to CNN's Jake Trapper who said ‘The Murdochs and the people at Fox have an obligation to put their country above their profits. It is very important that people make it very clear — that there is no credible evidence of widespread fraud’; a peculiar and persistent obsession by Marxians since the election.

The identity of “We” was answered in a narcissistic article titled *‘The Secret History of the Shadow Campaign That Saved the 2020 Election’* written by Molly Ball for Time Magazine; a self-congratulatory tome arrogantly continuing a litany of ‘What are you going to do about it?’ machinations that began with the weaponizing of federal agencies during Obama's term. Ball describes and substantiates “...a well-funded cabal of powerful people, ranging across industries and ideologies, working together behind the scenes to influence perceptions, change rules and laws, steer media coverage and control the flow of information”; “an extraordinary shadow effort” Ball herself described as a conspiracy.

In a concise dissection of Ball's article, executive editor of the Federalist Joy Pullmann makes repeated reference to Ball's “conspiracy leader” but names only one conspiracy member; Ian Bassin, Executive Director of the front organization ‘Protect Democracy’ who crowed after the fact “Every attempt to interfere with the *proper outcome* of the election was defeated”.

Mike Podhorzer, “The Architect”, is given substantial credit by Ball for recognizing that despite the best efforts of media to push the Russian Collusion “stolen election” illegitimate President Trump narrative, by fall of 2019 it became apparent 2020 was not a foregone conclusion; Podhorzer began the process of coordinating an already highly organized and funded “resistance” under the auspices of “protecting democracy”. Like Black Lives Matter “protecting democracy” sounds good but upon closer examination the easily defended motte is far different than the bailey; democracy has a far different meaning to true believers within the false religion Marxianity.

“Democracy is the road to socialism”

Karl Marx

True to the neo-Marxist strategy of defining the meaning of words before the debate begins, democracy does not mean a democratically elected government reflecting the will of the people as to the preferred form of self-governance; for a Marxian “democracy” means egalitarian redistributionist equity policies and the necessary ballots to achieve them. Marxianity is a secular religion wherein good and evil, right and wrong are malleable concepts allowing for intellectual definitions of what constitutes “progress” i.e. democracy as a repudiation of American civics, culture and western civilization and the way “forward” using a term so loved by Marxists...but even Karl Marx was not a fool.

*“Democracy is a form of government that cannot long survive, for as soon as the people learn that they have a voice in the fiscal policies of the government, they will move to vote for themselves all the money in the treasury, and bankrupt the nation.”*

Protect democracy versus protecting the Republic is a distinction with a huge difference equal to the difference between “liberal/progressive” and Marxian; the founders were repulsed by democracy and so created a representative Republic. When one comes to accept the conspiracy to elect Biden was actually a sophisticated ‘by any means necessary’ collaboration between government, media, academy, corporations and wealthy oligarchs the terms Marxian and Fascist are revealed to be a distinction without a difference.

Marxians seek to use democracy to create a fascist one party state thus the closest analog to the 2020 election is 1932 Germany which had doddering and forgetful warhorse Hindenburg asked to stand for election in a country subject to plenary emergency declarations...like Covid-19. In a sharply divided election Hindenburg was elected to the presidency but within a year stepped aside and appointed Hitler as Chancellor ‘for the good of the nation’ after an event that most certainly rhymes with the unfolding events today; the Reichstag Fire.

*“The world...is indebted to Germany in a terrifying way, because she demonstrated to everyone what the ultimate conclusions of negative and destructive ideas really are. Ideas which in London or New York are repeated as seemingly harmless abstractions have been shown up by the Germans in all their blood-chilling finality. In this sense Nazi Germany has become the Gorgonian Mirror in which a decadent West could study its own features.”* Erik von Kuehnelt-Leddihn, Leftism Revisited

Had organizers of the various ‘Stop the Steal’ events known their history and taken time consider the matrices ‘axis of greatest evil’ evidencing Obama as evil on par with Adolf Hitler, they might have anticipated the assault on the capitol to be blamed on “deplorables” but not traced back to Marxian fascists; Reichstag Fire part deux.



How easy it was to call Antifa and BLM activists to the capitol letting them know in flyers to dress as Trump supporters to incite and break windows even as the Capitol Police were removing barriers and ushering "rioters" into the capitol and even exchanging pleasantries with the "Shaman".

And then there is Capitol Police Officer Brian Sicknick as Horst Wessel whom Goebbels crafted into a martyr to the cause; having Nazi elites and 30,000 faithful attend his funeral rather than lying in state in a rotunda. Any death is a loss but Sicknick assured his brother after the "insurrection" he had been pepper sprayed but was otherwise fine, but later collapsed and was taken to a hospital where he died the next day of natural causes...yet a martyr.

History does indeed rhyme and repeating that which has worked in the past allows evil to write another line of cynical poetry to sway the unknowing. Half of America has now been labeled white supremacist and at the time there were actual calls for the deprogramming of "insurrectionists" and invoking the Insurrection Act.

One can be sure that the FBI and DOJ selectively choose which capitol "insurrectionists" are identified and prosecuted from videos but nary a one that is identified as being a Marxian/BLM/Antifa activist. There are thousands of hours of video Pelosi refuses to release citing security concerns after an "insurrection" that more than suggests, it proves, whatever security was in place seemingly failed to anticipate the incursion; seemingly in that there was warnings weeks in advance. Releasing the video would not compromise security after an obvious failure but it would provide evidence that contradicts the Marxian narrative and provide exculpatory evidence that would free the hundreds of individuals rotting in the DC gulag without charges or indictments.

Americans and all of western civilization must come to accept the verse now being written is an act of grace in that the 72 year increment axis of greatest evil evidencing Obama as evil on par with Adolf Hitler now has parallels the average individual, the ploughman, can understand. It is a verse that was rewritten by an actual miracle to purchase time with the election of an unlikely Cyrus to expose Marxianity for the evil it is; a bull in the China closet meant to force Americans to use the oracle of reason i.e. common sense.

Reason screams the only plausible explanation for Hillary Clinton communicating with Obama and others on an off the grid server and then destroying all of the hardware when discovered goes the subject matter discussed; the Marxian end game conspiracy began with weaponizing the agencies of governance, creating a vast network to bring millions into the streets while nurturing corporate allies for the War of Maneuver; a violent revolution at the time of their choosing.

Had Hillary Clinton won in 2016, eventually a constitutional crisis would have been manufactured; the lumpen proletariat would have been called into the street in unrelenting chaos and Obama would have been called to lead for "the good of the nation"...and the failed Constitution would be replaced by a social justice blank check mirroring that of South Africa.

One need only use common sense and reason to piece together the puzzle of intent and planning in the context of weaponized agencies where the poison has taken effect. Set aside Special Counsel John Durham's investigation as to the origins of the Trump Russian collusion canard that has now taken longer than the specious Mueller investigation. Look instead to US Attorney David Weiss who decided not to seek search warrants or issue grand jury subpoenas against Hunter Biden in 2019 so as not to "alert the public to the existence of the case in the middle of a presidential election"

The problem with the explanation goes to timing; the Democratic presidential primaries did not begin until February and there were 29 candidates with Biden and Harris far down on the preferred list. The only plausible reason for the decision not to prosecute is Obama and company...which would go on to reverse the gains of Bernie Sanders overnight by calling upon Jim Clyburn to call out the Democrat's most loyal constituency, black women, to propel doddering Biden to the presidency...Biden who chose one of the most least liked candidates, Kamala Harris, as Vice President. Obama pulled the strings of the deep state to set the stage for his second coming.

With the miracle election of Trump, Marxians were denied the last and most important piece of the puzzle; the military which for eight years Obama purged...but with fraudulent election of doddering Biden and the Reichstag Fire part deux the military was brought to Washington DC to send a message to half of America being labeled racist insurrectionists. The message being that unlike Trump who was accused of being an authoritarian and cowed into refraining from invoking the Insurrection Act as cities burned, Marxians are authoritarians and will use the CIA, FBI, military and the Insurrection Act.

It is no coincidence the Secretary of Defense Lloyd Austin is black and the Chairman of the Joint Chiefs of Staff General Mark Milley replaced the works of Carl von Clausewitz and Sun Tzu with Ibram X. Kendi in anticipation of his most likely replacement; black Air Force Chief of Staff Gen. Charles Q. Brown Jr. i.e. control of the military.

The conspiracy Molly Ball revealed in her article is the logical and reasonable culmination of strategy launched by Hillary Clinton and authorized in Obama's Oval Office in 2015; the 'Russian Collusion' lie that failed to prevent Trump's election but did succeed in labeling his presidency illegitimate while hobbling his administration. As to the "conspiracy leader"



common sense points to Marc Elias of Perkins Coie, the mastermind behind the “Russian Collusion” scheme, as the unnamed leader of the shadow campaign at the behest of Obama’s shadow government to change election laws due to the Covid emergency to benefit Democrats.

The cabal Molly Ball refers to actually dates to 2016 and was activated when Jim Clyburn was called upon to instruct black voters in 2020 to vote for a badly lagging Biden...who then chose Kamala Harris, Obama’s choice, to be his running mate; a Hindenburg placeholder to be replaced by a vindictive product of George Soros ‘Oprah Winfrey’ strategy that has resulted in numerous unabashedly vindictive and biased black women in positions of authority. The months leading up to January 2025 will be the most dangerous in American history.

Deeply consider the words of Molly Ball:

“The handshake between business and labor was just one component of a vast, cross-partisan campaign to protect the election—an extraordinary shadow effort dedicated not to winning the vote but to ensuring it would be free and fair, credible and uncorrupted” which is a lie.

“Though much of this activity took place on the left, it was separate from the Biden campaign and crossed ideological lines, with crucial contributions by nonpartisan and conservative actors. The scenario the shadow campaigners were desperate to stop was not a Trump victory. It was an election so calamitous that no result could be discerned at all, a failure of the central act of democratic self-governance that has been a hallmark of America since its founding” which is another lie.

“They got states to change voting systems and laws and helped secure hundreds of millions in public and private funding. They fended off voter-suppression lawsuits, recruited armies of poll workers and got millions of people to vote by mail for the first time. They successfully pressured social media companies to take a harder line against disinformation and used data-driven strategies to fight viral smears. They executed national public-awareness campaigns that helped Americans understand how the vote count would unfold over days or weeks, preventing Trump’s conspiracy theories and false claims of victory from getting more traction. After Election Day, they monitored every pressure point to ensure that Trump could not overturn the result”. Which is the truth.

The list is a vast understatement as to the true extent of the actual conspiracy; the 2020 election was an ‘all hands on deck’ effort to recoup the expected neo-Marxist 2016 election victory using the alliances and infrastructure created by Obama and Clinton in anticipation of a one party state.

If one wants an accurate measure as to the extent the agencies of government were weaponized one need only consider how the Intelligence Community, FBI and DOJ leaked like a sieve during the Trump administration and yet the Hunter Biden investigation was kept secret for over a year until the New York Post published the story...only to be censored by tech oligarchs. "Post-election research found that just the conspiracy's successful information control on Hunter Biden's alleged corruption and its potential links to his father would have been enough to tip the election".

And then there is the CDC which amplified the Covid-19 hysteria and waited until the day before the election to announce it would be unnecessary to change the manner of voting...long after the hysteria resulted in mass vote by mail. As the November election approached an FDA at war with Trump managed to insure both Pfizer and Eli Lilly would not release news of the 90% effective vaccine and an anti-viral therapy until one day after the news media declared Biden the winner.

What most fail to realize is that like the before dawn arrest of Roger Stone with CNN inexplicably present to video and National Guard in Washington DC, Marxians are sending less than veiled warnings with the timing just as the support for the riots was meant to send a message to corporations that bowing to the anti-racism movement and openly Marxist Black Lives Matter was prudent i.e. nice business you have there...pity if something happened to it.

According to the Federalist's Joy Pullmann "Activists began preparing to reprise" the George Floyd riots as it looked like Trump was about to win, Ball writes. Their "Protect the Results" coalition "had a map listing 400 planned postelection demonstrations, to be activated via text message as soon as Nov. 4. To stop the coup they feared, the left was ready to flood the streets."

By any objective measure the 2020 election was not free and fair given the 90% negative coverage of the Trump presidency. The high tech censorship and the weaponized agencies like the DOJ tasked with election protection took no interest in insuring even the most fundamental integrity precautions as it concerned the over 70 million mail-in votes; Planned Chaos that would benefit neo-Marxists who, when after years of placing Democrats in government rank and file jobs, control of the means of transportation and production needed to deliver an election was in place.

*"Monsters exist, but they are too few in number to be truly dangerous. More dangerous are the common men (and women), the functionaries ready to believe and to act without asking questions."* A slightly expanded version of a quote by Primo Levi...the truth admits no apology.



Marxians are extremely adept at using projection, made easier when the weaknesses in a conspiracy can be anticipated in advance as well as the expected objections and challenges to a corrupted vote e.g. the word went out to let the public know that due to the number of mail-in ballots counting would extend for days after the election...and during the counting the Covid hysteria would require "social distancing" that would render the required observation of the count a farce. But who would be doing the counting made all the difference in an election that was far closer than most realize.

In February in an article titled 'Republicans came within 90,000 votes of controlling all of Washington' Aaron Blake with the Washington Post concluded the difference was "43,000 votes for president, 32,000 votes for the House, and 14,000 votes for the Senate" and "Shifts of 0.6 percent for president, 2.2 percent for the House, and 0.3 percent for the Senate"; a change that would have resulted in a virtual Republican sweep, further noting "Republicans came within 43,000 total votes of winning Arizona, Georgia, and Wisconsin".

Marxian election fraud conspiracy strategists needed only to target specific states and cities then insure their most reliable functionaries transported and counted the ballots...not legitimate votes. It is a distinction with a huge difference and fully explains how Trump managed to capture the majority of historically bell weather elections yet lost by the thinnest of margins i.e. Republicans traditionally vote on election day and as such it would be quite easy to calculate and produce the necessary number of ballots to be counted days and even weeks after the election to reverse Republican wins.

Those ballots were both harvested and created in mass by fictional voters with many going to empty lots and false addresses and because the rules and laws designed to control absentee and mail in ballots were gutted by election officials and the army of attorneys under the wings of Marc Elias the cabal only needed to insure a ready source of manufactured ballots and the control the means of transportation and production...those who would be inspecting and counting the ballots; loyal black men and women. I find it impossible to believe that shortly after the election '*Black Women have been bailing out the Dems for Years*' by Leonard Greene appeared in the New York Daily News by coincidence.

It takes time to both manufacture ballots and then initiate dumps that would that would have to be counted for days and weeks after the now tripwire that used to be called Election Day and so early voting was moved forward by upwards of six weeks in some places...but even before the Electronic Registration Information Center (ERIC), Ostensibly created to insure the integrity of voter registration rolls, make crosschecks of Social Security death records and DMV data to identify those who have moved it also "...identifies individuals who are not yet registered so election officials can provide information on how to register to vote".

The reoccurring lawsuits to clean up the voter rolls in a number of the 30 states that are members of ERIC is evidence enough there is possibly an ulterior motive for the non-profit; providing names and addresses to be used to manufacture ballots and then there are the "mules" utilizing drop boxes.

2000 Mules is a documentary directed Dinesh D'Souza which claims it proves widespread and highly coordinated fraud was carried out during the 2020 wherein "mules" tracked by cell phone geo-location data going to and from left leaning nonprofits and then to ballot drop boxes where they were video recorded dropping off large numbers of ballots. Given that Marxians are loyal ideologues and there is no serious threat of investigations it make simple common sense the mules were given addresses and names near their residence to harvest ballots they would then return to the nonprofits to be filled out for the mules...and pictures taken of the drops would result in payment. All that would be left then was transportation to the counting centers where the majority of workers are the aforementioned blacks...given a cloak of invisibility by the 'Oprah Winfrey Strategy'.

The Soros 'Oprah Winfrey Strategy' entails installing black women in positions of authority and regardless of any obvious bias criticism is labeled racist and misogynistic; a strategy used just recently by Chicago Mayor Lori Lightfoot that also applies to functionaries. Those black women in positions of authority are limited in their ability to affect elections but the vast over-representation of black women and men employed by the federal and state governments, especially in Democrat run cities, most certainly has that ability.

As to production, minority hiring preferences in the contested battleground states are such that Marxians insured those who would be determining which mail-in ballots would be added to the pile were the most reliable allies; black women who, like Lois Lerner, did not require an email or phone call to insure every Biden vote was counted and every Trump vote that could be opportunistically disposed for whatever reason was disposed of...not to mention rejection of mail-in ballots were on an order of magnitude lower than in previous years. Look to the videos of the counting and be brave enough to endure the slings and arrows of "racist".

As to transportation it was the USPS heavily staffed with blacks and no doubt Democrats, i.e. hiring using voter registration rolls insures who will be transporting ballots; the Postal Union backed Biden and those who deliver mail would know best from contact, bumper stickers and yard signs who supported Trump...which adequately explains why a pile of ballots were found alongside a road with yellow stains that appear to be urine. Did the FBI use DNA to determine if the USPS employee was the culprit? And then there are the reports of the USPS dating ballots to allow for counting. The DOJ need only make a concerted effort to identify those Republicans who applied for and submitted absentee ballots never counted to determine if there is a pattern implicating USPS delivery employees by routes...thousands of them.



The Marxian conspirators knew full well that with mass vote by mail one can control the outcome simply by controlling the poll-watchers and vote-counters; the first were denied access due to Covid and the second provided cover to act upon their bias and loyalty. It is a situation made worse by what anybody living in or in close proximity to the black subculture knows full well; lying is a virtual art form and there is a perception, nurtured by Marxians, gaming an "oppressive" system is justified. The 2020 election was the apocryphal Stalin quote in real terms; "The people who cast the votes decide nothing. The people who count the votes decide everything."

The quote was just one of many censorious Facebook algorithms flagged as misinformation even as Mark Zuckerberg's "foundation gave \$400 million in 2020 to local governments to run elections, including "training" election workers" with particular emphasis on the efforts of Stacey Abrams in Georgia after inviting "nine civil rights leaders to dinner at his home, where they warned him about the danger of the election-related falsehoods that were already spreading unchecked".

Did Zuckerberg buy into the Marxian claim that requiring identification is voter suppression in violation of civil rights? I think not; I think he knows Marxianity has been using civil as a cudgel since 1965 with highly educated white neo-Marxist elites treating blacks like children and acting as conservators; intentionally creating the foot soldiers they needed to transport and produce votes to complete the "praxis/process" phase...and the cannon fodder they will need for the violent revolution that is, and always has been, the end game for Marxianity.

If one is confused and wondering where what seems to be a meandering train of thought is heading one can be forgiven in that the difference between the view from ground level and that from the higher vantage rarely results in a common destination; is this about the election, about blacks or about the "we" of Kathryn Murdoch? Neither one...this is about recognizing Obama has been identified as evil on par with Hitler and the 2020 election rhymes with 1933.

History certainly does rhyme...and the verse goes on; the NYT retracted its story of capitol police officer Sicknick dying from a head wound; Pelosi and Schumer are refusing to confirm there was a request for National Guard troops two days before the "insurrection" on the 6<sup>th</sup>; in filings against "insurrectionists" the FBI confirmed Facebook, not Parler, was planning central...and for the first time the Department of Homeland Security used its National Terrorism Advisory System to warn in the week after the Biden inauguration there was "a heightened threat environment across the United States" and "Ideologically-motivated violent extremists with objections to the exercise of governmental authority and the presidential transition, as well as other perceived grievances fueled by false narratives, could continue to mobilize to incite or commit violence".

Marxian Democrats are moving quickly to introduce legislation that would expand upon the Patriot Act to designate those who refuse to accept the 2020 election domestic terrorists i.e. after four years of pushing the narrative Trump was illegitimately elected with Russian Collusion Marxians are making it clear there will be no tolerance, and there will be retribution, for "false narratives" of an illegitimate Biden...and as usual God does not agree.

Every black who participated in the election fraud would be well advised to come forward lest they are deemed a threat to the Constitution and guilty of betraying a blessing few recognize through the haze of the 1619 Project and the empowering "anti-racist" movement.

The differences between the two have disappeared; Marxianity is collectivism based on race and ethnicity...and white Judeo-Christian males have been disinvited from participating by the ruling class.

I have absolutely no interest in trying to convince anybody to deeply consider election analysis articles such as 'Five More Ways Joe Biden Magically Outperformed Election Norms' by J.B. Shurk, 'Pollster: It's Curious How Biden Underperformed Hillary Clinton In Every City...Except These Four' by Matt Vespa and 'Election Fraud Expert Russ Ramsland Files Affidavit Showing 'PHYSICAL IMPOSSIBILITY' of Election Results in Michigan' written by Joe Hoft.

What all must come to understand is the why, the end game of the fraud; a one party state that has all the indications it is well on the way to becoming the classic definition of fascism. You will know them by their works and nobody does a better job of explaining Marxian thinking and the stakes than Michael Anton who published a brilliant article titled "Why Do the Election's Defenders Require My Agreement?" for American Greatness. I welcome Anton to the battle but it is as Jeremiah said "Who will listen?"



The Constitution must be preserved; not democracy as defined by the fascist cabal that is in the habit of reminding average Americans constantly and threateningly...the courts fearful of interfering had their say as did state election officials who unconstitutionally changes the rules and as such the claims of election fraud and massive irregularities backed by hard evidence are irrelevant; those in power have decided Biden would be the president not the unwashed Americans in flyover country.

The only positive aspect of that truth goes to knowing what power is willing to do to take and keep power, up to and including 'It can happen here'.

The question all should be asking while there is still time is a lament that now requires an answer; 'How can it be, such a dynamic, creative and intelligent people that contributed so much to history allow Adolf Hitler and the Nazis come to power?' Aleksandr Solzhenitsyn had the answer: "Men have forgotten God; that's why all this has happened."

More than forgotten, God has been intentionally removed from the public square, popular culture and the schools by design and religion has been cast in a negative light...it's not hard to imagine a young Jacobin contemplating the Sistine Chapel ceiling and the *Pietà* and concluding they should be destroyed as were so many historic churches during the French Revolution.

A more accurate answer would be men have replaced God with ideology. A brilliant essay titled *How the Great Truth Dawned* by Gary Saul Morson for The New Criterion explores Solzhenitsyn's acute awareness of the dangerous nature of ideology. Morson quotes Solzhenitsyn "To do evil a human being must first of all believe that what he's doing is good, or else that it's a well-considered act inconformity with natural law. . . . it is in the nature of a human being to seek a *justification* for his actions." Morson continues...

*"Why is it, Solzhenitsyn asks, that Macbeth, Iago, and other Shakespearean evil doers stopped short at a dozen corpses, while Lenin and Stalin did in millions? The answer is that Macbeth and Iago "had no ideology." Ideology makes the killer and torturer an agent of good, "so that he won't hear reproaches and curses but will receive praise and honors." Ideology never achieved such power and scale before the twentieth century."*

It not only can, but is happening here when Marxian zealots and foot soldiers of Marxianity are willing and able to defraud the vote franchise. In backrooms of political nonprofits and academia there is a realization Marxianity has crossed the Rubicon and there is no going back; the revolution will either succeed or all is lost...and as such familiarity with 1933-34 Nazi Germany is prudent now that November 2022 midterms have passed lest the Nuremberg Laws part deux become reality.

That the Democrats defied history and won so many narrow midterm victories long after election day confirms 1) Marxians have perfected the theft of elections with manufactured ballots, and 2) Democratic-Republicans must wrest control of the Republican party from those unwilling to fight...and pass the American Vote Integrity act in every states who join in CommonSenseCession.

### ***American Vote Integrity Act (AVIA)***

The emissary refuses to entertain denials of vote fraud after conclusively making the case millions of illegal migrants in receptive sanctuary states and urban districts have resulted in a substantial number of seats in the House of Representatives at the expense of 22 states combined...hence the effort to omit the common sense citizenship question on the 2020 census. A question that if answered honestly would provide evidence the word "people" as it used in the Constitution to determine the number of representatives allotted each state was meant to be understood as citizens as the author of the 14<sup>th</sup> Amendment made clear. Common sense does not admit illegal migrants should have more representation in the House of Representatives than 22 states combined...an error that will be corrected when the IMRA becomes law.

There have been a number of articles of late speaking the necessary truth to the evil that is Marxianity and as it concerns voting there is one, *'Ending Election Fraud'* written for the *American Thinker* by Daniel John Sobieski that frames the problem succinctly. The American Vote Integrity Act is simple common sense and will forever deny Marxianity the ability to take from Americans the sword that is the vote; the only means to transfer power peacefully. If the vote is not secured now legislatively it will be secured by the sword and Americans would be fully justified in doing so. Thomas Jefferson was indeed the prophet of governance and every word he left to guide America seems meant for this moment.

*"The elective franchise, if guarded as the ark of our safety, will peaceably dissipate all combinations to subvert a Constitution, dictated by the wisdom, and resting on the will of the people."*

Unlike the obvious bid by Marxians to pass the "For the People Act" mandating Federal control of elections that would result in a one party state, the American Vote Integrity Act (AVIA) would focus on federal elections exclusively in that the effects of federal elections cross state lines; voters in Montana have a right to know that a federal vote in Massachusetts is being conducted according to the same rules...and results will be available from all states by the end of the last day of in person voting.



The AVIA would rely upon the same 'god of the gaps' as does the IMRA; Information Technology the Silicon Valley gladly provides to the Chinese Communist Party to rate the obedience of the people and censor the speech of Americans who oppose the Marxian agenda; technology capable of making the *National Voter Registration Crosscheck* program (NVRC) a reality.

The NVRC would inject federal steroids into the voluntary Electronic Registration Information Center (ERIC) and the Interstate Voter Registration Crosscheck (IRVC) program, which was restricted to using first and last names with date of birth and was attacked as voter suppression due to the high number of common names in the black and Hispanic communities i.e. racism where there is none as is the Marxian way.

The NVRC would access a massive data base with passage of the IMRA linking federal data bases to insure the structural changes to federal elections that will come with the AVIA are impervious to the accusations of racism that limited the effectiveness of the IVRC program. NVRC would provide a template for identifying and tracking the address of every person in the United States on a virtual real time basis along with voter registration but unlike ERIC will not identify unregistered voters to NGOs or nonprofits. Americans have a responsibility to take it upon themselves to register and vote.

Those who fear a national identification card must admit tracking is a train that left the station long ago with advanced technologies used by cellular providers and Google...which knows more about average Americans than their neighbors. Every American should ask why the social security card, originally printed on cardboard and upgraded to currency paper since 1983, has not been replaced by plastic card smart chip technology. The original explanation is that the cards were never meant to be carried is far outweighed by the reality the card is often used as identification and the paper cards are easily counterfeited; an intentional loophole that will be closed with IMRA and AVIA.

The AVIA is inextricably bound to the passage of the IMRA and the GNA in that tracking over 60 million CAMs will already require integration with the Social Security Administration and many other agencies; information that cannot be trusted to a politicized general government but can be trusted to the neutral and objective administrative agencies that would be the result of the GNA. All are interwoven like the weave of nature to protect national sovereignty, individual civil liberty and the Constitution.

Contrary to Marxians who label goods as human rights the vote is more privilege than a right and as such requires a degree of personal responsibility; with the AVIA common sense will be returned to federal elections. As noted, the American Vote Integrity Act would still allow the states to manage elections, but because national elections impact every US citizen voting for federal officeholders can be regulated by Congress.

The AVIA would mandate minimal standards for national elections; states can sever state elections from federal if they so choose...but federal elections will be the same as to process, procedures, ballots, security and reporting from state to state. Importantly, the AVIA would repeal the National Voter Registration Act of 1993; motor voter and registration when applying for public benefits would end.

### ***AVIA Structurally***

- 1) The DOJ would establish a Vote Integrity Division separate from the Civil Rights Division the Democrats have used for years to impede attempts to insure the integrity of the vote using race as a foil.
- 2) The DOJ Vote Integrity Division (VID) would have responsibility for vote and election integrity; enforcing provisions of the AVIA.
- 3) The first priority would be instituting the *National Voter Registration Crosscheck (NVRC)* linking every federal data base to the NVRC as to name, age, gender, race, citizenship status, SSN and address; the SSA, USPS and USCIS/IMRA data banks in particular. That the USPS and every other federal agency, despite the National Change of Address (NCOA) database, are incapable of maintaining current addresses defies logic, reason and simple common sense...as does the failure of logic attendant to the lack of a central federal clearing house for contact information linked to every federal data base.
- 4) The NVRC would be a standalone VID data base updating state voter registration rolls in real time. The VID would establish enforcement offices as necessary in each state and the secretary of state office in each state would be required to establish a liaison office specifically tasked with AVIA compliance.
- 5) The Social Security Administration would transition to smart chip cards immediately; notifying citizens over age 18 by mail who would then surrender their paper card in return mail to receive the new card.
- 6) Those who cannot wait the estimated two week turn around can visit the nearest SSA office.
- 7) Mail notifications would include a questionnaire as to optional information to be included e.g. medical, email, phone, next of kin.
- 8) Any person in the United States illegally would be subject to summary deportation without appeal should they apply for a smart chip card or submit and invalid SS card for replacement.
- 9) Requiring a valid social security number while registering to vote would allow the NVRC database to insure elimination of duplicate registrations in multiple jurisdictions.



- 10) The necessary data transfer need not require changes to the existing SSA data storage systems but merely the addition of a prompt to a separate program linking the database to the NVRC; the VID and SSA could manage the data exchange within the parameters of existing data storage and exchange protocols easily.
- 11) The VID would be able to access agency data bases as necessary and if the crosscheck discovers an error or contradiction the responsible federal agency would be notified.
- 12) Every federal agency, the USPS in particular, would be required to report address changes to the VID; multiple addresses would require identification of primary address for voting purposes.
- 13) Agencies would be able to access the NVRC to confirm addresses but would not be authorized to change data; discrepancy reporting would be an automatic function of inquiry i.e. enter address query and if different an automatic flag is generated.
- 14) If flagged the agency making the inquiry would be required to phone, email or mail the citizen to resolve the discrepancy and report findings to the VID/NVRC within 30 days.
- 15) Failure to respond invalidates federal voter registration.
- 16) States would be required to report every death to the SSA within one week of passing.
- 17) States would be required to report every felony conviction in real time and provide a list of every incarcerated felon.
- 18) The DOJ-VID would have its own law enforcement arm and courts of special jurisdiction.

### ***Restoring Federal Election Integrity Point by Point***

Marxians have, since 1965, engaged in a strategy of Planned Chaos per Ludwig von Mises and as it concerns voting have leveraged control of state legislatures to advance their agenda including vote harvesting that resulted in 22 Republican victories called on election night 2018 being reversed over the next days...in California which leads the nation in unrestricted vote harvesting.

Despite denials it is obvious Marxians want open borders to pack the House of Representatives and dilute what is left of the white Anglo-Saxon Protestant Judeo-Christian vote and are now going far beyond; allowing illegal migrants to vote in local elections and advocating for the "right to vote" for illegal migrants in general elections.

- 19) November 2018 marked 100 years after the end of WW1 and the 100<sup>th</sup> anniversary of the start of America's decline into the darkness of neo-Marxism in 1919 and I can think of no better way to honor those who have given the full measure of devotion than to establish November 11<sup>th</sup> as Election Day(s)...exclusively. It is not a new idea but it is an idea whose time has come.

- 20) Election "day" would be expanded to a 3 day window ending at 7pm on November 11<sup>th</sup>.
- 21) Polling stations would be open from 7am to 9pm the first two days and 7am to 7pm on the last day November 11<sup>th</sup>. (MIT political science professor Charles Stewart III estimated the 2012 election cost America \$544.4 million in lost productivity due to 23 million hours of waiting in line to vote). In addition, it has been estimated the long lines resulted in 500-700 thousand choosing not to vote at all. Two extra days of voting would be far more efficient than the highly inefficient and aggravating one day election which heretofore has provided an excuse for all manner of subterfuge negating the requirement for responsible participation in what is the most sacrosanct expression of democracy; the vote.
- 22) The AVIA is designed to eliminate every avenue now available for vote fraud with millions of illegal migrants in America; legislatively forbidding any election process founded upon the honor system; all votes and elections federal, state and local will require verification of voter eligibility and ballot integrity i.e. procedures to insure ballot chain of custody and a deadline no later than 9pm November 11<sup>th</sup> for ballot receipt at designated counting facilities.
- 23) Federal elections are held every two years; the AVIA would mandate all federal registrations be purged after each election requiring reregistration starting July 4<sup>th</sup> and ending September 30<sup>th</sup> election year with provision for in person registration the month of October.
- 24) The DOJ-VID would design and print registration in English only forms that would clearly state a migrant or immigrant regardless of status will be summarily deported without appeal if they vote in an American federal election.
- 25) The registration forms would include the standard information requests plus two new features; a social security number for purposes of NVRC crosscheck and a fingerprint, thumb or index finger, on a prepared surface with peel off cover.
- 26) The registration forms would not be distributed but rather requested over the internet, mail, phone or in person at libraries, post offices or registrars offices; the Secretary of State for each state would responsible for implementation.
- 27) Upon receipt the registration would be completed and mailed to the address provided by the Secretary of State reflecting the correct local district where a registrar would then input the data to the NVRC.
- 28) Once registered, a confirmation of registration would be mailed.
- 29) Every county, city and township would be required to provide voter services to the homeless including but not limited to providing a mailing address for purpose of voter registration only. It can be safely assumed a homeless individual seeking to exercise the vote would benefit from services just as the municipality would benefit from knowing what homeless services are needed.



- 30) NVRC participation would not be voluntary but rather mandatory for federal elections requiring the state or states to lift the voter from the rolls until any conflict is resolved. Technology allows for a data base that includes addresses, telephone numbers and email for prompt resolution.
- 31) The Secretary of State offices of individual states would be required to update voter registration rolls in a real time basis which would include requiring the DMV of each state to report license issuance to individuals moving into or out of state; surrendering their out of state licenses.
- 32) Absentee ballots are tools of necessity not convenience; restricted on an individual basis if the voter is elderly, is disabled or located more than 30 miles from a polling station which would include military, diplomatic and contract workers overseas.
- 33) Absentee ballots will no longer be provided for convenience; the vote is a privilege and one that must be protected in line with *take away the matter of them* i.e. minimizing the opportunity for fraud.
- 34) Absentee ballots would require submitting an application designed by the VID at which time the request would be subject to approval by the state registrar with an electronic copy to the state VID office; the VID would have standing instructions to reverse an approval if the applicant fails the "necessity" criteria.
- 35) Absentee ballot request forms would have a justification category selection check box and a small box for written explanations if needed...below which the line for signature would include an affidavit 'under penalty of perjury' warning.
- 36) Absentee ballots requests for military, government contractors, diplomatic staff and voters working overseas would be no different; category selection and signed affidavit required.
- 37) States registrars need only print an Absentee ballot request on the reverse of voter registration.
- 38) Absentee ballot requests would be accepted July 4th through a September 30<sup>th</sup> post mark.
- 39) Absentee ballots would be mailed to voters the first 10 days of October.
- 40) Executed absentee ballots must be received by the USPS and postmarked no later than the day before the last day of the three day election period and if a Sunday the day before.
- 41) Early voting would be confined to absentee voters within the time span allotted.
- 42) Early voting for all others would be prohibited.
- 43) Registration in person would end on October 31<sup>st</sup> and would require presenting oneself at the office of either the state/country registrars or VID office where identification and evidence of state residency would be required to register so as to allow time for crosscheck.
- 44) The Secretary of State would be required to maintain an official list of registered voters updated in real time available for review at Registrar of Voters offices.

- 45) The Secretary of State for each state and the NVRC would provide the voter the ability to confirm individual registration online or by phone using a social security number to access.
- 46) In person voting would require valid state or federal photo identification.
- 47) Ballot harvesting and drop boxes would be illegal for federal elections.
- 48) Illegal migrants voting in an American election would be subject to deportation without appeal.
- 49) Felons, who have not paid their entire debt to society, including parole, would be barred from voting in a federal election.
- 50) Felons convicted of violent crimes resulting in life threatening injury or sexual crimes against children would be barred from voting in federal elections permanently.

### ***Ballot Integrity; Chain of Custody***

With the number and identity of eligible voters accurately identified and allocated to specific polling stations in every county one unknown that has created havoc to vote integrity will be removed; the number and disposition of ballots that with the AVIA will have mandated answers. Marxians often point to Sweden as a model and in one instance there is concurrence; Sweden mandates separate ballots for national, regional and local elections.

- 51) The AVIA would mandate separate ballots for national and state elections.
- 52) National election ballots would conform to minimal standards established by the AVIA and require approval of the VID on a state by state basis.
- 53) National elections would require a paper trail i.e. ballots that can be recounted if necessary.
- 54) The DOJ-VID would also require a chain of custody and vote counting plan from each state subject to approval.
- 55) Ballot chain of custody documentation would be required records for each of the three election days.
- 56) Election officials of each county would be required to post the number of voters per polling station and the number of blank ballots provided to individual polling stations on the morning of the first day of voting. Provisional ballots would require a valid reason e.g. registration issue or error correction.
- 57) At the end of the day polling stations would be required to audit the number of ballots cast, the number replaced for any reason, the number of provisional ballots and ballots unused.
- 58) The process would be repeated all three days of the voting period.
- 59) Those requesting provisional ballots would be required to sign an affidavit attesting to eligibility under penalty of perjury.



- 60) The provisional ballot would be inserted into an envelope with affidavit attached and sequestered from all other ballots to be verified using the NVRC during the three day voting period.
- 61) The process of verifying provisional ballots would be performed at the end of each day of the election, tabulated and sequestered.
- 62) All executed ballots, replaced ballots and provisional ballots would, after audit, be transferred back to the county vote registrar/counting facility with the daily audit according to the approved plan.
- 63) After audit all unexecuted ballots would be placed under guard by state police assigned at random on Election Day who would count them in the presence of the polling station presiding officer with receipts issued.
- 64) Federal VID officers would at random oversee state police.
- 65) The next morning the state police would deliver the ballots to the polling station where the process would be duplicated transferring the ballots back to the presiding polling official.
- 66) At the end of the third day of the election period a final audit would be performed and all ballots outstanding would be transferred back to the county vote registrar/counting facility.
- 67) Vote counting would commence at 12 noon on the last day of voting with tabulations and results withheld until after 7pm.
- 68) Employees tasked with the vote count would be on lockdown during the 12noon to 7pm counting period, unable to leave and reenter unless approved by federal VID officers.
- 69) Releasing vote counts before 7pm would constitute a felony.
- 70) All vote counts must be completed by 11pm and results published before 12 midnight on the 11<sup>th</sup> of November.
- 71) If a county vote registrar/counting facility cite extenuating circumstances a notification with a signed declaration must be made before 9pm at which time VID investigators would be authorized to assess the validity of the declaration and make a determination.
- 72) If the notice and declaration are deemed valid an additional 12 hours would be granted but the grant would require hourly written updates be provided to the DOJ-VID.
- 73) If the notice and declaration are deemed invalid the DOJ-VID would be authorized to assume control over the county voting process.

### ***Voter ID Requirement***

The United States is the only major democracy that does not require identification to vote but rather than argue the point with those who look upon the honor system as a weakness to be exploited, the only common sense solution *is to take away the matter of them.*

- 74) The AVIA requires the SSA to issue free of charge smart chip Social Security cards to every American citizen to supplement the required state photo ID.
- 75) The SSA card accompanied by a valid state photo ID would be the only valid identification for voting purposes.
- 76) Every voting station would be provided a card reader to swipe the SS chip card so as to provide an electronic record to be transmitted to the VID at the end of each vote day for use if the vote is challenged.
- 77) Voters would be required to present a valid, not expired, state issued photo identification and the issuing state must certify migrants, regardless of status, issued identification are clearly identified as such on the issued identification with the letters "VI" in red bold print; *Vote Ineligible*.
- 78) If the voter cannot afford the cost of the state identification it will be provided free of charge by the state, and in a case of poetic justice the state would have to confirm the indigent voter is entitled to an ID free of charge for voting purposes which begins the question "Are you a citizen of the United States?" omitted from the census.
- 79) States issuing identification free of charge to indigent voters would be required to first utilize the NVRC and if issued, provide the DOJ-VID in that state with an electronic copy of the photo ID.

The vote can be secured, but Americans must surely recognize the task cannot be entrusted to a political establishment that has allowed tens of millions of illegal aliens to secure more seats in the House of Representatives than 22 states combined.

Those who might assert the salvos of solutions to this point provide too much information to a weaponized government are merely placing a lid on the cooker to keep Americans from jumping; using technology to insure at the very least every agency is aware of a citizens address in real time is the most basic of efficiencies...beyond the ability of the federal government by design.

The vote was intended from the beginning to be a sharp blade that would only draw blood from the beast; a sacred trust to be used lest human blood is spilled. At no time in American history is that more true than now; Marxianity cannot be allowed to repeat the fraudulent November 2020 and 2022 election victories.
