

Pamphlet No.29 Convergence Matrix Detailed

"He has made everything beautiful in its time; also the [wisdom of] the world He put into their hearts, save that man should not find the deed which God did, from beginning to end" Ecclesiastes 3:11

The verse tells of a deed, something that God did, mankind would not recognize from ground level, the wisdom of the world, until the appointed time when the deed would be revealed in the end. There is no candidate for the deed other than the Convergence Matrix and no other candidate for the faithful emissary God in His infinite wisdom has identified just recently in no uncertain terms; the Queen equations.

As to removing all doubt, the matrices are clear as to Yeshua in Jerusalem July 4th 2026 and for quite some time I thought the honorable and dignified Queen Elizabeth II was a marker and reminder of what faith and duty entail given her 1926 birth year, but then she died on September 8th of 2022. I thought sure of the marker thesis given Queen Elizabeth I is identified specifically at the 1570AD mark; excommunication, the start of the enlightenment and the creation of an island fortress of Protestantism where the colonies that would eventually form the United States were conceived.

As it turns out both Queen Elizabeth I and Queen Elizabeth II were indeed markers; the first was born September 7, 1533 and the second died on September 8, 2022...exactly 500 years to the day given the Julian calendar was replaced by the Gregorian calendar to allow for calculating leap years which included a onetime deletion of 11 days from the month of September 1752 that when converted to years per the repeating terms of convergence and added to 489 years Gregorian yields 500 years; 500 years is a critical marker in the matrices.

The second equation arose with the realization Queen Elizabeth II and I have something fleetingly in common; Queen Elizabeth II became queen the moment her father the king died on February 6th 1952. I was born in 1952 and as one versed in convergence I looked for a mathematical and historical fusion that would also include Judaic meaning which is the most difficult but obvious if one is willing to consult the oracle of reason and do the research. To wit: "Seventy has a sacred meaning in scripture that is made up of the factors of two perfect numbers, seven (representing perfection) and ten (representing completeness and God's law). As such, it symbolizes perfect spiritual order carried out with all power. It can also represent a period of judgment".

The question then went to the year 1952 and the two perfect seventies; the Queen's reign, my age and the relationship. Not so fleeting when one converts years to days, $70+70$ for 140 then adds the 140 days to February 6th 1952 which yields my June 25th 1952 birthday which only works because 1952 was a leap year. The central theme of the Convergence Matrix is "What are the chances?" and there is no arguing with the mathematics; the mathematics makes clear the deed was a message that only has context as time and events unfold in the end.

The third equation was prompted by the meaning of the first two; to wit: in 2019 I recognized the rare July 4th earthquake sequence in a remote area of California on an unexpected fault as a warning and then went on to accurately and publically predict three subsequent earthquakes and the Canadian Omega Dome i.e. is the halfway point of the seven year countdown to 2026 related to the queen equations? I multiplied 7 times 365 then divided by two for 1277.5 days then pushed off the leap year fraction for a clean July 4th 2019 plus 1277 =

January 1st 2023. If ones adds the leap year and half days to the second half for 1279 days then subtract from July 4th 2026 = January 2nd 2023; auspicious days for a message written in the ink of natural phenomenon.

The message came to pass in California with record atmospheric rivers that inundated the state but did not end the severe drought in that enough water to supply California for ten years flowed out to sea after those who are identified in the matrices as evil incarnate blocked the building of reservoirs despite being approved by voters ten years ago. It was a message layered atop a second i.e. a blessing the wisdom of the world negated; the false religion of human intellectual arrogance Marxianity prevented the building of the reservoirs.

Those same intellectuals should appreciate matrices on multiple axes only an incomprehensible intellect and power could create; matrices opened by a mathematical key left in history; matrices which step through history in 250 year increments on the most obvious axis identifying people and events with most to the exact year; matrices on multiple axes with one axis identifying three direct interventions to provide instruction in 1750 year increments; matrices which fold the Gregorian and Judaic calendars into a virtual double helix giving life to an understanding and relationship with God transcending the religious constructs of men; matrices providing an understanding of human history and the deeper meaning hidden in the Torah of Sinai; matrices awaiting dissection by Judaic scholars so as to provide guidance for mankind at the most critical time in history; the end of human history as it is currently understood and a new beginning.

Welcome to the matrix, the Convergence Matrix; there are no blue pills, there are no red pills, there is only the truth...but as Jeremiah said "Who will listen?" Listening now is the most important decision ever made in history; the penultimate decision that will decide endlessness or an eternity of possibilities on an individual basis. Empirical evidence of the God of Sinai is no small thing; a God unwilling to negotiate is warning every decision made henceforth will be weighed on scale inscribed with the words 'Embraced Reason' or 'Rejected Reason'.

Reason now requires thinking in the context of an ineffable intelligence, intellect, and power willing to empirically evidence His existence to the world but unwilling to negotiate; a Creator that specifically identifies Marxism and Islam as evil incarnate to be confronted rather than tolerated or embraced as many of the equally evil but ostensibly Christian churches have done...churches led astray by Athanasius with the trinity and the half-truth deception that is the Book of Revelation. Obviously, making friends is not a concern.

One begins the journey through the matrices by first asking the obvious; what is the most logical and reasoned way the ineffable intellect and power that chose the title God would message mankind to inform a final test of reason is being administered in real time?

Not pure mathematics in that without an inarguable association to the physical world the math is meaningless as exemplified by the movie 'Contact'. The mathematics therein simply said listen and then information was imbedded in a signal...a message saying 'build it and you will come'.

Not words that all would hear and understand as if God were a metaphysical genie disinterested in testing mankind's ability to reason. What would be the purpose of a message in words few would be ready for and even fewer would accept...and why the message at all if a metaphysical snap of the fingers would achieve the intended result at the cost of free will?

I spent a mere five seconds in 70AD Jerusalem where I learned a mental parlor game I played for years, the theory of convergence, was not a theory but fact i.e. look to history as a mathematical equation with the highly improbable reestablishment of Israel by the same people, worshipping the same God, from the same Torah, in the same land, speaking the same language as prophesized more than 2500 years ago the answer. What are the chances is not an idle question.

The Convergence Matrix is brilliant in conception and application; fusing the only two known human variables, history and mathematics, with Judaic scripture to write a message across that tablet of time that is incomplete until the appointed time which is now as evidenced by the Queen equations.

I am not prophet; I have no words from G+d to offer. At the same time as human detritus chosen to confound the wise and confront the powerful I am fully cognizant of the implications. The truth of the matter is captured in an apropos Steinbeck *East of Eden* quote: *"An unbelieved truth can hurt a man much more than a lie. Five seconds in Jerusalem

"Hope is a waking dream." Aristotle

After pacing for some time considering a question none have answered I sat down on the end of my bed in the twilight of a mid-December afternoon in 2014 Montana to take off my shoes...wracking my brain trying reconcile how it could possibly be that the covenant was "passed" to Christianity? Had the Jews failed as many believed and yet Israel was reestablished as was promised? Was the destruction of the 2nd Temple punishment?

The theology was superficial and failed the test of reason and then there was the abrupt change in the flow of history with Christianity and the improbable nature of the gospel expanding exponentially; thinking about *why* the covenant would be passed in that nothing in history suggests Judaism was a failed theology; thinking about the accepted reasoning versus my theory of convergence; thinking of the convergence of circumstances and forces which might better provide clarity and reasoned understanding.

I put my hands behind my head and began recline...when in an instant I was somewhere else and before me was a vignette, a snippet of what happened long ago while a presence I *sensed* next to me narrated in a manner

beyond understanding. The “dream” was like no other; *I was as conscious and aware of my surroundings; I was there and not dreaming.*

What made this dream so thoroughly unique was that the sights and sounds happened 2000 years ago, I was not alone and answer for the question “*why*” was provided in the seconds that followed.

I vividly remember standing to the left side of a stone doorway overlooking a stone walkway between stone buildings no more than 12’ wide watching two people scurrying to and fro in a hurried way. Most vivid were the efforts of a woman carrying a flat basket dodging a fortyish looking bearded man wearing robes trying to move the opposite direction with someone looking on from the doorway of what may have been a shop of some sort on the opposite side; all stone save for the wooden window frame and small cloth awning of the shop adjacent to the occupied doorway.

I have to believe HaShem thought it best I take the experience lying down; by the time my head hit the bed and I managed a simple “Wow” the world had changed. There were no trumpets, no angels with wings, and definitely no ladders or chariots of fire; there was absolutely no time to react, but enough time for the presence I sensed beside me to let me know in words that were not words at all I was in 70AD Jerusalem, my theory of convergence was not a theory and why Christianity has been wrong for 2000 years, very wrong for 1600 years and why Judaism has yet to get it right...Yeshua in the context of a plan has never been a serious consideration for theologians or historians.

The “dream” was strictly business wherein incomprehensible intellect used a method of communication Judaic scholars should recognize immediately; the narration, the words of the presence beside me were without explanation; words that were not words at all; words that were forgotten within seconds, which assumes I actually heard anything that actually took the form of words...but the message remained.

It was not a dream, it was very real and in the next instant I was up pen and paper in hand to write down the details of a shifting map I could see in my mind’s eye that I recognized immediately; the evil of the past was projected into the future in a way that could be reduced to an actual equation to provide a means to overcome the last hurdle to peace mankind will face before 2026; reasoned, not religious, revelation in that the terms of engagement between the God of Abraham and mankind is now entirely based on reason yet it is as it always has been...predicated on the fear of a Creator unwilling to negotiate.

The equation providing a solution to the last major hurdle between mankind and a world at peace was an indictment of a life wasted; who would listen to human detritus?

Jeremiah came to mind as did every other prophet tasked with the impossible along with a newfound respect for those prophets; prophets worthy of conversations with HaShem. The nature of the brief conversation left only one conclusion; there would be no words from God...reason would dictate and the terms would have a newly commissioned emissary entirely on his own to breath meaning into what had occurred.

The experience defied any familiar dream analogy in that there was absolutely no time to contemplate my surroundings, no time for emotional reaction, no time to formulate or ask questions and yet specific, comprehensive information was provided in a way that compounds the defiance of analogy in that a message was intended; not a dream and most definitely not a nightmare.

I do not have nightmares as most people would describe a nightmare; never a fan of anything that uses death and destruction at the hands of some supernatural force or nefarious evil mind as a vehicle to tell a story. Refusing to indulge was my way of denying support for commercialized evil in that a convincing argument can be made one imprints cheap thrills upon the brain like the genetic memory inherited when snake lays its eggs, leaves, and yet the young are hatched fully prepared for the world; cheap thrills are most often what nightmares are made of.

What did I experience and why? Not a nightmare or a dream but instead a very real piercing of the presumably impenetrable curtain of time for a specific reason given the information conveyed which, with the suddenness of my departure my brief stay and return, demanded an explanation. The “dream” production had to have significance far beyond the words that were not words as explosive as they were, and while I must admit a degree of personal vindication as to Convergence Theory I was completely lost.

There was only one plausible answer; the dream was a nexus of information and time with a stunning display of an ability to fuse the two into *purpose* which requires intent; incomprehensible intellect used a “dream that was not a dream” to convey specific information to a specific person, for a reason human detritus could not fathom until the Convergence Matrix. The soon to be emissary was given his first lesson as to how our Creator thinks and would have human beings think when problem solving in the presence of a very real and engaged G†d; the dream that was not a dream was the beginning and somehow I was to work my way to the end.

I had been given a starting point with an explosive answer and validation of a theoretical methodology but the last aspect of the reasoned deduction was absolutely disconcerting; the presence beside me in 70AD Jerusalem was by inference extending a singular authority and a commission to do what?

Human detritus learned firsthand how an omniscient and omnipotent Creator thinks; I was taken to the end to understand the beginning and left to use reason to answer all of the questions in between; Jefferson’s oracle of reason put to its ultimate test.

In the past mankind would explain such an event metaphysically or simply defer to “miracle” thus negating the need to explain the dream in any other terms, but doing so at this juncture is not an option given the knowledge mankind has accumulated with its attendant cynicism. The event occurred and there are plausible answers inferred even if the initial deductive reasoning is cursory. As such, it is incumbent upon me to describe in detail the event even at the risk ridicule; science and the academy have earned that right.

Every aspect of the 5 seconds should rightly be debated from the standpoint of the cynical and the religious confronting an emissary chosen to spur debate rather than end debate. There is nothing herein to suggest my perception and conclusions should be considered inviolate even though authoritative.

I am not a prophet and have no words from God to offer; I am but a lowly but faithful emissary delivering the messages written across the tablet of time subject to reason alone; messages written in the language of God mathematics having but one possible Author. The path will narrow as these writings proceed and as the path winds its way upward, the view from above, the higher vantage, widens and it is quite spectacular.

The “Passing” of the Covenant in Convergence

Until the 5 seconds and the subsequent key, Convergence Theory was nothing more than an intellectual parlor game of speculation. With the dream that was not a dream the first critical pieces of a complex puzzle fell into place. It is incumbent upon all of mankind to dispense with the idea of miracles as metaphysical parlor tricks and begin to recognize them for what they are; reasoned manifestations of a power and intellect beyond comprehension for specific reasons. C.S. Lewis captured the truth succinctly: *“Miracles are a retelling in small letters of the very same story which is written across the whole world in letters too large for some of us to see.”*

The question that needed to be answered so as to make sense of Convergence had everything to do with G+d's Sinai covenant and *why it was passed from the Jews to Christianity as a “new covenant” supplanting the old as many Christians believe?* Passing of the covenant did not make sense in that despite persecutions the Jews not only endured but thrived for almost 2000 years and HaShem kept his promise...Israel was reestablished.

I was allowed the answer in my very real Jerusalem “dream” and in the context of convergence the answer was, as so many are, common sense. At the same time it suggests the profound brilliance of He Who Is and reveals a plan at a critical stage; the 2nd Temple would soon fall to the pagan Romans in a clash of civilizations.

Theologians and historians alike have a very real cross to bear in that neither considers the fall of the 2nd Temple and Yeshua in terms of actual history in that theologians ignore history and historians ignore the existence of God and the possibility of a plan.

Convergence now made sense as a continuum; Jerusalem would fall in a clash of civilization and with subsequent research I learned provision had already been made for survival of Torah and the Jews. Judeo-Christian European western civilization would rise with its crowning achievement being the United States...and with the answer the convergence variables gained clarity which then required a return to scripture for further prophetic substantiation.

I submit the answer to the question never seriously asked; why would the Sinai covenant be “passed” to the gentiles?

The covenant was not “passed” but rather two covenants in perfect accord with Jeremiah 31:30-32 were issued for entirely different reasons for two entirely different peoples; the convergence of forces and circumstances in

first century Judea made the destruction of the Jewish institutions of the time inevitable, and G+d knew long before that the 2nd Temple would fall...G+d simply made long term plans for that eventuality.

Look to 1 Chronicles 17:8-14 where every Jew, and every Jew of the lesser House of Judah, need only find themselves in the words while noting the italics added.

"And it will come to pass when your days are finished to go with your forefathers, then I shall raise up your seed after you, who will be of your sons, and I shall establish his kingdom. *He will build Me a house*, and I shall establish his throne forever. *I shall be to him as a father, and he will be to Me as a son*, and I shall not remove My loving-kindness from him as I removed [it] from he who was before you. And I shall station him in My house and in My kingdom forever, and his throne shall be established forever."

HaShem made a huge investment and commitment to the Jewish people, and remained true to his original Covenant and promise to David in 1 Chronicles by burying them deep within the folds of Christianity to insure their survival and the survival of critical instruction, Torah, for the 2000 years to follow; a house built by and paid for by the sacrifice of "as a son" Yeshua who made clear he came only to save "the lost sheep of Israel".

Each juncture required cross reference to scripture which time and again suggested the Torah, and to a lesser extent the Tanakh in its entirety, was not only far more comprehensive than Christian scripture but *only made sense* if the notion of an "Old Testament" versus a "New Testament" is set aside. Yeshua was the second chapter of a story that began with Abraham; the faith and family born at Sinai expanded exponentially with Yeshua but as a continuum...not a separate faith which is entirely a religious construct of man.

Yeshua, Jewish carpenter, did build a house to shelter Judaism so as to survive the 2000 years of godlessness to follow, and just as it took Judaism 1750 years to fully develop the House of Israel into a great power so too the lesser House of Judah and the United States. Judaism had served the Master Planner's purpose to date by developing the written law with the completion of the Tanakh and the sophisticated system of civil law which included mechanisms for dealing with gentiles within the context of the Law. After Yeshua the Jews were ready to live within the folds of Christian western civilization.

It was time for *expansion* of the Abrahamic covenant within the context of our Creator's long term understanding of what was to be; Judeo-Christianity would become the most formidable idea known to man and it would carry foundational Judaism relatively intact through the coming centuries; the "New Covenant" allowed for gentile adoption into the Jewish family born at Sinai; the House of Judah as the lesser of two houses; the greater House of Israel are the direct descendants of Abraham, Isaac and Jacob *as Israel*.

Only in the context of the House of Israel and adoption into the greater Jewish family created at Sinai under the auspices of the Abrahamic covenant that Christians have meaning, validation and purpose. Even with the distance created by corruption of HaShem's instruction the Christian religion has followed where Judaism has led throughout history; without Exodus, Sinai and the Torah the followers of Yeshua have absolutely no foundation.

I remember reading Isabel Paterson's underappreciated *"The God of the Machine"* (1943) in which she posited that Greek democracy and Roman law recognizing the rights of individual citizens within the context of a republic were foundational to western civilization, which is true to a certain extent.

What she did not, or would not, acknowledge was the overarching Judaic Law that first supplemented Greek and Roman law and then supplanted European paganism in the form of Christianity; providing the legal and societal foundations allowing for the preeminence of western civilization over the next 2000 years.

"Certainly, the world without the Jews would have been a radically different place. Humanity might have eventually stumbled upon all the Jewish insights. But we cannot be sure. All the great conceptual discoveries of the human intellect seem obvious and inescapable once they had been revealed, but it requires a special genius to formulate them for the first time. The Jews had this gift. To them we owe the idea of equality before the law, both divine and human; of the sanctity of life and the dignity of human person; of the individual conscience and so a personal redemption; of collective conscience and so of social responsibility; of peace as an abstract ideal and love as the foundation of justice, and many other items which constitute the basic moral furniture of the human mind. Without Jews it might have been a much emptier place." Paul Johnson, *A History of the Jews*

Greece gave us democracy and Rome gave us the concept of the republic and the citizen, but it was Judeo-Christian ethic which melded both in an enduring way with its crowning achievement being the Constitution of the United States; individual freedom the primary purpose of republican governance and responsibility to ones fellow human beings the price of individual freedom. It actually took hundreds of years and numerous political philosophers lending to the concept of freedom and liberty to bring the Constitution to fruition; years marked by achievements such as the Magna Carta which was 800 years old on June 15, 2015 as this writing was slowly developing.

The trajectory of history demanded that an idea carrying the seed of future nations be given a vehicle to make the expansion of the covenant to gentiles a reality, and the vehicle was a Jew named Yeshua, a messiah of purpose, who taught for a very short time, left no writings or physical trace yet changed the world like no other before or after.

The Jews, the *seed of Abraham through Israel*, needed a place to survive, and did so within the confines of historic Christianity...and yet they remained an essentially separate and cohesive entity within said confines.

"The Jews proved not only unassimilated, but inassimilable, and... the demonstration that this was so proved one of the most significant turning points in Greek history, owing to the gigantic influence exerted throughout subsequent ages by their religion, which not only survived intact, but subsequently gave birth to Christianity as well."

I would leave it to Pascal, Einstein and Newton to *calculate the odds of such spectacular success* and the subsequent changes and effect on history in general; Yeshua is G⁺d's plan manifested in the second part. I refer to Yeshua as the second part of the plan because it took 1750 years for the chosen people to complete the

necessary journey resulting in Judaism as a formalized and distinct faith with a scriptural canon before the need for a new covenant was made necessary by convergence.

Yeshua had a divine commission to inculcate the pagan gentiles with the Judaic foundations of the future but all should know Judeo-Christianity was the product of 1750 years of patient instruction even before Yeshua.

If you are questioning the 1750 year increment I would suggest that your curiosity has been piqued and the number will not only be explained, but a second and then a third 1750 year increment in recorded history will confirm actual direct interventions by our Creator in the way of *singularities* that have marked time since sentience...every one bearing the stamp of Judaic, the chosen, influence; the chosen people were chosen for a reason.

The Jewish people can collectively claim the highest measurable intelligence of any identifiable group of people with an average a good deal higher than then next highest identifiable group; Koreans. The relatively high intelligence, an unmatched ability to conceptualize, their creativity and cohesive nature within the context of the instruction suggests the reason they were chosen was threefold in the context of Convergence; to bring the law to maturity in anticipation of expansion of the covenant to include the gentiles; play a critical role in the development of science, law and finance...and finally, to provide the political catalyst for the reestablishment of Israel. The Jews were chosen for good reason and John Adams concurred.

"I will insist the Hebrews have [contributed] more to civilize men than any other nation. If I was an atheist and believed in blind eternal fate, I should still believe that fate had ordained the Jews to be the most essential instrument for civilizing the nations ... They are the most glorious nation that ever inhabited this Earth. The Romans and their empire were but a bubble in comparison to the Jews. They have given religion to three-quarters of the globe and have influenced the affairs of mankind more and more happily than any other nation, ancient or modern." John Adams to F. A. Van der Kemp

There is scriptural reference to the reality and nature of phase two, the New Covenant and the "strength of the gentiles", but in the final analysis there was, and is, an actual plan centering on the chosen people and Israel. The soon to be revealed matrices evidence the birth of Christian western civilization and the eventual reestablishment of Israel as the very reason for a *second chosen people*; one country blessed above all others.

Such is the destiny of United States; the lesser House of Judah Christians are in fact a second chosen people forged to fulfill a destiny few recognize.

In an effort to dissuade some from throwing down this book at this moment I would suggest that there is a compelling argument to be made that Convergence Theory is valid based upon the same mathematics suggested when considering the probabilities of Yeshua's success; matrices Pascal himself would both embrace and find comforting, closely mirroring the Convergence Theory requirement for identifying the historical events within the context of a plan...with the difference being that G+d himself provides the identification. The Convergence

Matrix, actually matrices, not only identifies events but specific people whose influence shaped the confrontation at hand.

The question: “Is it possible to actually determine if there is a discernible evolving plan linking Judaism, Christianity, western civilization, the United States and the reestablishment of Israel as a continuum which would require the existence of a Creator and if so does the answer include the reason for a “New Covenant”?

The answer is yes; Judaism, Christianity, the United States and Israel are indeed a continuum within the context of an actual plan.

Before wading through the actual matrices it must be impressed upon those brave enough to test the water a suggestion as to how one does their wading so as to minimize the parsing that can be expected from intellectuals and academics preferring our Creator remain mere speculation. To wit: There are arguments between historians and others as to Homer’s Iliad and Odyssey; are they poetic fiction or are they based upon actual history? Troy was considered a myth until the city was excavated in the 19th century.

The debate would end if an amphora with actual papyri dating to the period were uncovered and writings written by the heroes named in the Iliad and the Odyssey such as diaries or manifests detailing the events and the places in precise detail were found. The Iliad and the Odyssey would quickly move from fiction to fact and the great majority of academics in the ranks of denial and doubt would be forced to concede the evidence changing the academic perception from one of poetic contemplation to intellectual exploration.

“If you would be a real seeker after truth, it is necessary that at least once in your life you doubt, as far as possible, all things.” René Descartes

Doubt demands conclusive evidence, and when there is evidence the possibility of nascent belief is the result; belief is the precursor to faith and conviction born of faith changes all things. Read the Convergence Matrix as if you were reading the diaries of Ulysses in his own handwriting on withered parchment if the concept of a supreme being still remains far too daunting; G+d knows the truth and your heart...and that is enough for now.

The Improbable as the Ultimate Key

Sir Isaac Newton dared to look into the future for an answer to the great Christian mystery; in Israel there is a file with Newton’s calculations as to the time of the second coming which he put at ‘no later than 2060’. I have never seen that calculation nor do I need to; I was always of the audacious but pessimistic mind that Newton made an addition error with the accepted 33 years of age of Christ when crucified which would put the end date

no later than 2027 which, given the world situation, seemed a more plausible year due to the convergence of forces and a possible rogue wave.

The presumptive hubris was not based upon the mathematics that Newton mastered, but instead upon my Theory of Convergence which leans heavily upon conflict dynamics and the possibility of an event of apocalyptic proportion happening before 2027; the current events growing ever more frightening each day appear to confirm the pessimism. Is there any way to be a bit more certain other than holding up a wet finger toward the winds of circumstance?

That was the question prompting my subsequent research; research centered upon the improbable success of Yeshua and his message; *what are the mathematical odds of Jesus' success?*

If correct about convergence and correct about the critical role of the United States, there should be some kind of improbable evidence left in history by a Creator wanting mankind to succeed; an odd proposition, but one I was convinced of after the "dream" that was not a dream. I felt confident I would find something that might at the very least offer a degree of understanding of what I perceived in history as it concerned my loose, but confirmed in Jerusalem, theory...which might also support Newton's calculation.

The possibility alone should pique the interest of those willing to keep an open mind, and after pondering again my conviction there is a purpose for the United States, I began to explore history for some clue...and what I found should do more than pique interest; what I found should prompt serious consideration of my presumptuous correction to Sir Isaac Newton calculation.

I did not discover, I merely recognized the key; a key hidden in plain sight. Either way it does not matter as with so many other considerations; there are far too many distinctions without a difference impeding debate and far too often two people looking at the same facts do not see the same things...but the improbable buttressed by mathematics precipitously narrows the debate.

"When you have eliminated the impossible, whatever remains, however improbable, must be the truth" Sir Arthur Conan Doyle, *The Sign of Four*

I have always maintained the United States is not an accident of history but rather part of a plan as the improbable flow of history makes fairly clear. The convergence of circumstances including two vast and sparsely occupied continents left undiscovered for 3000 years after Phoenicians developed the keel allowing for seagoing ships is far too perfect...so perfect one has a tendency to gloss over the reality that the birth of the United States was actually just over 3500 years in the making.

Those who colonized North America were making an exodus of faith wanting nothing more than the freedom to worship God in their own way as did the Jews following Moses; a promised land where life, liberty and the pursuit of happiness according to a shared Judeo-Christian ethic was theirs for the making. At first I was fascinated by the extraordinary natural resource wealth that cannot be found anywhere else on earth if one

were to take a template of America and overlay it anywhere else but where it is; an interesting fact but not revealing as to my quest. In frustration I leaned toward Occam's razor:

Among competing hypotheses predicting equally well, the one with the fewest assumptions should be selected. Other, more complicated solutions may ultimately prove to provide better predictions, but—in the absence of differences in predictive ability—the fewer assumptions that are made, the better.

In simple terms Occam's razor simply states that between competing theories the less complicated theory is most often the best explanation. In essence, don't complicate the issue by including an almost inexhaustible number of variables and possibilities...and so I began to concentrate on what makes the United States unique among nations; the Constitution and the Declaration of Independence.

If the documents which define individual rights as bequeathed by the "Laws of Nature and of Nature's G+d" provided some clue, or might indicate that the men who wrote them had a very real divine hand upon their shoulder, by default the documents would have the weight of writings no less important, especially given the stresses of today's reality, than the scriptural guides of Judaism and Christianity.

Such a discovery would drive a "progressive" insane, while providing a great deal of comfort to Americans who only know viscerally that their exceptional nature derives from a Constitution being *the only one in the world* defining rights as "unalienable" and bequeathed by a higher power; the comfort will be provided and the insanity within the ranks of "progressives" shall ensue.

The approach did not appear promising in that I felt confident there would be no "bible codes" ...at least not in plain sight. Harkening back to Newton's calculation I then approached the search another way; is there something as *mathematically* improbable as the success of Yeshua hidden in American history or the founding documents? The founding fathers with Jefferson in the forefront were not reticent about the providential nature of the United States but there was one who stated a truth few recognized.

"I do not believe that the Constitution was the offspring of inspiration, but I am as satisfied that it is as much the work of a Divine Providence as any of the miracles recorded in the Old and New Testament."

Benjamin Rush, signer of Declaration of Independence

In retrospect, knowing what is now known about the true nature of America's blessings and the eventual reestablishment of Israel, history makes *uncommon* sense; we are witnessing a convergence of events in accord with scriptural descriptions of "the end of days". And yes, *there is an incredibly unlikely mathematical clue*, and the convergence of the variables indicates an unambiguous purpose due to the specificity of the clue. Benjamin Rush was more right than he could possibly have known.

The Convergence Matrix; the 1st Axis

"I do not pretend to be able to prove that there is no God. I equally cannot prove that Satan is a fiction. The Christian God may exist; so may the God s of Olympus, or of ancient Egypt, or of Babylon. But no one of these

hypotheses is more probable than any other: they lie outside the region of even probable knowledge, and therefore there is no reason to consider any of them.” Bertrand Russell, *Why I Am Not a Christian and Other Essays*

It would seem HaShem has added crow to the menu of intellectuals past and present. With confirmation convergence was not a theory the 1st axis came within hours but it would require a key to open.

History as an equation produced only one other instance when probability was defied to the nearly infinitely impossible fact one man teaching in the ancient world for such a short time, leaving no written or physical trace, yet change the world like no other before or after; Thomas Jefferson and John Adams dying within hours of each other on the 50th anniversary of the signing of a document that would change the world like no other before or after; 50 is a profound number as it concerns Judaism.

At the time of their deaths many in a far more religious July 4th 1826 America recognized the hand of “Providence” better conveyed to a cynical world in terms of mathematics; the chances any two men present at the signing of the Declaration of Independence dying on the 50th anniversary of the signing has been calculated at 1.67 billion to one odds...not factoring the fact Jefferson and Adams were the 2nd and 3rd presidents and most responsible for the Declaration of Independence and passage of the Constitution which elevates the defiance of probabilities mathematics to trillions to one and most likely equaling that of Yeshua.

From the original calculation it is apparent I am not the first to ponder the probabilities nor am I the first to infer that the “coincidence” was the hand of a higher power, but apparently the first to discover why; the incredibly improbable event was fully intended by our Creator to be a mathematical key to unlock a series of interlocking matrices spanning 6000 years based upon Pascal’s probabilities mathematics...and his wager it seems.

It seems asking the question “What are the chances?” is a key to discernment in and of itself; only an incomprehensible power and intellect could and would defy probabilities mathematics to write a message across the tablet of time.

Upon realizing the significance it would seem a degree of vindication as to the mental parlor game of convergence would be in order, but to the contrary; for the first time the heavy weight of responsibility settled upon an unwitting emissary; a heavy weight that has not lifted in seven years. Instead, there was the question of translating the deaths of Jefferson and Adams into meaning. Obviously the words of both would hold a prominent place in future contemplation but what of the mathematics?

Thomas Jefferson and John Adams were instrumental in the drafting and ratification of the Declaration of Independence and the Constitution. It was Adams, who nominated George Washington as the first president and could claim the concept of separation of powers so vital to our Constitution; it was he who pushed for adoption of the Declaration of Independence for 40 days; it was he who gave life to “A nation of laws not men”.

Unarguably, Thomas Jefferson's writings on governance are a corpus almost scriptural in breadth; literally shaping the world and his writings read like prophesy. Alexis de Tocqueville did not hesitate to make the same assessment as to the Declaration of Independence made by Benjamin Rush.

"It is impossible to read this opening paragraph without an involuntary feeling of religious awe; it breathed the very savor of Gospel antiquity. The sincerity of the author heightens his power of language."

The last words of John Adams on his deathbed uttered a few hours after Jefferson's passing at Monticello were "Jefferson survives" not 'Jefferson lives', and I am inclined to believe Adams was actually looking at Jefferson in spirit and Adams would soon join him in eternity; one can live on in words or in notes comprising a symphony but to say "survives" is to say Jefferson, the prophet of governance, survived death intact. Jefferson was not a "deist" but an actual prophet...of governance; many of his quotes are far too prescient as it concerns the issues of today to be dismissed as mere coincidence.

"Did we ever expect to see the day, when, breathing nothing but sentiments of love to our country and its freedom and happiness, our correspondence must be as secret as if we were hatching its destruction!"

Thomas Jefferson to Elbridge Gerry, 1799

Using logic and reason to determine the July 4th 1826 date was a key added little to knowing how to use the key. It goes without saying 1776 was intended as a benchmark and 50 is a critical number for Jews to whom there are no numbers and letters, only symbols that serve in equal measure, but how to begin? I had four numbers to work with; 2 men, 5 decades of 10 years each totaling 50. In combination I settled upon 2 and 50 and finally 250 knowing smaller patterns would be impossible to discern during the initial explorations.

The first inclination was to simply add 250 years to 1776 for 2026 which gave me pause when it coincided with my musings as to the Newton calculation; 2026 seemed to confirm my correction to Newton's calculation but more importantly, the date aligns with the convergence of forces suggesting mankind's survival to 2026 without a catastrophic event unlikely.

The coincidence struck me as interesting but then it occurred to me 5 decades, 50, multiplied by 5 gave me the same total as the original 250 in combination. First impression suggested the factor 2 was unimportant but the factors 5, 10 and 250 were important, but intuition suggested otherwise. The intuition proved to be correct; two men, Jefferson and Adams, proved to be the key providing a degree of *interpretive context* to the matrices but the remaining factors, along with combinations of all three, revealed constantly expanding and stunningly accurate matrices.

What at first seemed nothing more than coincidence now prompted the question as to the significance of 250 year increments in the context of Convergence; are historically significant milestones identified in 250 year increments? If so, any more than three such increments would surely defy "coincidence" testing probabilities mathematics to the breaking point.

I first started my search by calculating in 250 year increments forward in time from the long held, but incorrect, year of Christ's birth at 1 CE and then followed by calculating out from the accepted date of Christ's passion and resurrection of 33 CE. Both were inconclusive, and I couldn't help but think that if our Creator were leaving a message the more important and pertinent dates would be exact or nearly exact...which is when it occurred to me I was missing the very benchmark established to begin with; the "dream that was not a dream" was intended to convey critical information; the passing of the covenant and the fall of the 2nd Temple in 70 CE provided both context and the benchmark for the ever expanding matrices calculations.

The answer was 70AD Jerusalem where my journey began, and with the realization the meaning and nature of the 5 seconds gained clarity; strictly business of the highest order. I lamented not being treated to the sight of the 2nd Temple or seeing a Roman centurion and, as noted, there were no angels and trumpets, but the denial has meaning in and of itself; God minimized any possible religious connotations, answered the needed questions and provided a starting point for the confirmed theory of convergence.

I had received a commission to expand upon the theory which would require identifying dates, events and individuals in an intelligible way, connecting the dots, using reason alone.

When I calculated in 250 year increments from the fall of the 2nd Temple in 70AD I was stunned to find major events lending credence to Convergence closely tracking with three identifying individuals with profound implications as it relates to the forces in conflict when considering the stresses of today's world, matching exactly or in combination within 2 years. The first axis:

- 1) 70CE fall of 2nd Temple and the *third* great Jewish diaspora begins.
- 2) 320CE the halfway point of Emperor Constantine's reign and the Arian confrontation; the Edict of Milan in 313CE ended persecution of Christians and ten years later Deacon Athanasius, convened the 1st Council of Nicaea in 325AD; 300 years after Yeshua the Nicene Creed professed Jesus God in the flesh and Christianity was severed from Judaism with the Trinity. For 300 years Christianity was considered a sect of Judaism but no more.
- 3) 570CE The Birth of *Muhammad* exactly 500 years after the fall of the temple.
- 4) 820CE Charlemagne is crowned first Holy Roman Emperor in 800CE and the birth of autonomous western civilization begins with the Carolingian Empire after his death in 814CE which resulted in the division of Europe between his sons; a map which essentially endures to this day.
- 5) 1070CE Battle of Hastings occurred in 1066 after the Norman invasion of Anglo-Saxon Britain and by 1070 the mother country of the United States is secured with the first English royal dynasty; the Normans.
- 6) 1320CE The *Renaissance* begins with the publication of Dante Alighieri's *Divine Comedy*, which is often referred to simply as *Dante's Inferno*, and the highest point of Giotto's career...the recognized first of the legendary Renaissance painters. Occam's razor is operative.
- 7) 1570CE Pope Pius V excommunicates Queen Elizabeth I of England with the Regnans in Excelsis papal bull, the Anglican Church is founded and the *Enlightenment* begins.
- 8) 1820CE Friedrich Engels is born in 1820 just two years after Karl Marx in 1818; without the financial support of Engels the works of Marx would have been stillborn.

I have no doubt that any objective historian will recognize the significance of the first axis of the matrices and I welcome the slings and arrows to be expected by my assertion the sequence of events are not mere chance; the specificity of the events and the identity of individuals point to a controlled evolution of history impossible to be explained away by mere “coincidence”.

The message written across the tablet of time from 70AD to 1820AD is merely the first paragraph yet clearly defines the final confrontation; western civilization led the United States and Israel are being assaulted from within and without, caught in a vise between the false religion Marxianity posing as political ideology in an alliance of convenience with a political ideology, Islam, posing as a religion...while Trinitarian Christians stand as the foremost impediment to mounting an effective strategy to defeat both false religions.

The angst of academics and intellectuals will intensify exponentially with the second level of the matrices; the specific identification of singularities, direct intervention by our Creator, to advance a plan with overarching implications

One might ask why 1776 was not included in the first paragraph but the exclusion has an answer; another axis of the matrices includes the birth of the United States in the greatest truth ever told.

The dates, events and individuals are so precise the chances of “coincidence” are virtually nil in that individually and collectively the axis defies Pascal’s probabilities mathematics as only God can do; the matrices are an act of grace providing certitude where once there was none.

There will be those who point to Justice Oliver Wendell Holmes Jr. observation “certitude is not the test of certainty” to which I would reply the mathematical certitude of Pascal is a spiritual value two steps above mere belief and one above abiding faith requiring one to rise and confront evil...validated by the certainty that comes with mathematics incapable of deceit. What is certain and beyond debate is the specific identification of four individuals associated with evil incarnate, Athanasius, Muhammad, Marx and Engels cannot be defined as “coincidence” and in sum the matrices empirically evidence the hand of God in history. One need only ask what Athanasius, Muhammad, Marx and Engels have in common?

The answer is supplanting the Sinai Torah; supersessionism.

The first axis required about six hours but the research to piece together matrices spanning 6000 years took years during which a piece of human detritus was subjected the unbearable weight of self-doubt, deep introspection and obligation; almost unbearable weight painful enough to eventually compel the acceptance of the role faithful emissary after five years. The experience of Theodor Herzl, the father of the state of Israel, when the idea of an independent Israel came to him provides the best analog for the 5 seconds and the years of agonizing research and writing that followed:

“He relates that the idea seized him as if from outside himself, obsessed him, and he wrote his work day and night in a stream of thoughts flooding his mind so fast he could hardly put them down. So furiously did the cataract of his thoughts rush through him, that he thought he was going out of his mind. He was not working out

the idea. The idea was working him out. It would have been a hallucination had it not been so informed by reason from first to last."

"Informed by reason from first to last" is confirmation Theodor Herzl was also chosen to play a far more critical part in the "end of days" but in the same manner as a reluctant emissary who need only evidence HaShem empirically and provide a path out of the growing flames but doing so will require a backfire that will necessarily burn dogmas, sacraments and even a number of churches to the ground but not with actual flames as Jacobins would have it but rather the burning embers of reason alone.

The second level is best approached with simple questions: Where are Yeshua and the United States identified if the thesis is correct? What information revealed in the matrices prompts the emphasis on Judaism other than the 70AD benchmark? It is at this point where the implications of direct and purposeful interventions by a Creator exceeding any past or present understanding come to the fore and as such I submit the second level of the matrices by answering the questions posed.

The Most Important Axis

The question of why 1776 was out of sequence was puzzling, and my conviction that Marxism is evil manifested demanded that some kind of plausible and substantive association be found. I simply started by pondering the reason 1776 was 44 years out of sync with the 250 increment timeline.

I then mused that, for whatever reason, the appearance of the United States was fortuitous in that the evil manifested as Marxist/Leninist communism in the Soviet Union was eventually defeated by the good that preceded by 44 years; the United States; evil authored by Marx and Engels.

My brow literally furrowed when I realized Yeshua's crucifixion preceded the evil that was the fall of the second temple by *approximately* 44 years. I use the term "approximately" in that confirmation of the most significant aspect of the matrices fell into place within a few hours. I had discovered the key to identifying direct interventions, singularities, as our Creator had intended them to be found *and* a marker used to identify evil incarnate or the mitigation of evil incarnate; the number 44.

"You must accept the truth from whatever source it comes"

When one considers that 44 years prior to the benchmark, the fall of the 2nd Temple in 70AD, is 26AD and exactly 1750 years before 1776, the birth of the United States, taking notice is prudent.

It was at that same moment when I realized that the same 1750 year span is the measure between the fall of the 2nd Temple in 70 CE and Marx/Engels in 1820; a second 1750 year increment parallel to the original 250 year increment timeline beginning with the evil that was Rome trying to destroy Judaism and ending with the evil that was Marx and an ideology seeking the destruction of Israel by forming an unholy alliance with Islam; a political ideology which rejects religion but has all of the traits of a religion in alliance with a religion that has the traits of a political ideology.

The only part missing from the matrices puzzle was a reasonable and logical confirmation of Yeshua's crucifixion in 26CE; the date did not comport with the common understanding of Yeshua at age 33 and the gospels which do not agree as to the length of his ministry. Instinctively I knew then there would be a reconciling confirmation waiting for discovery. The matrices at that moment seemed almost miraculous and I would not be disappointed.

Before making even one more calculation, I recognized an aspect of Judaic understanding as to the appearance of Judaic mashiach which fit perfectly; 2000 years of 'godlessness' before the Jewish mashiach which, if measured from 26CE would be 2026; reconciliation of the Judaic eschatological tradition indicating Yeshua, a messiah of purpose, is the benchmark for Judaism not the fall of the temple.

The Yeshua that would be revealed by the matrices was a Jew then and is now...in complete harmony with Torah and the eschatological expectations of both House of Israel Judaism and the lesser House of Judah Christianity.

The number 1750 is in agreement with the 250 year increment on a broader scale and 1776 would be exact as it relates to Yeshua's crucifixion in 26AD at age 32 if one measures from a birth in 6BCE as historians believe. Academics are almost unanimous as to the birth of Yeshua in 6BCE; a date that for years has been used to emphasize the inexact nature of religious institutional constructs such as the Gregorian calendar which "calculated" the birth of Yeshua in 1 CE.

The academics will be happy to know that their estimations were correct but not in a way that will please most.

The Gregorian calendar is an extremely appropriate daily reminder of religious institutional fallibility but academia's correct date of 6AD provides a clustered matrix of dates which will force a reassessment of Christian scripture. There are four gospels and it is safe to assume whoever cuts through the Gordian knot of contradiction is wielding the Sword in the Stone, Excalibur, thus revealing king; the matrices are Excalibur and G+d has put the sword in motion ergo the gospels must align with the matrices and not the other way around so as to please religion.

The 26AD date was certainly worthy of note given the parallel 1750 increment between 70AD and Marx/Engels but initially I had nothing but a very compelling piece of anecdotal evidence.

Pontius Pilate was in his first year as Prefect of Judea in 26CE and common sense suggests the answer as to why a politically astute first year Roman Prefect was reluctant to take responsibility for Yeshua's crucifixion; Pilate was new to Judea and executing a "king" above his office; Pilate's prudent political inclinations prevailed; Pilate washed his hands leaving the Sanhedrin to take responsibility for taking the life of a messiah of purpose who *amended* Sinai thus engendering the temple hierarchy's hatred.

Approach all things as it concerns Judaism and Yeshua in the context of history rather than religious dogma and the truth will become apparent from the higher vantage provided by the matrices; history guided by our Creator's hand. Thomas Jefferson the "deist" understood the true nature of Yeshua's commission and warned of mankind's fallibility in explicit terms as it concerns accurately conveying the truth into the future.

"But a short time elapsed after the death of the great reformer of the Jewish religion, before his principles were departed from by those who professed to be his special servants, and perverted into an engine for enslaving mankind, and aggrandizing their oppressors in Church and State."
Thomas Jefferson to Samuel Kercheval, 1810

Yeshua prepared Judaism for the diaspora by amending the Sinai covenant presaging the Constitution in many ways with his teachings; Yeshua amended Sinai to relieve the Jews of the strict civil, dietary and temple laws to prepare them for life under the roof built by Yeshua; western civilization.

The span of 1750 years seemed to be confirmed with the parallel timelines and there was no way to dismiss the possibility that was implied; the birth of Christianity and the birth of the United States were actual interventions intended for all mankind. But could the inference be reasonably and logically confirmed by replicating the two 1750 year increments as something more than the coincidence intellectuals are hoping for? Was there a link to Judaism that went back in time as well as forward to the 2nd Temple?

I started again calculating from known dates looking for some correlation extending back into ancient history. Doing so would be entering into a vast gray area of conjecture still argued by archeologists and historians, but the matrices were stunning throughout recorded history and I had to believe their accuracy would hold; confirmation of our Creator's authorship...and again I would not be disappointed.

Using 26CE and 6BCE as the markers there was nothing I would expect given the exact nature of the dates revealed thus far. But as with my first excursion, I realized I was not using the correct benchmark which had everything to do with Judaism. I found what I was looking for when I reached back in time to what is actually the most important event in human history; G+d's original covenant with Abraham.

Abraham received the Covenant between the Parts in 1743BC seven years after the death of Hammurabi thus explaining the precise dating; the first attempt at law giving, the Code of Hammurabi, fell on barren ground. The date is well recorded and Abraham was literally just a short distance away at the time in the vibrant city Ur.

1750 years later in 7AD Yeshua at age 13, 'ish' a man, faced examination by the Temple elders after which he assumed his commission telling his parents he was about his father's business; Yeshua began his ministry when he acknowledged his purpose. Yeshua was not 12 as the gospel of Luke reads but age 13; an age infinitely more plausible for his first temple visit; Yeshua came of age according to Judaic tradition which fully explains his temple visit. Do not assume the author of Luke was in error but rather question scripture in the context of the matrices, asking who would benefit from the change?

The early church had, within 72 years of crucifixion, embarked upon a strategy to divest Yeshua of his Jewish identity and the change to age 12 would have served as a subtle insult to the temple authorities i.e. Jesus at age 12 was wiser than the elders. That temple aside, focus on the repetitious seven x 250 year increments and for those with quick mathematical minds the 19 year gap between 7AD and crucifixion in 26 AD has an answer.

Consider the number 7 represents G^d, creation, natural perfection: *7 days of creation; 7 days to the week; seven oceans; seven continents, and exactly 7x250 for 1750 years between Abraham and Yeshua at age 13 impressing the elders in the 2nd Temple and exactly 7x250 for 1750 years from Yeshua's crucifixion in 26CE to 1776. HaShem was creating matrices intended to define all of history for a cynical world including identifying evil in convergence; 1750 years between the fall of the temple and Marx/Engels.*

I was able to derive the 250 increment from the signing of the Declaration of Independence and the deaths Jefferson and Adams 50 years later, from which the matrices evolved. Thereafter, every single consideration included some factor of 5, which naturally led me to consider the 5 centuries between 70CE and the birth of Muhammad as a confirmation. I also took note of the 250x5 increment of 1250 years between 570AD and Marx/Engels to arrive at 1820 which marks closely the birth of Karl Marx in 1818 and exactly as it relates to Marx's enabler Friedrich Engels.

I then began to wonder just how significant the number 5 is to Judaism in the context of the matrices and a confirming piece dropped into place; a set of numerical correlations speaks volumes. There are five books in the Torah, five sections to the beloved Psalms...and finally, the 5th of Iyyar, 5708; Yom Ha'atmaut; Israel's Independence Day celebrating the reestablishment of Israel in 1948. The circle connecting the American Declaration of Independence on the July 4th 1776 and Israel's reestablishment is made complete.

While the correlation may strike many as tenuous and tendentious, confirmation exists elsewhere in history as mathematical improbability, but the equation is reserved for the most formidable tower; Judaism will have the additional confirmation before this writing ends when the significance of the number 72 is manifested in history as a matrix marking the ebb and flow of good and evil in the eighth and last 250 year increment ending in 2026.

For those Jews who politically lean toward "progressive" and secular I would add another walk on the hot stones of the matrices back into the deep past. Would it make any difference to secular Jews to know that the matrices also provide substantiation for the ancient Judaic timeline suggesting that Exodus, Joshua, David and Solomon are not quaint and archaic stories as Einstein intoned? I walked the increments back into the ancient past and discovered two more possibilities....possibilities only in that archeological and Judaic scholarly confirmation is required.

The matrices confirms 1743 BCE as the year the Abrahamic Covenant was bequeathed as measured 1750 years back from 7 BCE; Yeshua at 13 years old in the temple. One 250 year increment forward in time is 1493 BCE; archaeologists have traditionally dated the Minoan eruption to approximately 1500 BCE. The mathematics of the matrices have held true and provide a strong indication Moses at Sinai occurred at some time close to the aforementioned 1493BCE; 3500 years, twice 1750, before the year of the three swords, 5777/2017, would be 1484BCE.

The date provides a strong argument that two recent Exodus documentaries might be reconciled; The Cameron/Jacobovici "The Exodus Decoded" and Timothy Mahoney/Thinking Man Films "Patterns of Evidence". Two more 250 year increments forward to 993 reconcile the presumed 1 Kings 6:1 480 year contradiction. If that

truth does not impress, I would suggest a deeper look into the past should be of substantial interest to Judaic scholars.

2nd century Rabbi Yossi ben Halafta calculated the first day of the Jewish calendar to be October 7, 3761 BCE. Adding 2026 to 3761 yields 5787 according to the Jewish calendar...providing evidence the year 5777 marked the beginning of a 10 year countdown to the end of human history; the year 5777 of the Jewish calendar, the number 7 thrice over with the number “7” in Hebrew also the letter “zayin” representing both the number “7” and the word “sword”; Not Peace but the Sword; the year of the three swords...when I realized my over 600 pages of text would have to be translated to the Not Peace but the Sword book trilogy; three swords.

If one calculates 1750 years back from 7 BCE to the accepted date of the Abrahamic Covenant of 1743 BCE then adds an additional 1750 for 3493BCE all that is necessary is a simple adjustment that is fair per the terms set forth in the matrices; add 250 years to 3493 for 3743 mirroring the 1750 years from Yeshua’s crucifixion to 1776 then 250 years to 2026 and singularity...a bookend and a mere 18 years difference.

If that sounds like a presumptuous conclusion by human detritus then I suggest one more prod to the ribs of Judaic complacency is in order and the prod reflects the importance and status of Yeshua once more. If measured from 3493BCE there are exactly 3500 years until Yeshua at 13 years of age in 7 CE in the temple.

Add the 2019 years between 7CE and 2026 for a total of 5519 years...which at first glance seems to be a disconnect until you subtract the 19 years of Yeshua’s commission as measured from 7AD to crucifixion in 26AD; 6000 years exactly and the factor of 5 holds fast.

The calculation, as with the rest of the matrices, cannot be logically and reasonably dismissed as coincidence and reinforces the reason for the omission of the 19 years of his ministry as history progressed from that time forward; Yeshua represents a hinge point in history.

Yeshua came for “the lost sheep of Israel” and the benchmark for the matrices, the fall of the 2nd Temple, reinforces that truth; *time virtually stood still* during the 19 years of his ministry *extending* the covenant to the gentiles; Yeshua as a precisely defined messiah of purpose, a divine being and as a son to G[†]d; Yeshua had the authority to amend Sinai and provide for adoption of gentiles into the lesser House of Judah as was done with the mixed multitude.

Jefferson was wrong, Newton was right; Yeshua the man was also the son of G[†]d and messiah; our Creator made a specific and telling interruption in the flow of the matrices that is so precise it cannot be dismissed as coincidence or misinterpretation on my part. Judaism cannot escape the challenges being presented by the matrices...the Yeshua of the matrices does not impinge whatsoever upon Judaism and the status of a Holy Nation set apart.

The task is one of reconciliation and to emphasis that truth I would simply challenge Judaic scholars to do the math as it concerns the chances of a specific “coincidence”. The original 555 page Not Peace but the Sword; the Convergence Matrix, a difficult and discordant writing journaling the years it took to accept the reality of God

after the 5 seconds in Jerusalem, was distributed in 2018 in PDF revealing a plan that began with the Covenant between the Parts in 1743BC; the year 2018 in the Judaic calendar.

The 19 year hinge point in history allows for the reconciliation of the Hebrew calendar to the Gregorian and forms a virtual double helix; 1743BC Gregorian is 2018 Judaic. There are a total of 3761 years between 1743BC and 2018AD; an auspicious number in that not only is 3761 Judaic 1AD in the Gregorian but the Gregorian 3761BC marks the 1st year of the Judaic calendar. And then there is Abraham's birth in 1948 Judaic and Israel's rebirth in 1948 Gregorian long dismissed as "coincidence".

Go to the end to understand the beginning and to the beginning to understand the end but in this instance two beginnings fused in the end like a double helix giving life to the idea Judaism and Christianity were never intended to be two religions but rather one faith; the fusion of the two calendars reveal a third evidencing HaShem's brilliance if one recognizes the quantum nature.

There is poetic truth to the long ago reflection as to words providing the only vehicle by which man can travel through time to a long ago reality, but only HaShem is capable of fusing mathematics, Judaic scripture and time itself into a new reality. Probabilities mathematics does not allow for "coincidence" and any one calculation alone should be sufficient for a person of reason no matter where in the world they may be.

I have no doubt that the matrices work back into the deep past as proven by the examples provided but a question remains; the matrices are essentially linear with the exception of the double helix which suggests the possibility of keys to unlock the weave of existence; mathematical keys evidencing the hand of He Who Is in a way that makes clear the exceptional nature of our world.

Not speculation; evidence exists in an axis very few intellectuals, save for the possibility of *'The Language of God'* Dr. Francis Collins, would appreciate; irrefutable evidence of "BioLogos" requiring an undeniable mathematical key...which also reveals the Axis of Greatest Evil.

The time has come to reach back all the way to Sinai, the Ten Commandments and the moment the Holy Nation was born when the chosen heard God speak; experiencing terror so profound it welded them together forever. The time has come to embrace the 'language of God' mathematics warning Americans they are responsible for the last five years of human history. The time has come to accept there is a reason Jefferson and Adams are the key. The time has come for all to do the math in the context of the axis of greatest evil exposing the Marxist messiah of Marxianity...the false religion of intellectual arrogance posing as a political ideology.

Central to the plans of Marxianity is Barack Obama, no friend of Israel, who arranged for the election of Biden and chose Kamala Harris to be his running mate; Barack Obama, who broke with tradition and took up residence in Washington DC from where he controls a shadow government...and from where he will guide Gramsci's War of Maneuver, violent revolution, designed to end with his second coming as the Marxist messiah.

How evil is Obama? Look to the earth and moon. Three verses of Exodus, 14:19-21, are unique in the entire library of human literature; three verses describing how G+d literally protected the rear of the chosen people from the army of the Pharaoh until the sea was parted allowing for salvation; three verses defying probabilities mathematics act as a key to the ebb and flow of evil in the last 250 years before singularity in 2026; three consecutive verses containing 72 letters each when arranged

as 72 triplets and reversed the 72 triplets are said to not only represent the names of G^d but His divine attributes forming the essential pattern of creation.

If one questions the significance of the number 72 as a key consider the brilliance of Maimonides who said God best understood in the context of His actions and His dominion...in this instance fused.

When you look at the moon or the sun does the fact there is a precise 400 to one ratio even occur to you or is that something you never knew? The diameter of the sun is exactly 400 times the diameter of the moon and the distance to the sun is exactly 400 times the distance to the moon which allows for the spectacular coronal effect during a full eclipse.

The probabilities do not allow for mere chance but as Jeremiah said "Who will listen?" when listening now is the most important decision in history even for intellectuals who dismiss the incredible odds as mere coincidence.

Look closer and you will see what none have noticed until this moment; the diameter of the moon, 2160 miles, is exactly 72×30 ; the diameter of the earth, 7920 miles, is exactly 72×110 ...with both the earth and the moon orbiting about their barycentre; the common center of mass which varies but on average follows the moons orbit over 2000 miles below the earth surface at a point that is on average 72% of the earth's diameter.

Even the significance of the numbers 30 and 110 lend to the fusion of the symbolic and the physical i.e. the relation between God and man; 30 signifies the apex of a man's development and the assumption of authority; 110 is 10×11 and 5×22 ...and every number indicated is significant to Judaism.

Pure mathematics intellectuals separated from the idea of a supreme being now presenting as pure intellect will have great difficulty dismissing; pure mathematics unknowingly supplemented by the brilliant Michael S. Schneider as part of his 'Constructing the Universe' series which includes germane calculations within a seemingly innocuous exploration titled 'What do U.S. paper sizes have in common with the earth and moon?'

"...the diameters of both Earth and Moon, $7920 + 2160 = 10,080$, is the same as the number of minutes in one week" and "...10,080 is a Highly Composite number with exactly 72 divisors; the same as the average number of heartbeats in a minute".

The number 72 as a key not only links the size of the Sun and Moon directly to heartbeat of humanity but the number of minutes in a week evidence the significance of the number 30; the calendar of today indicates human scientific knowledge has reached maturity...and when He Who Is and his key are accepted those who accept can speak with authority and conviction to say God created both a perfect moon and a perfect sun to create a perfect home for mankind; His actions and dominion and 72 is the key.

Evil incarnate, by definition both adjective and verb, is spiritual evil assuming flesh and blood form and to this point a matter of opinion with Adolf Hitler leading the list of historical candidates; the Führer offering hope and change to the German people after the first college professor in the White House, one Woodrow Wilson,

allowed the United States to be drawn into the death throes of European empire thus setting the stage for WW2 with the Treaty of Versailles...manifest evil in retrospect.

The references to 'college professor' and the promise of 'hope and change' are nothing more than ugly racist memes directed at Barack Obama in the estimation of academics and intellectuals who largely identify as Marxians but the truth is by no means mere opinion; just as the first axis of the matrices identify Athanasius, Muhammad, Marx and Engels as evil incarnate so too an exceedingly specific axis within the last 250 increment between 1776 and 2026; an axis bearing the personal imprimatur of the God of Sinai in that only He could author a message written across the tablet of time itself.

There are two axes of the matrices in parallel consisting of a series of 72 year increments spanning the last 250 years of human history between 1776 and 2026. "Genuine historians" would be close but it is only from the higher vantage where the true implications of history can be seen; the French Revolution ushered in a degree of secular thought not easily transmitted to the United States which was intended from the beginning to be a continental fortress of Anglo-Saxon Protestantism that originated with the island fortress of 1570 England.

Mankind has paid a heavy price for the bloody egalitarian and anti-religious French Revolution including the inevitable rise of two secular false religions with Marxist socialism and National Socialist Nazism; cousins responsible for the deaths of over 100 million people in just 100 years. need only ask what 1789, 1861, 1933 and 2005 have in common as it concerns the final confrontation in the approach to 2026?

- The French Revolution in 1789 created an intellectualized society and political ideology less secular than anti-religious, intent upon enforcing egalitarianism rather than liberty; the template for secular false religion Marxianity.
- The Civil War in 1861 allowed neo-Marxists to burden the United States with the original sin of slavery despite those who gave the last full measure; carving the mark of Cain across the very soul of America even though hundreds of thousands gave the last full measure to end slavery.
- Hitler and the Nazis in 1933 forever tainted nationalism as racist in their attempt to exterminate the Jews and in defeat served as a foil to absurdly assert Soviet Marxism as a force for good; two messianic false religions...both of which targeted the Jews and as it concerns the Soviet Union created the open wound that is "Palestine".
