Committee of the Association. Dickson and her mother, Johnnie (who had been in on the surprise) shed tears of joy and excitement as Dickson was completely surprised by the honor. Dickson gives much credit to her mother and late father, Joe, who are the epitome of parental love, sacrifice, and devotion.

Dickson lives life to the fullest saying, "it's not the destination, it's the journey." When she was 15 months old, she was diagnosed with Werdnig-Hoffman disease, a type of spinal muscle atrophy, and was given one year to live. Twenty-seven years later, Dickson graduated third in her class from Temple High School, *summa cum laude* from Southwestern University, and number one in her class from Baylor Law School!


