### Section 1 – Applies to all workers at all sites

Areas to discuss	Discussed
<p><b>1. Definition of workplace violence:</b></p> <ul style="list-style-type: none"> <li>The worker knows where to find information on the definition and what is considered workplace violence.</li> </ul>	
<p><b>2. Site specific Workplace Violence Risk Assessment</b></p> <ul style="list-style-type: none"> <li>The worker knows where to find the site specific risk assessment and understands the risks of workplace.</li> </ul>	
<p><b>3. Measures taken to address workplace violence</b></p> <ul style="list-style-type: none"> <li>The worker has been informed where to access procedures, policies, instructions or has been given tools that support the elimination of workplace violence. When elimination is not possible, the risk needs to be minimized to prevent injury to workers.</li> </ul>	
<p><b>4. The appropriate measures to take if violence occurs</b></p> <ul style="list-style-type: none"> <li>The worker has been informed how to respond to incidents of workplace violence.</li> </ul>	
<p><b>5. Informed about consulting with a physician if necessary</b></p> <ul style="list-style-type: none"> <li>The worker has been informed about their rights under the Occupational Health and Safety Regulation to consult with a physician if required after an incident.</li> </ul>	
<p><b>6. Individuals with a history of violence</b></p> <ul style="list-style-type: none"> <li>The worker has been informed about individuals with a history of violence to whom they are expected to work with. The employee knows where to find relevant individual safe work instructions.</li> </ul>	
<p><b>7.
