




In the context of hourly compensation rates for general laborers, Test Company sat below the market average by 8.70% in September 2023.


2. What is the hourly compensation rate for service work in your organization?



In the context of hourly compensation rates for service work, Test Company sat above the market average by 9.38% in September 2023.


3. What is the hourly compensation rate for a Site Supervisor in your organization?





In the context of hourly compensation rates for service work, Test Company sat below the market average by 9.94% in September 2023.


4. In relation to employee compensation, what is your current Living Out Allowance (LOA) per-day per-employee/subcontractor excluding accommodations?






In the context of LOA allocation per-day per-employee/subcontractor excluding accommodations, Test Company sat below the market average by 38.89% in September 2023.


5. What are you paying as a percentage of sales for materials specific to commercial work?

Market Average September 2023 - 53% of total sales spent on material costs towards commercial work. Market Average August 2023 - 47% of total sales spent on materials costs towards commercial work. This demonstrates a 6% increase from the previous month.

Test Company September 2023 – 55.80% of total sales spent on material costs towards commercial work. Test Company August 2023 – 51.74% of total sales spent on material costs towards commercial work. This demonstrates a 4.06% increase from the previous month.

In the context of what a company is paying as a percentage of sales towards materials for commercial work, Test Company sat above the market average by 2.80% in September 2023.
