- AKK's fee is \$45.00 a day for boarding.
- You are responsible for providing food for the duration of your dog's stay. You may also bring a bed, blanket and toys to help comfort your dog during its stay.
- Your dog will be fed according to the schedule and amount you indicate below

- Your dog will have their own sleeping kennel unless you are boarding more than one dog with us. Your pet will have yard time up to 5-7 hours a day and be allowed to play with other pets according to temperament and behavior.
- Pet owner certifies that pet being boarded is not currently a show dog or used for income sources.
- If the pet shall in any form become ill or if the state of the animal's health requires attention, pet owner will be called immediately, and the pet will be taken to the vet listed on the contract. If that vet is not available, AKK will take pet to a vet of our choice at the pet owners' experience.
- Pet owner represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.
- Pet owner specifically represents that they lawfully own pet(s) listed in the Pet Boarding Agreement.
- Pet owner will be held solely responsible for all acts or behavior including aggression that takes place during boarding.
- Pet owner understands that all fees must be paid in full before the pet may leave the kennel.
- This agreement, and any addendums attached shall be binding on the agreed parties.
