He authored his second children's book in 2014. He wrote **Up in the Sky** to commemorate the birth of his first grand-daughter, Skylar.



Silber pens children's book at daughter's urging

During the week, Jere Silber of Silver Spring sells jantitorial supplies as part of a family business but his real passion lies elsewhere.

A man in touch with his creative side, author Silber, 44, prefers spending time with his 7-year-old daughter, Morgan, or coming up with a new story line.

Silber, who lived in Olney for 13 years before moving to Silver Spring, can recall writing screenplays about people he knows as far back as high school. After finishing lins first movie, he hired a literary agent to help market it to the folks in Hollywood.

"I started writing at 18. I had just graduated from high school, and my childhood sweetheart had moved away to become a model. I thought that if I wrote a movie, she might like to be in it, "Silber said." do not think I am a good writer. Many of the people I know can write better than I can.


My strength is conceptual. I have ideas.

Silber has continued to market his screenplays with the assistance of an agent ever since he began writing in the early 1980s. He now has nine screenplays tucked away in his portfolio, but is still awaiting his big break. With the knowledge that producing a screenplay could cost millions of dollars, Silber considered a new avenue to stardom for the first time two years ago.

It was then that while he was writing a screenplay called "The Hourglass," his daughter suggested that he turn his attention to something she could read. In this discussion with her father, Morgan said she wanted him to write a children's book about trees.
With that, Silber's book, "The Family Tree," was born.
In it, he tells the story of a family of deeply rooted sycamone trees that find they have no place to hide when three

men from a logging company come into the forest to nail up signs.

After the trees are cut down, they can no longer provide a home to the birds or other animals that used to find shelter under their branches. They become separated for a time. Just as a happy ending seems virtually impossible, the trees are surprisingly reunited in the home of the Kobinson family, where they find each other serving as everything from a grandfather clock to a coffee table, kitchen cabinets and wood siding.

"I started doing the book for Morgan, but when I sent it to my agent, she said it was pretty good," Silber said. "So I began multiling over ideas for how to package it. In addition to the book [published under the name of "Morgan's Magical Books"]. I put the story on CD and turned it into a coloring book and a viden. The video comes with seeds donated by Weyerhaeuser for kids to plant."

Morgan, already a pro at planting asparagus and flowers with her mother, is looking forward to planting

these seeds with her father in a couple of weeks. By putting them in the fridge, they hope to fool the seeds into thinking it is winter. If they are successful, the seeds will be ready for planting when they emerge.

"I am compassionate toward a lot of causes, but in the book, I took no stand on issues either way." Silber said. "It is not a social issue book. It is a vehicle for children for kids to understand the process of turning trees into things we need in our every day lives."

Writing the book came easily to Silber, because he said he thought of it as a gift for his daughter. The hard part was finding someone to illustrate it, until he happened upon Rob Rock, who has illustrated segments for a public access series, "Diana, Mike and the Rabbi."

Rock lives in Hagerstown and has done political cartoons for many years. This was his first time illustrating a childen's book, and he said he had some difficulty fitting the project into an already tight work schedule, but nevertheless would like to illustrate a children's book again.
"I have three children of my own [Kathleen, 9, Jonah, 8, and Joyce, 6], and it is interesting to convey pictings to them in a way that they understand them," Rock said. "Illustrating The Family Tree' was a lot of fun. The only challenge was creating a variety of illustrations when they all were supposed to be basically trees talking to one another."

Silber said he tries to market "The Family Tree" every chance he gets be-

Later this month, the video he created based on what began as a children's book for his daughter will air several times on Montgomery Community fleelvision, where he currently serves as assistant producer of a stand-up comedy show.

His marketing plan also includes teaming up with a national organization, such as the Arbor Day Foundation, which he says could share in a portion of the proceeds in turn for leading its name to the sales campaign.

The 1999 Monty Award for *Best Studio/Arts and Entertainment Program* was presented to Jere Silber for his video adaptation of his children's book. The Family Tree was judged by several television stations throughout the region. The video was credited for originality and creativity.

Mr. Silber credits his daughter for the concept and stated that this experience was a family effort and he shares this award with her.





The Evolution of Tree Story

I began writing in 1974. My first screenplay was based on the song "Taxi" by Harry Chapin. I wrote my first children's book in 1997. My daughter Morgan was the driving force that gave me the inspiration and motivation to write, Tree Story, which was originally titled The Family Tree. Before that, I had never dreamed that I would ever write anything for children. I was divorced at the time, and it was my weekend to spend with Morgan. I was just coming out of a long-drawn-out annoying bout with writer's block, and I was eagerly working on a screenplay that I had been writing when my thought process decided to suddenly go on an extended vacation! Out of desperation, I was trying to keep Morgan both happy and entertained. I was feeding my VCR with what seemed to be an endless supply of videos for her to watch. When I thought that I had finally gotten her attention directed entirely on Barney the Purple Dinosaur she got mad at me for leaving her out there stranded all alone on "Barney Island". It was at that point that she let me know exactly how disappointed she was, "How come you never write anything that I can read?" She asked. I was taken by surprise, and I did not know quite how to respond. "Well, what should I write," I asked. It was obvious that she had planned her response for quite a while because she fired right back with, "You can write about trees. You should make them families of trees in a forest!"

I knew that I had just been put on notice by my five-year-old daughter. She had just challenged me to write my very first children's book. I couldn't ignore what I perceived to be a dare of sorts even though my first inclination would have been to somehow slither far away from her request. Fortunately, my voice of reason immediately kicked in and I decided that I would write a very quick, short story about a tree or two in the forest just to appease Morgan enough so that I could then hurriedly get back to working on the screenplay that I had been writing before her trying to redirect the entire course of my writing career!

As I began to work on the story, I clearly remember thinking that I would only dedicate an hour or so to working on the project. As I was writing what was originally supposed to be that one to two trees in the forest scenario it became very clear that I couldn't stop it from growing. It kept getting bigger and better as I continued to write. It was very peculiar because I felt this unbelievable sense of power when I put my fingers back onto the keyboard. I had never experienced a sensation quite like that one before. When the story was complete the forest scenario had transformed into a multitude of family trees accompanied by a wide array of wildlife that was all living harmoniously inside of the boundaries of that forest. In the end, the story had grown conceptually beyond anything that I could have ever imagined.

Tree Story is geared toward children 8 to 13 years of age, and elementary school-aged children, and it follows families of trees that are harvested, taken to a lumber mill, and made into new wood products. Throughout the story, the families continue to face the possibility of being separated forever... or did they?

Goals

It is intended for the Capital Cares Presentation to become a public service announcement and to focus on the efforts of the Nation's Capital to feed hungry families throughout the country and right here at home; and

To produce a recording from this performance. It is our intention to secure media involvement in the presentation. The ultimate goal is for the song to be signed on with a record company. In that event, all proceeds will be directed to a local fund raising organization for hunger.

From Woodstock icon to TV 'word wizard'

Richie Havens turns talents to helping kids read

Owned staff writer is graying, but the speaking voice is as soft as the one that chatted up the Woodstock audience in 1969 while he repaired a broken guitar string at the very start of that legendary three-days carried. day festival.

Richie Havens — singer, songwrit-er, community activist and literacy advocate — has been plying his tal-ents in Rockville this week as part of a new television program aimed at encouraging literacy among chil-

a new television program aimed at encouraging literacy among children.

And a new technology that accompanies the effort is a breakthrough that opened a door in even Havens' wide-ranging concern for children.

"To me," he said, "If people give me information, I use it. It's that simple." The simplicity of the new technique in "Mr. Word Wizard" is an extension of what Havens said he's always held to in his career.

With 21 albums and 13 motion picture soundtracks under his belt during a career spanning nearly four decades, he maintains, "I really sing songs that move me. I'm not in show business and never was. I'm in the communications business. That's whati's about for me."

"Mr. Word Wizard" is the first nationally distributed program to make its debut on public access television and will feature Havens and a cast of characters designed to encourage reading among younger children.

The show will be launched during

Jere Silber AKA - Stevie Ray Ban - Actor / Comedian




Stevie Ray Ban (Not his real name. His legal name is Foster Grant). Stevie was introduced into the world of comedy through his association with Mr. Jeffrey M. Penn of Proper Entertainment Incorporated. He immediately discovered a tenacious admiration and earnest devotion with respect to the profession. His initiation helped establish a working knowledge of the business side of comedy. This opportunity was very fortuitous. It enabled him to work on events that would feature many of the biggest name comics of the time. Dennis Miller, Sinbad, Martin Lawrence, Billy Connolly, Soupy Sales, Bob (Bobcat) Goldthwait, Marty Putz, to name a few.

Through his affiliation with Proper Entertainment, Stevie Ray Ban had accumulated extensive travel time with prop comic extraordinaire Marty Putz. As a result of this road time, Stevie discovered a high-spirited desire to perform. The idea of Prop Comedy was self-evident and a natural due to his admiration for Marty Putz, and his ability to transform an idea into a visual creation. During their many writing collaborations on the road, Marty expressed his sincere interest in the comedy career of Stevie Ray Ban.

Billed as a Prop Comic, Stevie Ray Ban integrates Stand-Up into his act as well. From... the camouflage outfit he wears on stage, confessing to the crowd, "The reason that I am dressed like this tonight is because I am hiding from my ex-wife. Actually if I really wanted to hide from her all I would really need to do is dress just like anyone who earns less than one hundred thousand dollars a year! She'd never spot me!"... to his gold earring, claiming "I was the victim of a drive-by shooting, I'm okay, luckily the bullet just pierced my ear."

He is quick to remind the audience, "My wife wanted me to donate my blood to the American Red Cross... I mean she wanted to donate all of my blood to the American Red Cross... Every Drop!"




