# **Vendor Rules and Regulations**

1. There is limited space. Applications will be accepted on a first come, first serve basis.
2. Vendors must provide a tent, tables, signage and any supplies needed for their booth.
3. Vendors will receive confirmation of their acceptance as vendors upon receipt of application with payment. Vendors will also receive a letter **by email regarding set up times etc. one week before for each event that vendor is participating.**
4. Vendor vehicles must be cleared out of the festival area no later than two hours before the festival opens each day. No vehicles may return to the festival area before the festival closes each night.
5. Vendors are responsible for their own sales tax collection. Food vendors are responsible for liability insurance and proper health compliance. Fayette Festivals PA must be “Additionally Insured” on your insurance for the dates of the festival(s) you attend.
6. Vendors must remain open during festival hours and be prepared for sales one half hour prior to the festival’s opening each day. Vendors who tear down before the close of the festival will NOT be invited to attend any future events.
7. The appearance of the vendor booths must be clean and attractive. Trash removal and space cleanliness is the responsibility of the vendor. Breakdown may begin at the close of the Festival on Sunday and must be completed by midnight. Vendors must leave their space clean and free of grease (food vendors) or any other debris (all vendors).
8. 24-hour security will be provided. Although you may elect to leave items at your assigned space overnight, we recommend that items be removed from vendor spaces and secured.
9. The Festival will commence even in inclement weather. **No refunds will be given for ANY reason.**
10. No power will be provided by Fayette Festivals PA. Vendors who need power MUST bring their own QUIET generator. If the generator is too loud, you will be asked to shut it down or leave the event. No refunds. No exceptions.
11. FAYETTE FESTIVALS, PA AND THE CHARITIES IT SUPPORTS WILL SELL ALL BEVERAGES. Any other vendor who attempts to sell beverages of any kind will be asked to leave the event with no refund. Wineries & distilleries are exempt from this rule.
12. The festival committee, its organizers and the venue where the festival is held will not be responsible for any injuries, lost or stolen property or damage of any kind during festival hours or overnight.

Applications *must* be completed and mailed with payment. No deposits to “hold” space will be accepted.

**We understand that each vendor wants the best spot in each festival. Vendors will be placed in the order their forms were received. So, if you want a great spot get your applications in ASAP!**
