Environmental Management and Protection Act, 2010

The Ministry of Environment regulates waste management and enforces landfill and transfer station compliance under The Environmental Management and Protection Act, 2010. Municipalities and private companies own and operate landfills throughout the province.

Policy:

1. WEATHER

- 1.1 The Resort Village of Kannata Valley sets the following weather restrictions on the use of the RTS on weekend hours when the operator is scheduled to be present:
 - a. Ambient temperatures of -30°
 - b. Wind chill of -45° or more

2. HOLIDAY HOURS

2.1 Winter holiday hours falling on a Saturday, the RTS will be open on the Sunday directly following instead.

3. PERMITTED USERS

3.1 Owners/residents of Kannata Valley and Rock Ridge may haul to the RTS as permitted users.

4. NOT PERMITTED ITEMS

- 4.1 The following items are NOT PERMITTED in the RTS:
 - a. Propane tanks of any kind

- b. Tires
- c. No freon from fridges and deep freezes
- d. Paint Cans
- e. Electronics
- f. Oil
- g. Batteries
- h. Florescent Bulbs

5. TREES/BRANCHES/SHRUBS

- 5.1 Any chipping required will be completed annually.
- 5.2 Large trees and branches must be 6 feet or under in length and no more than 3" in diameter.

6. FURNITURE

- 6.1 Furniture with wood frames and/or main construction material.
- 6.2 Furniture must be broken/cut down before adding to the large red bins.
- 6.3 Acceptable furniture based on subsection 6.1:
 - a. Beds, couches, chairs, cabinets, end tables, coffee tables, dining tables, and similar outdoor furniture.
- 6.4 Metal furniture must be added to the steel pile after the removal of any other attached material.

7. RECYCLE BINS

7.1 No garbage will be accepted in the blue recycle bins.

8. PROPERTY DEMOLITIONS

8.1 All demolitions of residential buildings and accessory buildings over 300 sq ft must obtain their own bin for refuse.

9. HOURS OF OPERATION

- 9.1 The RTS hours of operation will be as follows:
 - a. Summer months May 1st October 31st Saturdays and Sundays 10:00
 a.m. 12:00 noon and stat holidays that fall on Mondays.
 - b. Winter months November 1st April 30th Saturdays only from 10:00 a.m. to 12:00 noon.

10. RTS KEYS

- 10.1 RTS keys are non-transferrable. All new property owners must obtain their own key. Key deposits will not be returned to property owners who have not paid the deposit.
- 10.2 RTS key deposit will be \$100.00/key.
