- 2. Change to the Science of Reading: Dyslexia BC's report champions a transformation in the education system to align with the science of reading. This means implementing evidence-based reading practices in all classrooms to ensure that students receive the most effective instruction. This change is crucial for supporting dyslexic individuals and creating a more inclusive learning environment.
- 3. Intensive Literacy Centers: Dyslexia BC emphasizes the need to establish literacy centers employing evidence-based practices in all school districts throughout British Columbia. These centers will serve as vital hubs for remediation, providing

- much-needed support to dyslexic students, which is essential for their educational success.
- 4. **Government Funding and Teacher Training:** Adequate funding and teacher training are identified as crucial components of this transformation. Dyslexia BC stresses the necessity of equipping educators with the tools and knowledge required to effectively support dyslexic students, ensuring that they receive the tailored support they need.
- 5. Post-Secondary and Workplace Access: Recognizing that the impact of dyslexia extends beyond K-12 education, the report highlights the importance of addressing barriers affecting dyslexic individuals in post-secondary institutions and the workplace. The report calls for breaking down these barriers and ensuring access to necessary accommodations for dyslexic individuals to promote their success in higher education and professional life.
- 6. Q Designation for Learning Disabilities: Dyslexia BC calls for clarity and consultation regarding the Q Designation for all learning disabilities in legislation. This should include input from families and learning disability experts to ensure that the designation aligns with the needs of dyslexic individuals. The report raises questions about the discontinuation of Individual Education Plans (IEPs) for Q Designation students and seeks clarification to ensure that the needs of these students are met effectively.

**Dyslexia BC** was thrilled this year to see their advocacy take shape with the motions passed earlier this year. These motions focus on dyslexia screening in kindergarten, the adoption of evidence-based reading practices across British Columbia, and the establishment of specialized literacy centers in each district for remediation. These actions aim to pave the way for a more supportive and inclusive educational landscape for dyslexic individuals in British Columbia.
