

MINUTES OF REGULAR TOWN BOARD MEETING

June 15, 2026

The regular monthly meeting of the Town Board of the Town of Johnstown was called to order by Chairman Mawhinney. Supervisors Fleming, Mair, Hillmann and O'Leary were all present, along with Clerk Kat Mawhinney and Treasurer Patsy Weber.

Following the posted agenda:

- Chairman Mawhinney called the meeting to order at 6:02 p.m.
- The Pledge of Allegiance was recited.
- **Approval of Agenda** – Motion by Fleming, seconded by O'Leary, Motion carried.

Fire and EMS Report:

- Chief Pickering provided an update on recent fire and EMS activity in the district.
- No representative from the Sheriff Department was present.

Clerk Report:

- A motion to approve the May minutes as submitted was made by Fleming and seconded by O'Leary. The motion carried.

Financial Report:

- The Treasurer's Report was presented by Patsy Weber. Motion by Hillmann, seconded by Mair, to approve the report. Motion carried.
- Motion by Mair, seconded by Hillmann, to transfer funds (\$13,674.85) and pay bills in the total amount of \$19,793.05. Motion carried.

Zoning Officer Report:

- Hoyt reported one Zoning Permit issued this month (Swets for a new home)
- Hoyt also reported that the Fletcher construction project is at a stand still per the building inspector.
- Mentioned that Derek Duoss maybe interested in a field driveway on Hwy KK, which would be a county issue

Alcohol, Tobacco, Operator's License Action/Approval:

- Application received to Renew the Class A Beer License and Class B Liquor License for Dorr's Prairie Woods Golf Course, LTD. A motion to approve both licenses was made by O'Leary and seconded by Fleming. The motion carried.
- Application received to Renew the Cigarette, Tobacco, Electronic Vaping Retail License for Dorr's Prairie Woods Golf Course, LTD. A motion to approve the license was made by Fleming and seconded by Mair. The motion carried.

- Application received to Renew the Class A Beer License and Class B Liquor License for Dorr's Prairie Woods Golf Course, LTD. A motion to approve both licenses was made by O'Leary and seconded by Fleming. The motion carried.
- Prairie Woods Golf Course, LTD submitted four renewal Operator License applications along with three new applications. A motion to approve the licenses was made by O'Leary and seconded by Hillmann. The motion carried.

Road Work:

- Chairman Mawhinney reported on the ongoing conversations with Rock Co DPW discussing the status of work that needs to be done within the township along with the request to review billing statements.
- Annual meeting at the DPW office for the Town of Johnstown is 6/18/26 at 8:00 am
- Discussion on fixing the stretch of road on County Line, authorizing the county to repair 200 feet of road for a cost of \$6400
- Other items mentioned: ditch mowing being aggressive, Six Corners shoulder breaking up, missing ATV route signs on Highway M

Community Center:

- The Prairie Preschool LLC hopes to start operations on July 1, 2026. Waiting on the final lease to be presented.
