**TO CREATE A REVISED MUNICIPAL CODE**

AN ORDINANCE TO CREATE A REVISED MUNICIPAL CODE PURSUANT TO SECTION 66.0103 OF THE WISCONSIN STATUTES.

The Town Board of the Town of Johnstown, County of Rock, State of Wisconsin, ordains as follows:

SECTION 1: PURPOSE. The purpose of this ordinance is to enact a revised "Town of Johnstown Municipal Code" consisting of the following chapters:

and which has been prepared and authorized by the Town Board.

SECTION 2: AUTHORITY.    The Town Board of the Town of Johnstown, Rock County, Wisconsin, has the specific authority under Section 66.0103 of the Wisconsin Statutes to prepare and enact a code of some or all of its general ordinances by enacting an ordinance that incorporates the code by reference.

SECTION 3: ADOPTION OF ORDINANCE. The Town Board, by this ordinance, adopted on proper notice, with a quorum and roll call vote of the Town Board present and voting, provides the authority for the Town of Johnstown to prepare and enact a code of its general ordinances by enacting an ordinance that incorporates the code by reference.

### SECTION IV. ENACTMENT AND INCORPORATION OF CODE OF ORDINANCES.

The code of ordinances in book form entitled "Town of Johnstown Municipal Code," listing the chapters set forth in Section 1 above, having been placed on file and open to public inspection in the office of the Town Clerk for a period of two weeks, commencing \_\_\_\_\_, 2025, pursuant to Section 66.0103 of the Wisconsin Statutes, is adopted as the general code of ordinances in and for the Town of Johnstown, Rock County, Wisconsin. The code is incorporated in this ordinance by reference.

SECTION V. EFFECTIVE DATE. The ordinance is effective on publication or posting as required by law.
