## 2) Discussion Items

- Formation of the Reata Ranch HOA and signed surrender legal doc by Declarant received Open discussion of the pros and cons to forming the HOA. Pros being able to focus on the goals for the betterment of the subdivision. Cons; Max will not be paying HOA dues on remaining lots. Getting HOA formed and ensuring the existing HOA is free from any liens or liability. Tackett is going to check on that and report back to all. Max has agreed to surrender provided the agreement is signed (Tackett will get with Max on signing the Surrender doc). Agreement reiterates HOA responsibilities already in the current HOA guidelines, but adds that he will be excluded from HOA dues. It was also mentioned to ask each lot owner, if possible, to mow their lots to include the HOA portion from where their lot begins and the road, to help save some money.
- Procedures and responsibilities of the Reata Ranch HOA
   Revision of the Agreement to remove the verbiage of Max maintaining his lots. He did not want
   that on the Agreement and text Tackett shortly before the meeting. Tackett is making that
   revision and will send to those that attended the meeting to sign on behalf of ALL members.

# Goals of Reata Ranch HOA

### **Immediate Goals:**

- a) Proceed with the formation of HOA.
- b) Lee's agreed to install a new well and allow HOA to tap into and add irrigation to the front entrance for landscaping needs. In exchange they will be exempt from HOA dues on their 3 lots. Further details will need to be in place should they ever decide to sell (Tackett will discuss with them and prepare that agreement).
- c) Upgrade entrance landscaping
- d) Correct the drainage/erosion issues on Lot 17, Blk 1 (Spicer has someone to contact with a bulldozer he will reach out to for a bid). Pagan provided his expertise on it as well.
- e) Roads; Reeder has already contacted the county to come and work on the road
- f) Rock culverts and planters; repair as needed and some sort of hardy plants or decorative rocks in planters.
- g) HOA website. Nagi suggested Tackett ask Max about transferring the existing site to the HOA and he can add to it a page for HOA public information as required by law. Tackett will talk to Max about that.

### Long Term:

- a) add electricity to front entrance b) install security camera
- c) lighted sign at entrance

- Duties needing done with regards to the formation of the HOA
  - a) By laws and record those with the county (Tackett will start on this).
  - b) HOA liability insurance (Reeder will gather info on this)
  - c) Election of officers
  - d) Obtain a current accounting of funds from Teresa and any monies due to HOA
  - e) Open a bank account for dues (Delfabro will be able to do this once HOA By Laws and any other legal docs are completed)
- Who would be willing to serve as Board Officers: Pres, VP, Sec, Treasure (min of 3 needed), ARC
  Committee, Landscape Committee (not elect, at this meeting, as all members have that choice
  and shall be done via email and voting response from all members)
  - a) Richard Reeder agreed to be President
  - b) Tim Spicer agreed to be Vice President
  - c) Rebekah agreed to be Secretary
  - d) George Delfabro said his wife, Julie, will agree to be Treasurer

These will all be one year terms of ALL elected. Tackett will send an email to ALL to vote.
