Wyoming State Fair

**August 16<sup>th</sup>, 2025 Show starts at 9:30am**

**Judges: Scott Rodriguez, Christa Denies and Teri Peterson**

- 2025 ARBA show will be a Double Open All Breed Rabbit show.
  - (any exhibitor can show in open shows)
- WSF ARBA show will be in the Event Tent. WSF will work on keeping this area cool.
- Entry Fees are per rabbit per show \$4.00 Fur Class \$2.00
  - WSF does charge an admission fee to get into the fairgrounds this is done at the time you enter the fairgrounds. Adults are \$8.00, 12 and under is \$3.00
- Mail in Entries need to be in the Mail by July 31<sup>st</sup>.
- Email or Online entries are due no later than August 10<sup>th</sup> 2025.
  - HTRC would prefer entry be done thru the online entry form or thru email.
- You have the option to pay for your entry fees at the time you make your entry if you use the online entry form. You will be required to pay the online processing fee the financial company charges.
- **No Day of Show Entries**
- Sanctioned Breeds: as of 7/8/2025 Mini Lop, Tan, Havana, Holland Lop, Dutch, Palomino, Standard Chin, Czech Frosty, Himalayan
- **Health Certificates will be required for all rabbits coming to HTRC's show at WSF.** For out of state exhibitors
- Make checks payable to HTRC not WSF.

### **To get to the Event Tent on the WSF fairgrounds:**

Go to Brownfield Rd enter WSF Fairground thru Gate 1 follow this road until you come to the entrance checkin gate. WSF staff will visually check your rabbits. Once leaving the entrance gate follow the dirt road to the west and along the river till you come to a white security building and head East. Event tent is across from the grandstands/parking lot.

Once you unloaded your rabbits you will need to move your vehicle to one of the fairgrounds parking lots. You will need to pay for your entry pass if you didn't when you

first came onto the fairgrounds. The closest parking lot to the Event Center is the parking lot near the Beef and Sheep barns which is further north of the event tent. If you need a ride back to the Event Tent, FFA is offering a free taxi call 866-333-3838 or the Fair Possie will be available also.

### Health Requirement:

All rabbits must be free of disease. All rabbits will be inspected upon arrival. Any rabbit showing signs of sickness or disease will not be allowed to enter the grounds. Each exhibitor is responsible for the health of their rabbits.

## HTRC's Show Rules

1. This is an official A.R.B.A. Open and Youth sanctioned show. By submitting an entry, you have indicated that you will abide by HTRC's show rules and the rules of the A.R.B.A., which govern this show.
2. HTRC's reserves the right to refuse entries from all locations within 30 miles for wild/50 miles domestic rabbits which has had a confirmed outbreak of RCD/RHD/VHD within the past 30 days of the entry.
3. **ARBA Show Rule 30**, All animals must be the property of the exhibitor(s) prior to entry. Each owner's personal name(s) must be listed on the entry form.
4. **No animals under 10 weeks of age will be allowed in the barn for any HTRC event.**
5. **HTRC will not accept day of show entries. This includes moving rabbits to different classes.**
6. All shows will start promptly at stated time in the catalog.
7. Make checks payable to High Time Rabbit Club (H.T.R.C.) Make sure your entry form is completely filled out, if you have questions, please call the show secretaries. Email entries to [hiddenlops@rtconnect.net](mailto:hiddenlops@rtconnect.net), Online entries can be made thru [www.hightimerabbitclub.com](http://www.hightimerabbitclub.com) click on spring show tab and link to online entry is on this page.
9. HTRC's rabbit events: **email or online entries will be accepted until 11:59 PM on August 10<sup>th</sup> 2025.**
10. **All entries will need to be paid for even if you do not attend or you scratch rabbits at the show.**
11. All entries must be paid before the start of the show. There will be a \$35.00 charge for all NSF checks. You will not be able to show in upcoming events till all fees are paid.
12. Judging order will be posted Friday night but judging order may need to be rearranged.
13. All rabbits must have **A PERMANENT, LEGIBLE TATTOO IN THE LEFT EAR** or they could be eliminated.
14. All wool/fur entries must be entered in their breed class. Unless another fur class is requested, all fur entries will be judged in breed fur.
15. Exhibitors will be responsible for getting their rabbits to the judging table as soon as the class is called. Rabbits will be called three times. If they are not on the table after the third call, the class will be closed. THERE WILL BE NO REJUDGING OF A CLASS.
16. Ear number substitutions will be allowed at the show table when the class is called. Please let the helper behind the table for your class know of your ear number change at the time you put your rabbit in the judging coop otherwise you may have your rabbit disqualified. **Substitutions may be made only in the same Breed, Variety, Class, and Sex. Please do not ask to change classes for different varieties or sex etc., this would be considered a new entry and HTRC is not allowing day of show entries.** Wool/Fur substitutions will be allowed only in the same breed and variety.
17. H.T.R.C. reserves the right to add or substitute judges, if necessary. There will be no payback for this show.
18. DO NOT enter any other buildings on the fairgrounds. Please keep track of your children. Anybody caught vandalizing property will be asked to leave and your entry fees and placing will be forfeited. You will be liable for the cost of repairs. Parking is allowed only in designated areas
19. **NO SMOKING WILL BE ALLOWED IN ANY OF THE BUILDING! If you smoke, please pick up your cigarette butts when finished with your cigarettes!! This would be greatly appreciated!!! HTRC members must clean up after you. So please be considerate and pick up your butts.**
20. **HTRC members are required to clean the barn and surrounding areas after the show is over and we would appreciate your help in cleaning your area when finished showing.**
21. Neither the H.T.R.C. nor the owner, agent, management, of the show facility, or any other organization will be responsible for any type of theft, accident, or injury to any person or personal property, (whether owned, borrowed, or rented) due to neglect or any other cause. Exhibitors will show at their own risk. Parents are responsible for their children and their actions.
