2026 Pool Opening Services INFORMATION

SPRING OPENING: Includes re-assembling filter, system, pumps, and accessories from winterization. Light heater pilot and test fire (the heater will be turned back to the off position after we test the pilot). Removing all plugs, installing handrails and ladders **if left available**. Water chemistry will be tested and adjusted unless otherwise specified by pool owner. **Chemicals for adjustment are billed additionally**. Water level must be 1/2 way across the mouth of the skimmer and the parts must be made available. There is a return visit charge of \$45.00 if this has not been completed and we need to return to start up system. If you have signed for a clean-up service, the pool will not be vacuumed on the opening day, we will return to complete clean-up. Additional charges will occur for systems with multiple filter systems, or extensive water features.

It is the customers responsibility to bring the water level to operational level prior to the scheduled opening date.

COVER REMOVAL: As described below. **Please note, there is an additional \$35.00 charge if this is the only service we are providing.**

Mesh Safety Cover. Cover removed, folded, and left on deck. Pop-ups lowered. **\$100.00**

Custom Solid Cover, Small Debris brushed off, cover folded and left on deck. Pop-ups lowered. **\$125.00**

Solid Vinyl Cover, Small Debris brushed off, folded, and left on deck. Empty water bags. **\$150.00**

It is the customers responsibility to remove all excess water and debris from the top of the cover prior to the scheduled opening date. If cover needs to be pumped and heavy debris removed, there is a minimum \$75.00 additional charge and \$25.00 per each 15 minutes of pump time.

Covers are left folded on the deck for the customer to store away.

POOL CLEAN UP SERVICE: Pool will be cleaned and adjusted throughout the course of several visits until it is clean and clear and chemically balanced. Service is provided and billed out hourly and **chemicals are not included and will be billed additionally**. Please know, this service requires several hours and varies year to year. Please plan for a minimum of \$300.00 or higher. Staining is not part of the clean-up process.

This service is only offered if oasis pool service is spring assembling the pool as well.

HEATER INSPECTION & CLEANING: We will clean burner tray, ignition assembly, and components of heater. We will inspect the controls and operation of the heater to ensure it meets safety requirements. Heater will be test fired and left to run no longer than 10 minutes, heater will be left with pilot lit but not running. Any parts needed and labor to install will be billed in addition to the cleaning service. IF PROPANE HEATER, PROPANE MUST BE FILLED TO COMPLETE INSPECTION. A fee will be charged to return to fire heater if propane tanks are not filled. Please note that no repairs or parts are offered for this service, this is for the inspection only.

This service is only offered if oasis pool service is spring assembling the pool as well.

SALT CELL INSPECTION & CLEANING: Salt system will be inspected, cell will be cleaned to remove build up from prior season, anode will be cleaned and replaced if necessary. Salt system will be left operational unless specified on paper. Salt cell will not be left on until pool is clean and clear and free of debris. All parts and labor to install include Anode will be billed additionally. Please note that no repairs or parts are offered for this service, this is for the inspection only.

2026 Maintenance Service INFORMATION

OPTION 1- FULL WEEKLY OR BIWEEKLY MAINTENANCE SERVICE:

Up to 45 minutes of labor. Any time past the first 45 minutes will be billed as additional labor

OASIS POOL SERVICE, INC. will maintain the pool on a weekly (1x per week) OR bi-weekly (every other week) basis as specified by the customer. Either option includes the following: Pool will be vacuumed, skimmed, and brushed. Skimmer baskets and pump baskets will be emptied. Tile will be brushed and cleaned as needed to avoid build up. Filter system will be backwashed as needed. Pool chemistry will be tested and adjusted. Neither option includes chemicals, they are billed additionally.

Customer chemicals can be used if available and only if specified by the customer, if not chemicals will be added and billed additionally.
The prices below are for pools up to 35,000 gallons. Any pool about that level will be charged our OVERSIDED maintenance prices. These prices are provided separately.

Weekly Maintenance Service (season pricing) \$ 95.00 per visit

Bi-Weekly Maintenance Service (season pricing) \$110.00 per visit

OPTION 2- WEEKLY CHEMICAL CHECK SERVICE:

Up to 20 minutes of labor. Any time past the first 20 minutes will be billed as additional labor

OASIS POOL SERVICE, INC. will test the pool chemistry and adjust the water balance according to the chemical demand. System will be checked and backwashed if needed. Chemicals will be added and brushed into pool water. Chemicals are billed additionally. This option is offered on a weekly occurrence only.

NO VACUUMING OR ANY CLEANING SERVICE WILL BE DONE WITH THIS OPTION.

Customer chemicals can be used if available and only if specified by the customer, if not chemicals will be added and billed additionally.

Weekly Chemical Check (season pricing) \$ 65.00 per visit

WATER LEVEL MAINTENANCE IS NOT PROVIDED NOR ARE WE RESPONSIBLE FOR WATER LEVEL FOR EITHER SERVICE. CUSTOMER MUST MAINTAIN THEIR OWN WATER LEVEL AT ALL TIMES, AT NO TIME, WILL OASIS POOL SERVICE, INC. ADD WATER TO THE POOL.

FOR ALL BIWEEKLY SERVICES- IT IS THE CUSTOMERS RESPONSIBILITY TO MAINTAIN THE WATERS CHEMISTRY AND POOL CLARITY ON THE WEEKS OASIS POOL SERVICE IS NOT SCHEDULED TO BE THERE. POOLS SHOULD BE TESTED AND ADJUSTED ON A WEEKLY BASIS TO REDUCE THE RISK OF CLOUDY WATER AND/OR ALGAE GROWTH. ADDITIONAL LABOR AND MATERIALS CHARGES WILL APPLY IF ALGAE CLEAN UP IS NEEDED AT THE TIME OF THE MAINTENANCE SERVICE*

ALL MAINTENANCE SERVICES ARE SCHEDULED BY LOCATION TO ENSURE WE HAVE EFFICIENT ROUTING TIMES. IF IT IS REQUESTED FOR US NOT TO BE ON SITE ON YOUR SCHEDULED MAINTENANCE DAY AND/OR WE ARE UNABLE TO GET ACCESS TO THE POOL AREA THEN THE MAINTENANCE SERVICE WILL BE CANCELLED FOR THAT WEEK AND WE WILL RESUME AT YOUR NEXT SCHEDULED VISIT. 2026 Credit Card on File Agreement

*****THIS AGREEMENT MUST BE FILLED EACH YEAR*****

For all Oasis Pool Services customers, a valid Credit Card to be kept on file is **required and mandatory** prior to any scheduled service. Oasis Pool Services will not provide any services without this requirement. There are **NO EXCEPTIONS** to this requirement. The valid Credit Card on file will be charged the required deposit for any service, unless other forms of payment along with the valid credit card number are submitted at the time of scheduling the service. After the deposit has been applied the credit card will not be charged unless the customer would like to be an **Auto Bill** customer and/or the customers unpaid balance on account exceeds a time limit of 15 days.

Please note that all invoices are due upon receipt. If payment is not received within 15 days a \$35.00 late fee will be applied to each invoice as needed and the card on file will be charged for the full amount. If the card on file declines for payment a \$15.00 fee will be applied with an additional \$35.00 for each additional month thereafter.

-All Auto Bill customer invoices will be billed and have the valid credit card on file charged full payment at the end of each month (for maintenance customers only) or at the time the service is completed for any unpaid invoices.

-In signing this agreement and providing a valid credit card to be kept on file you are understanding and accepting all terms and conditions provided by Oasis Pool Services. Failure to comply with any of these Terms and Conditions can result in postponement or termination of services.

ANY SPECIFIC INSTRUCTIONS FOR THE TECHNICIANS MUST BE PROVIDED IN WRITING PRIOR TO YOUR SCHEDULED DATE OF SERVICE. THIS INCLUDES ANY AND ALL PET INSTRUCTIONS, PARKING INSTRUCTIONS, GATE INSTRUCTIONS, ETC.

IF PAYMENT IS NOT RECEIVED WITHIN 15 DAYS OF INVOICE, A \$35.00 LATE FEE WILL BE ASSESSED, AND THE CARD ON FILE WILL BE CHARGED THE FULL AMOUNT. IF THE CARD ON FILE DECLINES AN ADDITIONAL \$15.00 FEE WILL BE APPLIED WITH AN ADDITIONAL \$35.00 PER EACH ADDITIONAL MONTH THEREAFTER. IN THE EVENT THAT COLLECTION PROCEDURES ARE REQUIRED, THE CUSTOMER WILL BE RESPONSIBLE FOR ALL LATE PENALTIES, AND ALL LEGAL AND COLLECTION FEES. WINTERIZATION PAYMENT IS EXPECTED PRIOR TO JOB COMPLETION, AS IT IS THE CLOSE OF OUR SEASON. YOUR CO-OPERATION IN THIS MATTER IS GREATLY APPRECIATED.

YOU WILL BE NOTIFIED BY TELEPHONE IF IN THE UNLIKELY SITUATION YOUR DATE HAS TO BE CHANGED.

OASIS POOL SERVICES IS FULLY INSURED AND IS A MEMBER OF THE ASSOCIATION OF POOL AND SPA PROFESSIONALS. OASIS POOL SERVICES FULLY GUARANTEES THEIR WORK. IF ANY DAMAGE OCCURS TO THE SWIMMING POOL DUE TO OUR IMPROPER WINTERIZATION, THE DAMAGE WILL BE REPAIRED AT NO COST TO YOU THE SWIMMING POOL OWNER. THIS GUARANTEE ONLY APPLIES IF THE WINTERIZATION IS DONE BEFORE ANY HEAVY, HARD FREEZES OCCUR. THIS GUARANTEE COVERS THE FILTER SYSTEM, POOL PLUMBING AND POOL PUMP. IT DOES NOT COVER THE DECK, COPING, TILING, PAINT, POOL SHELL, SKIMMERS, OR THE POOL COVER.

NOTICE OF CANCELLATION

You may cancel this transaction, without any penalty or obligation, within three business days from the date of signed contract. If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instrument executed by you will be returned within ten business days following receipt by the seller of your cancellation notice, and any security interest arising out of the transaction will be cancelled.

If you cancel, you must make available to the seller at your residence in substantially as good condition as when received, any goods delivered to you under this contract or sale; or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods to the seller's expense and risk.

If you do make the goods available to the seller and the seller does not pick them up

within twenty days of the date of your notice of cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract.
