RULES: READ, SIGN & RETURN WITH APPLICATION

- A completed application is a commitment to participate. Every vendor at Montana Mule Days must have a signed contract.
- Booth Set up may begin on Thursday the 11th of June at 12pm (Please communicate arrival time with us prior to this date, if you are needing special arrangements).
- The exhibitor is fully responsible for all services, furnishings etc. necessary above and beyond the space provided. **(Please note that all canopies, EZ ups, etc., need to be approved by a fairground employee).**
- All vendors will be responsible for their own monies.
- There will be **NO ALCOHOL** sold on site during the Montana Mule Day event.
- All vendors will only be allowed to set up in the area designated for vendors.
- No Security provided.
- Montana Mule Days, Montana Longears Association, Ravalli County Fairgrounds, and Ravalli County, and all of their workers or volunteers will not be held responsible for the safety of the exhibits, exhibitors, or their property against theft, burglary, vandalism, or damages by fire, water, or other causes. The exhibitor agrees by signing this agreement and participation to waive any and all claims from damage resulting in participation in the show.
- The exhibitor will comply with all the rules and regulations and conditions determined necessary by Montana Mule Days, Montana Longears Association, Ravalli County Fairgrounds and Ravalli County Health department. For the Benefit of all the exhibitors and the comfort and safety of and welfare of all visitors.
- Montana Longears Assoc. has the right to limit the number of vendors due to limited space.
- Vendor spaces are to be cleaned by vendor upon vacating the event- Failure to do so, will result in a cleaning fee.
- **Each vendor will receive 2 complimentary season passes for setting up for the event. If you need additional passes, they will be at gate price. Passes are nontransferable between people. Please plan accordingly if you require additional staffing. You can purchase additional passes with this application. \$7 a day or \$15 for the whole event.**
- Pets must be kept on a leash – per Fairgrounds Policy.
