- A completed application is a commitment to participate. Every vendor at Montana Mule Days must have a signed contract.
- Booth Set up may begin on Thursday the 6th of June at 8am (Please communicate arrival time)
- The exhibitor is fully responsible for all services, furnishings etc. necessary above and beyond the space provided. **ALL EZ-UPS, CANOPIES, ETC. NEED TO BE APPROVED BY FAIRGROUNDS EMPLOYEE BEFORE SET-UP.**
- All vendors will be responsible for their own monies.
- **NO ALCOHOL** will be sold on site during Montana Mule Days.
- All vendors will only be allowed to set up in the area designated for vendors.
- No Security provided.
- Montana Mule Days, Ravalli County Fairgrounds, and Ravalli County, and all of their workers or volunteers will not be held responsible for the safety of the exhibits, exhibitors, or their property against theft, burglary, vandalism, or damages by fire, water, or other causes. The exhibitor agrees by signing this agreement and participation to waive any and all claims from damage resulting in participation in the show.
